(山西省農業資產經營有限責任公司), assistant to the general manager of Shanxi Investment Group Co., Ltd. (山西省投資集團有限公司) and the office manager of Shanxi Provincial Rural Development Fund Management Committee (山西省農村開發資金管理委員會).
