PLEDGE OF SHARES BY CONTROLLING SHAREHOLDER

This announcement is made by Chongqing Hongjiu Fruit Co., Limited (the “**Company**”) in accordance with Rule 13.17 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

Reference is made to the announcement dated April 22, 2024 in relation to pledge of shares by controlling shareholder. The Company has been notified that on April 27, 2024, Mr. Deng Hongjiu (“**Mr. Deng**”), the controlling shareholder (as defined under the Listing Rules), the chairman and an executive director of the Company, has pledged 35,300,000 domestic shares of the Company, representing approximately 9.34% of total shares directly held by Mr. Deng in the Company, in favour of China CITIC Bank Corporation Limited Chongqing Branch (中信銀行股份有限公司重慶分行) (the “**Lender**”) as security for a loan facility in an aggregate amount of RMB266,634,600 provided by the Lender to the Company (the “**Facility**”). As at the date of this announcement, the aggregate domestic shares of the Company pledged by Mr. Deng represent approximately 5.96% of the total issued shares of the Company.

To the best knowledge of the directors of the Company, China CITIC Bank Corporation Limited Chongqing Branch (中信銀行股份有限公司重慶分行) is an independent third party of the Company and its connected persons.
