SIIC Environment 160,000-tonne Projects Commenced Operation and Update on One Sludge Treatment Project

This announcement is made voluntarily by SIIC ENVIRONMENT HOLDINGS LTD. ("**SIIC Environment**" or the "**Company**", together with its subsidiaries, the "**Group**"), a water treatment and environmental protection company listed on the Main Board of the SGX-ST and the Main Board of the Hong Kong Stock Exchange, to update the shareholders of the Company and potential investors on its latest business developments.

The Group is pleased to announce that three wastewater treatment plant ("**WWTP**") projects with a total designed capacity of 160,000 tonnes per day have completed construction and begun commercial operation in Zhejiang Province; and signed a supplemental agreement for a sludge treatment project with designed capacity of 200 tonnes per day in Henan Province, the People's Republic of China ("**PRC**").

160,000-tonne projects have commenced commercial operation

The Pinghu City Eastern WWTP Project 3rd Phase first stage (“**Pinghu WWTP Project**”) has been in commercial operation with retrospective effect to 23 March 2023. Pinghu WWTP Project has a designed capacity of 80,000 tonnes per day with a discharge standard as Class I Standard A.

The Pinghu City Eastern RWT Project 1st Phase (“**Pinghu RWT Project**”) has been in commercial operation with retrospective effect to 1 July 2023. Pinghu RWT Project has a designed capacity of 30,000 tonnes per day and discharges as reclaimed water quality standards.

The Yuyao City (Xiaocao'e) Municipal WWTP Expansion Project 3rd phase (Upgrade and Reconstruction) (“**Xiaocao'e Project**”) has completed construction and commenced commercial operation on 1 March 2024. Xiaocao'e Project has a designed capacity of 50,000 tonnes per day and a discharge standard as Zhejiang Province clean discharge standard.

Nanyang City Sludge Treatment Project signed supplemental agreement

The Company's 69.1125 % indirectly owned subsidiary, Nanyang Zhonghui Sludge Treatment and Resource Utilization Co., Ltd. has signed a supplemental agreement for the Nanyang City WWTP ST and Disposal Project 2nd Phase (“**Nanyang Project 2nd Phase**”) with the Housing and Urban-Rural Development Bureau of Nanyang City. The construction of Nanyang Project 2nd Phase divided into two stages, with a total designed capacity of 200 tonnes per day and the recent designed capacity is 100 tonnes per day.

The above-mentioned projects are expected to contribute positively to the Group's future performance.
