Report on Production and Sales Volume of Dongfeng Motor Group for April 2024

This is a voluntary announcement made by Dongfeng Motor Group Company Limited (the "Company").

The Company's sales volume in the first four months of 2024 was 664,715 units, representing an increase of 11.3% year-on-year. Dongfeng Motor Corporation, the parent company of the Company, recorded a total sale of 848,950 vehicles for the first four months, representing an increase of 24.7 % year-on-year. The sales volume of Dongfeng Automobile Company Limited (A-share code 600006, hereinafter referred to as "DFAC"), a subsidiary of the Company, was 58,357 units for the first four months, representing a growth of 25.4 % year-on-year.
