If you post the Reply Form within Hong Kong, you may use the mailing label at the bottom of the Reply Form and need not affix a stamp. Otherwise, please affix an appropriate stamp.

If the Company does not receive the duly completed Reply Form from you (or another response from you indicating that you object to the Email Option) by 13 June 2024, you will be implied to consent, until you inform the Company otherwise by reasonable notice in writing to the Hong Kong Branch Share Registrar at the above address or by email to 125-corpcomm@unionregistrars.com.hk, to have elected to receive printed notification letter of the publication of the Corporate Communications. In future, when the Company publishes any Corporate Communication on the Websites which excludes any Corporate Communication that seeks instructions from you on how you wish to exercise your rights as the shareholders ("Actionable Corporate Communications"), it will only send to you a notification letter that the Corporate Communication has been made available on the Websites. The notification will be sent to you by email (if you have provided a valid email address) or by post (if you have not provided an email address or the email address is invalid) at your address as it appears in the Company's register of members maintained by the Hong Kong Branch Share Registrar.

The Company will send its Actionable Corporate Communications to you individually in electronic form, if applicable. In the event that you have not provided your email address or the email address provided by you is invalid, the Company shall send the Actionable Corporate Communication in printed form together with a Reply Form for soliciting your valid email address to facilitate electronic dissemination of Actionable Corporate Communications in the future.
