Electricity Sold for April 2024

China Power International Development Limited (the “Company”) announces that based on the Company’s preliminary statistics, the combined total electricity sold by the Company and its subsidiaries (collectively, the “Group”) in April 2024 amounted to 10,847,433MWh, representing an increase of 37.65% compared with the same period last year, while the total electricity sold for the first four months of 2024 was 40,817,493MWh, representing an increase of 33.45% compared with the same period last year.

The Group’s total electricity sold for the four months ended 30 April 2024 presented by type of power plants is as follows:
