At the AGM held on 4 June 2024, voting on the proposed ordinary resolutions (the “**Resolutions**”) as set out in the notice of AGM contained in the Circular was conducted by way of a poll. The Company’s branch share registrar in Hong Kong, Tricor Tengis Limited, was appointed as the scrutineer of the poll on all resolutions.

No shareholder was required under the Listing Rules to abstain from voting, and no party has stated in the Circular an intention to abstain or to vote against the Resolutions at the AGM.

In accordance with Rule 13.39(5A) of the Listing Rules, all of the Company's 7 Directors have attended the AGM.
