## **DISCLOSEABLE TRANSACTION PROVISION OF FINANCIAL ASSISTANCE**

### **PROVISION OF FINANCIAL ASSISTANCE**

The Board is pleased to announce that on 7 June 2024, the Loan Agreement was entered into between QLCG as the lender and Customer CU, Customer CV and Customer CW as the Borrowers, pursuant to which QLCG has agreed to grant the Loan to the Borrowers for a principal amount of HK\$4,700,000 for one year term.

### **LISTING RULES IMPLICATIONS**

As an applicable percentage ratio under Rule 14.07 of the Listing Rules in respect of the Loan granted to the Borrowers exceeds 5% but is less than 25%, the grant of the Loan constitutes a discloseable transaction for the Company and is subject to notification and announcement requirements under Chapter 14 of the Listing Rules.

## **PROVISION OF FINANCIAL ASSISTANCE**

The Board is pleased to announce that on 7 June 2024, the Loan Agreement was entered into between QLCG as the lender and Customer CU, Customer CV and Customer CW as the Borrowers, pursuant to which QLCG has agreed to grant the Loan to the Borrowers for a principal amount of HK\$4,700,000 for one year term.

Summarised below are the principal terms of the Loan Agreement.

### **THE LOAN AGREEMENT**

Date of Agreement	:	7 June 2024
Lender	:	QLCG
Borrowers	:	Customer CU, Customer CV and Customer CW
Principal	:	HK\$4,700,000
Interest rate	:	14.5% per annum
Term	:	1 year commencing from the drawdown date
Security	:	A first legal charge mortgage in respect of an industrial property and a car park spacing located at Shatin, Hong Kong, and a first legal charge mortgage in respect of a residential property located at Yuen Long, Hong Kong with valuation conducted by independent property valuers in Hong Kong with the amounts of approximately HK\$7,500,000 and HK\$6,000,000 respectively as at 24 and 28 May 2024
Repayment	:	the Borrowers will repay the interest on a monthly basis with a principal amount to be repaid at maturity.

## **INFORMATION ON THE CREDIT RISK RELATING TO THE LOAN**

The making of the Loan is collateralised against an industrial property, a car park spacing and a residential property. The collaterals provided by the Borrowers for the Loan are sufficient based on the value of the mortgaged properties for the Loan as determined by independent valuers.

The advances in respect of the Loan are also made on the basis of the Company's credit assessments with reference to the facts that (i) the collaterals provided by the Borrowers are at the prime site in Hong Kong; (ii) the Borrowers' net worth are strong and solid to prove their repayment abilities; and (iii) the relatively short term nature of the Loan. After taking into account the factors as disclosed above in assessing the risks of the relevant advances, the Company considers that the risks involved in the advances to the Borrowers are manageable.

## **FUNDING OF THE LOAN**

The Group will finance the Loan with the Company's general working capital.

## **INFORMATION ON THE BORROWERS**

Customer CU and Customer CV are merchant who engage in the construction industry. Customer CU is the father of Customer CV. Customer CW is a student, grandson of Customer CU and son of Customer CV. The Borrowers are new customers and have no previous relationship with the Group, and were approached by the Group through its network. To the best of the knowledge, information and belief of the Directors having made all reasonable enquiry, the Borrowers are Independent Third Parties and not connected with the Group.

## **INFORMATION ON THE GROUP AND THE LENDER**

The Company is an investment holding company. The Group is principally engaged in provision of financial services in HK and the PRC. QLCG, as the lender of Loan, is an indirect wholly-owned subsidiary of the Company.

## **REASONS FOR ENTERING INTO THE LOAN AGREEMENT**

Taking into account the principal business activities of the Group, the grant of the Loan to the Borrowers is in the ordinary and usual course of business of the Group.

The terms of the Loan Agreement, including the interest rate applicable, were negotiated on an arm's length basis between QLCG and the Borrowers, having taken into account the prevailing market terms and practice of transactions of similar nature. The Directors consider that the grant of the Loan is a financial assistance provided by the Group within the meaning of the Listing Rules. The Directors are of the view that the terms of the Loan Agreement were entered into on normal commercial terms based on the Group's credit policy. Taking into account the satisfactory financial background of the Borrowers and that a stable revenue and cashflow stream from the interest income is expected, the Directors consider that the terms of the Loan Agreement are fair and reasonable and the entering into of the Loan Agreement is in the interests of the Company and its Shareholders as a whole.

## **LISTING RULES IMPLICATIONS**

As an applicable percentage ratio under Rule 14.07 of the Listing Rules in respect of the Loan granted to the Borrowers exceeds 5% but is less than 25%, the grant of the Loan constitutes a discloseable transaction for the Company and is subject to notification and announcement requirements under Chapter 14 of the Listing Rules.
