KEY OPERATING DATA OF MAY 2024

This announcement is made by China Suntien Green Energy Corporation Limited (the “**Company**”) pursuant to the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

According to the Company’s preliminary statistics, the power generation of the Company and its subsidiaries (collectively, the “**Group**”) on a consolidated basis for May 2024 amounted to 1,194,674.18 MWh, representing a year-on-year decrease of 3.88%. As at 31 May 2024, the accumulated power generation amounted to 6,575,980.69 MWh, representing a year-on-year decrease of 4.18%.

According to the Company's preliminary statistics, the transmission/sales volume of gas of the Group on a consolidated basis for May 2024 amounted to 411.6875 million cubic meters, representing a year-on-year increase of 69.13%, of which, the sales volume of gas amounted to 370.1275 million cubic meters, representing a year-on-year increase of 79.80%; the volume of gas transported by the Group for its clients amounted to 41.5600 million cubic meters, representing a year-on-year increase of 10.66%. As at 31 May 2024, the accumulated transmission/sales volume of gas amounted to 3,061.6694 million cubic meters, representing a year-on-year increase of 42.58%, of which, sales volume of gas amounted to 2,736.5820 million cubic meters, representing a year-on-year increase of 47.98%, the volume of gas transported by the Group for its clients amounted to 325.0874 million cubic meters, representing a year-on-year increase of 9.07%.
