### **UPDATE ON WINDING-UP PETITION APPOINTMENT OF FINANCIAL ADVISOR**

Reference is made to the announcements of XJ International Holdings Co., Ltd. (the “**Company**”) dated 28 March 2024, 14 April 2024 and 21 May 2024 (the “**Announcements**”) in relation to, among other matters, the Petition filed against the Company and application for the validation order.
