

## POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 13TH JUNE, 2024

The board of directors (the “Board”) of Cosmopolitan International Holdings Limited (the “Company”) is pleased to announce that at the annual general meeting of the Company held on 13th June, 2024 (the “AGM”), all the ordinary resolutions proposed at the AGM (the “Resolutions”) were duly passed by the shareholders of the Company by way of poll.

Prior to voting on the Resolutions, the motion to elect Mr. Jimmy LO Chun To, a Vice Chairman of the Board, as Chairman of the AGM was approved by the shareholders of the Company by way of poll (721,162,611 ordinary shares (100.000000%) voting in favour and 0 ordinary share (0.000000%) against).

There were no shares entitling the holders to attend and to abstain from voting in favour of any of the Resolutions at the AGM. No person was required to abstain from voting on any of the Resolutions put to vote at the AGM.

All directors of the Company attended the AGM in person or by electronic means.

Computershare Hong Kong Investor Services Limited, the Company's share registrar in Hong Kong, acted as the scrutineer for the poll taken at the AGM.
