Electricity Sold for May 2024

China Power International Development Limited (the “**Company**”) announces that based on the Company’s preliminary statistics, the combined total electricity sold by the Company and its subsidiaries (collectively, the “**Group**”) in May 2024 amounted to 11,449,220MWh, representing an increase of 28.11% compared with the same period last year, while the combined total electricity sold for the first five months of 2024 was 52,445,473MWh, representing an increase of 32.70% compared with the same period last year.

The Group’s total electricity sold for the five months ended 31 May 2024 presented by type of power plants is as follows:
