POLL RESULTS OF ANNUAL GENERAL MEETING HELD ON 21 JUNE 2024

The Board is pleased to announce that all ordinary resolutions and the special resolution set out in the AGM Notice were duly passed by the Shareholders by way of poll at the AGM held on 21 June 2024.

Reference is made to the circular (the “**AGM Circular**”) of China Wan Tong Yuan (Holdings) Limited (the “**Company**”) dated 26 April 2024 and the notice (the “**AGM Notice**”) of annual general meeting of the Company (the “**AGM**”) dated 26 April 2024. Capitalised terms used in this announcement shall have the same meanings as those defined in the AGM Circular unless otherwise defined herein.

As at the date of the AGM, the total number of issued shares of the Company was 1,000,000,000 Shares, which was the total number of Shares entitling the Shareholders to attend and vote for or against the resolutions at the AGM. There were no Shares entitling the Shareholders to attend and abstain from voting in favour pursuant to Rule 13.40 of the Listing Rules. There was no Shareholder who was required to abstain from voting in respect of the resolutions under the Listing Rules. There were no restrictions on any Shareholders casting votes on any of the proposed resolutions at the AGM. No party has stated his/her/its intention in the AGM Circular to vote against the resolutions proposed at the AGM or to abstain.

The Company’s Hong Kong branch share registrar, Computershare Hong Kong Investor Services Limited, acted as the scrutineer for the purpose of vote-taking at the AGM.
