POLL RESULTS OF THE ANNUAL GENERAL MEETING AND DISTRIBUTION OF FINAL DIVIDEND

The board (the “**Board**”) of directors (the “**Directors**”) of 無錫盛力達科技股份有限公司 (Wuxi Sunlit Science and Technology Company Limited*) (the “**Company**”) is pleased to announce the poll results of the annual general meeting of the Company (the “**AGM**”), held at 10:00 a.m. at 1 Yanxin Road East, Huishan Economic Development Zone, Wuxi, Jiangsu Province, the People’s Republic of China (the “**PRC**”), on Wednesday, 26 June 2024. Unless otherwise defined in this announcement, terms used but not defined in this announcement shall have the same meanings as defined in the circular of the Company dated 22 April 2024 (the “**Circular**”).

The AGM was legally and validly convened in compliance with the requirements of the Company Law of the PRC and the articles of association of the Company. The AGM was chaired by Mr. Zhang Degang, an executive Director and the chairman of the Board. All the resolutions as set out in the notice of the AGM (the “**AGM Notice**”) dated 22 April 2024 were voted by way of poll as required by the Listing Rules.

ATTENDANCE OF THE AGM

At the date of the AGM, the total number of Shares entitling the holders to attend and vote for or against the resolutions was 128,000,000 Shares, which were divided into 32,000,000 H Shares and 96,000,000 Domestic Shares. The Shareholders in attendance either in person or by proxy at the AGM held a total of 95,080,500 Shares, representing approximately 74.28% of the Company’s total issued Shares with voting rights. As at the date of the AGM, the Company had no treasury Shares. There were no Shares entitling the Shareholders to attend and abstain from voting in favour at the AGM pursuant to Rule 13.40 of the Listing Rules and no Shareholder was required under the Listing Rules to abstain from voting on any of the resolutions proposed at the AGM. None of the Shareholders have stated their intention in the Circular to vote against any of the resolutions proposed at the AGM or to abstain from voting.

In compliance with the requirements of the Listing Rules, the Company's H Share Registrar, Union Registrars Limited, acted as scrutineer for the vote-taking at the AGM.

All Directors attended the AGM.

DISTRIBUTION OF FINAL DIVIDEND

The proposal for the payment of a final dividend of RMB0.08 per Share (before tax) totalling RMB10.24 million (before tax) for the year ended 31 December 2023 (the "2023 Final Dividend") to the Shareholders was approved at the AGM. It is expected that the 2023 Final Dividend will be paid on or around Friday, 19 July 2024.

In order to determine the Shareholders who are entitled to the receipt of the 2023 Final Dividend, the register of members of the Company will be closed from Wednesday, 3 July 2024 to Monday, 8 July 2024, both days inclusive. To be eligible to receive the 2023 Final Dividend all share transfer documents accompanied by the relevant share certificates shall be lodged with the Company's H Share Registrar, Union Registrars Limited at Suites 3301-04, 33/F., Two Chinachem Exchange Square, 338 King's Road, North Point, Hong Kong (in respect of H Shares), or the Company's registered office in the PRC at 1 Yanxin Road East, Huishan Economic Development Zone, Wuxi, Jiangsu Province, PRC (in respect of Domestic Shares) for registration no later than 4:00 p.m. on Tuesday, 2 July 2024.

The actual amount of the H Share dividend paid in HK\$ will be calculated according to the average closing exchange rate of RMB against HK\$ as published by the People's Bank of China for one calendar week immediately preceding the date of the AGM (being HK\$1.00 equivalent to RMB0.9121), amounting to a cash dividend of HK\$0.0877 per Share (before tax).
