**POLL RESULTS OF
THE ANNUAL GENERAL MEETING
HELD ON JUNE 28, 2024**

References are made to the circular (the “**Circular**”) and the notice (the “**Notice**”, together with the Circular, the “**AGM Documents**”) of Lushang Life Services Co., Ltd. (the “**Company**”) dated May 29, 2024 in relation to the annual general meeting of the Company (the “**AGM**”). Unless the context otherwise requires, capitalized terms used in this announcement shall have the same meanings as those defined in the AGM Documents.

AGM

The Board is pleased to announce that the AGM was convened and held at 38th Floor, Block 5, Lushang Guo’ao City, No. 9777 Jingshi Road Lixia District, Jinan, Shandong, the PRC at 9:30 a.m. on Friday, June 28, 2024.

As at the date of the AGM, the total number of Shares in issue was 133,340,000 Shares, comprising 100,000,000 Domestic Shares and 33,340,000 H Shares, which entitled the holders to attend the AGM and vote for or against the resolutions proposed thereat.

As at the date of the AGM, none of the Shareholders was required to abstain from voting on any resolutions proposed at the AGM pursuant to the Listing Rules, and there was no Shares entitling the Shareholders to attend and abstain from voting in favour of any resolutions proposed at the AGM as set out in Rule 13.40 of the Listing Rules. None of the Shareholders has stated their intention in the Circular to vote against or to abstain from voting on any resolutions proposed at the AGM.

The H share registrar of the Company, Tricor Investor Services Limited, was appointed as the scrutineer for the purpose of vote-taking at the AGM.

The Shareholders and proxies of Shareholders attending the AGM held a total of 108,751,500 voting Shares, representing approximately 81.56% of the total number of issued Shares at the date of the AGM. The resolutions as set out in the AGM Documents were put to vote by way of a poll at the AGM.

All Directors attended the AGM either in person or via telephone conference.
