**COMPLETION OF SUBSCRIPTION OF NEW SHARES
UNDER GENERAL MANDATE**

Reference is made to the announcement of SK Target Group Limited (the “**Company**”) dated 27 June 2024 (the “**Announcement**”) in relation to, among others, the subscription of the Subscription Shares of the Company. Capitalised terms used in this announcement shall have the same meaning as defined in the Announcement unless otherwise stated.

COMPLETION OF SUBSCRIPTION OF NEW SHARES

The Board is pleased to announce that as all condition precedent set out in the Subscription Agreement have fulfilled, the Completion took place on 17 July 2024 in accordance with the terms and conditions of the Subscription Agreement. An aggregate of 27,252,720 Shares, representing (i) approximately 20.00% of the issued share capital of the Company immediately before the Completion; and (ii) approximately 16.67% of the issued share capital of the Company as enlarged by the allotment and issue of the Subscription Shares, have been allotted and issued to the Subscriber at the Subscription Price of HK\$0.08 per Subscription Share. The net proceeds from the Subscription of approximately HK\$2.10 million will be applied in manner as disclosed in the Announcement. Immediately after the Completion, the Subscriber will be regarded as a substantial Shareholder of the Company under Chapter 20 of the GEM Listing Rules.
