# CHAIRLADY'S STATEMENT

## 主席報告書

On behalf of the board of directors (“Board”) of North Asia Strategic Holdings Limited (“Company”), I am pleased to present the annual results of the Company and its subsidiaries (collectively, the “Group”) for the financial year ended 31st March 2024 (the “Year”). Facing tremendous challenges during the Year, the Group recorded a consolidated net loss of approximately HK\$48,735,000 despite an uptick of orders in the second half of the Year, compared to a consolidated net profit of approximately HK\$1,088,000 last year.

### POST-PANDEMIC CHALLENGE

The announcement by the World Health Organization on 5th May 2023 marked the end of COVID-19 pandemic but the long-awaited recovery of China economy had only lasted for a short period of time. The Group's high-tech distribution and services business experienced market slump due to the persistent sluggish demand in global mobile phone market in the first half of the Year, compensated by an obvious rebound in orders mainly from some China mobile phone manufacturers in the second half of the Year. Since there will be a new generation upgrade of Fuji's Surface Mount Technology (“SMT”) machine which offers newer technology and efficiency for smart factory, the Group expects a new wave of replacement of SMT machines in the years ahead.

The Group's leasing business has also experienced severe price competition and unstable demand of SMT machines. In order to stay competitive in its product offerings, the leasing division has accelerated replacement of the old operating lease SMT machines by new generation SMT machines to strengthen its operating lease machines fleet.

The Group's electronic payment business operating under the “Jarvis” brand, which focuses on local consumption market, has not performed as expected due to slump in local consumption market contributed in part due to more outbound travel by Hong Kong residents. To counteract this, the Hong Kong Government has rolled out economic stimulation measures to boost local consumption market such as “Hello Hong Kong” and “Night Vibes Hong Kong”. We have confidence that the current market downturn is temporary and will recover soon. Meanwhile, the Group will continue to revamp Jarvis's electronic payment application to bring more services and will put more effort in expansion of its merchant portfolio.

本人謹代表北亞策略控股有限公司(「本公司」)董事會(「董事會」)，欣然呈列本公司及其附屬公司(統稱「本集團」)截至二零二四年三月三十一日止財政年度(「本年度」)之年度業績。本年度面臨嚴峻挑戰，儘管本年度下半年的訂單上升，本集團仍錄得綜合虧損淨額約48,735,000港元，而去年則錄得綜合溢利淨額約1,088,000港元。

### 疫後挑戰

雖然世界衛生組織於二零二三年五月五日已宣佈2019冠狀病毒病疫情結束，但期待已久的中國經濟復甦只持續了很短時間。於本年度上半年，由於全球手機市場需求持續低迷，本集團的高科技產品分銷及服務業務市場一直錄得下跌，但有關下跌於本年度下半年因主要來自若干中國手機製造商的訂單明顯回升而得以抵銷。由於富士的表面貼裝技術(「SMT」)機器將進行新一代升級，為智能工廠提供更新的技術和效率，本集團預計未來幾年將出現新一輪的SMT機器更換浪潮。

本集團之租賃業務亦面臨激烈的價格競爭及SMT機器需求不穩定的情況。為保持其產品供應的競爭力，租賃分部已加快以新一代SMT機器取代舊SMT機器的經營租賃，以增強其經營租賃機器團隊。

本集團以「Jarvis」品牌營運之電子支付業務專注於本地消費市場，其表現部分因香港居民出境旅遊增加導致本地消費市場低迷而未及預期。為應對此情況，香港政府全面推出「你好，香港！」及「香港夜繽紛」等經濟刺激措施，以提振本港消費市場。我們相信現時市場低迷為暫時性並會很快復甦，同時本集團將持續改進Jarvis電子支付應用，推出更多服務，並將加大力度擴展其商戶組合。

# CHAIRLADY'S STATEMENT

## 主席報告書

### STRENGTHENING OF BUSINESS

The Group has continued to upgrade its enterprise resource planning (“ERP”) system during the Year for supporting the Group’s future business growth and improving work efficiency. Due to the market slump and significant reduction in sales during the Year, the Group has executed staff optimisation plan that streamlines its manpower to manage its costs. Since the interest rates remain high, the Group will continue to adopt a prudent and low leverage policy to maintain the resilience of its business. The Group remains open to leveraging on its listing status to raise capital, if and when appropriate, to address financing needs for its future development and investment.

### OUTLOOK

The Greater Bay Area blue print of President Xi outlines the future for growth and development for Hong Kong. With its headquarters in Hong Kong and major operating units in Southern China area, the Group is motivated and enthusiastic about the future of Hong Kong and its role in the Greater Bay Area initiative. To further strengthen soft power of Hong Kong, the Hong Kong Government has launched the “top talent pass scheme” and received overwhelming response. The Hong Kong Government has also proposed the “Northern Metropolis Strategy” and “Lantau Tomorrow Vision” to complement the Greater Bay Area initiative. The Group will proactively look for opportunities to increase investment in line with the 14th five-year plan and Great Bay Area initiatives, through both internal growth and external acquisition.

In the meantime, in response to the trend of the Group’s customers relocating their manufacturing bases as US-China decoupling continues, the Group’s offices in Southeast Asia countries will continue to expand its sales and engineering cohort to be able to serve those customers outside China.

### 強化業務

本集團於本年度已持續升級其企業資源規劃（「ERP」）系統，以支持本集團之未來業務增長及改進工作效率。由於本年度市場低迷及銷售大幅下降，本集團已實施員工優化計劃，精簡其人手以管控成本。鑒於利率仍居高不下，本集團將繼續採取審慎及低槓桿之政策，保持業務抗跌能力。本集團對在適當時候利用其上市地位集資以滿足其未來發展及投資方面的融資需求仍持開放態度。

### 展望

大灣區由習近平主席謀劃，概述了香港未來的增長及發展。本集團總部位於香港，主要營運部門位於華南地區，對香港的未來充滿信心，對其在大灣區計劃中的角色滿懷動力及熱情。為進一步加強香港的軟實力，香港政府推出「高端人才通行證計劃」，反應熱烈。香港政府亦已動議「北部都會區發展策略」及「明日大嶼願景」來配合大灣區計劃。本集團將通過內部增長及外部收購，配合「十四五」規劃及大灣區計劃，積極尋求增加投資機會。

與此同時，隨著中美脫鉤持續導致本集團客戶轉移其生產基地的趨勢，本集團於東南亞國家的辦事處將繼續擴大其銷售及工程團隊，以便為中國以外的客戶提供服務。

## A SOCIALLY RESPONSIBLE COMPANY

The long-term sustainability of the Group depends on its ability to maintain a balance between its stakeholders. As a member of a community, the Group believes that it is responsible not only to the Company's shareholders but also to other stakeholders such as its suppliers, customers, employees and the society in which it operates and the government. The Group has sponsorship program to encourage talented employees to broaden their skills and is reviewing its remuneration policies to provide better support and rewards to our staff for their long term commitment and enhanced professionalism. In 2023, the Company was awarded "The Junzi Corporation Award" the second time by the Hang Seng University of Hong Kong for conducting its operations in accordance with the Confucian ethics of "Five Virtues" referring to "Benevolence, Rightness, Propriety, Wisdom and Trustworthiness". The award encourages the Group in its continuous effort in becoming a socially responsible company.

## APPRECIATION

Without the trust and support of our shareholders, customers, suppliers, fellow directors, management and staff, I could not have persevered and to overcome the challenges during the Year. The financial and operational performance are the direct results of years of relentless hard work of our entire staff, management team and directors. I would like to take this opportunity to thank the directors for their long-term service and commitment. I am also grateful for the support and guidance of the Listing Division staff who have been helpful in facilitating our corporate actions.

# MANAGEMENT DISCUSSION AND ANALYSIS

## 管理層論述及分析

### FINANCIAL AND BUSINESS PERFORMANCE

Despite the continued Russia-Ukraine war and US-China trade tensions, as well as uncertainties around exchange rates and generally cautious consumer sentiment, the global smartphone market saw a double-digit quarter-on-quarter growth in the third quarter of 2023, with only a 1% year-on-year decline, indicating a slowdown in the downward trend. The consumer electronics industry and supply chain companies have also seen their inventory levels decreasing, with a noticeable narrowing of the year-on-year decline in smartphone shipment volumes compared to the sustained multi-quarter drops seen previously. A recent market research report by Counterpoint indicated that global smartphone shipments grew 6% year on year in the first quarter of 2024 mostly attributable to the growth from Europe and emerging markets, after its report of the decline in global smartphone shipments from April to September 2023.

Throughout the Year, manufacturers in consumer electronics industry remained cautious in response to the market rebound. The uncertainties in the global macroeconomic and geopolitical environment have made the recovery of emerging markets and operations particularly fragile. With the ongoing US-China decoupling and other geopolitical reasons that had led a trend of diversification of manufacturing bases of the Group's customers outside China, the Group has established operations during the Year in Thailand and Vietnam to better serve the Group's customers.

During the Year, the Group recorded consolidated revenue of approximately HK\$1,305,420,000, representing a decrease of 42.4% from approximately HK\$2,266,642,000 last year. The decrease in revenue was mainly due to the decrease in revenue by 46.1% from the Group's hi-tech distribution and services division. Such decrease was contributed by sluggish consumer electronic market causing most of the Group's customers to cut down or postpone their manufacturing equipment acquisition plan during the Year.

The Group's total operating cost during the Year decreased by approximately HK\$69,763,000 or 20.3% from last year's approximately HK\$344,277,000 to HK\$274,514,000. The decrease in operating expenses was mainly because of the reduction in sales related expenses and net exchange loss from approximately HK\$26,306,000 in last year to approximately HK\$4,694,000 in the Year. During the Year, the Group's total operating expenses (excluding the exchange loss) to the revenue ratio increased to 20.7% from approximately 14.0% in the corresponding period last year.

### 財務及業務表現

儘管俄烏戰爭及中美貿易緊張局勢仍然持續，匯率亦存在不確定性，而消費者情緒普遍謹慎，但二零二三年第三季度全球智能手機市場仍實現兩位數的按季增長，按年降幅僅為1%，顯示跌勢有所放緩。消費電子行業和供應鏈公司的庫存水平亦有所下降，與之前持續多個季度的降幅相比，智能手機出貨量按年降幅明顯收窄。Counterpoint報告二零二三年四月至九月全球智能手機出貨量下降後，其最近發佈的市場研究報告則顯示，主要由於歐洲及新興市場的增長，全球智能手機出貨量於二零二四年第一季度同比增長6%。

於本年度，消費電子產品製造商在應對市場反彈方面一直保持謹慎。全球宏觀經濟及地緣政治環境的不確定性，使新興市場及業務營運的復蘇變得尤為脆弱。隨著中美脫鉤持續及其他地緣政治因素，導致本集團的客戶傾向將生產基地分散至中國以外，本集團已於本年度於泰國及越南開展業務，以更好地服務本集團的客戶。

於本年度，本集團錄得綜合收入約1,305,420,000港元，較去年約2,266,642,000港元減少42.4%。收入減少主要由於本集團高科技產品分銷及服務分部之收入減少46.1%所致。有關減少乃由於消費電子市場需求低迷，導致本集團大多數客戶於本年度縮減或推遲其製造設施採購計劃。

本集團之經營費用總額由去年約344,277,000港元減少約69,763,000港元或20.3%至本年度274,514,000港元。經營費用減少主要由於與銷售有關費用及匯兌虧損淨額由去年約26,306,000港元減少至本年度約4,694,000港元。於本年度，本集團經營費用總額（不包括匯兌虧損）佔收入的比例較去年同期約14.0%上升至20.7%。



## FINANCIAL AND BUSINESS PERFORMANCE *(Continued)*

Although the Group's gross profit ratio slightly improved from last year's 14.7% to 15.7% in the Year, the Group still recorded consolidated net loss of approximately HK\$48,735,000, representing a turnaround from consolidated net profit of approximately HK\$1,088,000 in last year. The consolidated net loss of the Group was mainly due to the significant drop in revenue from hi-tech distribution and services business division while the operating costs did not reduce at the same rate as the revenue.

The basic loss per share in the Year was approximately HK10.7 cents, representing a turnaround from the basic earnings per share of approximately HK0.3 cent in last year. As at 31st March 2024, the consolidated net asset value of the Company per ordinary share was approximately HK\$3.02, representing a decrease of HK\$0.14 from approximately HK\$3.16 as at 31st March 2023.

Below is a summary of the financial and business highlights of our business divisions. The profit/loss figures disclosed below do not include any intra-group sales and charges, as they are eliminated upon consolidation.

### HI-TECH DISTRIBUTION AND SERVICES DIVISION

The Group conducts its hi-tech distribution and services business through its wholly-owned subsidiary, American Tec Company Limited ("AMT"). AMT, a 30 plus years old firm is a leading distributor and after-market service provider of surface-mount technology ("SMT") equipment and semiconductor manufacturing equipment in Asia. AMT has more than 240 professional engineers and customer care staff in more than 25 cities in China, Vietnam and India and other South-East Asia countries to service the needs of its customers. Customers include most of the major telecom and electronic equipment manufacturers in the world. AMT is especially well positioned with its growing base of Chinese manufacturers. Its suppliers include leading equipment and solutions manufacturers from Asia, the United States and Europe.

雖然本集團之毛利率由去年14.7%稍微增加至本年度15.7%，惟本集團仍錄得綜合虧損淨額約48,735,000港元，較去年的綜合溢利淨額約1,088,000港元轉盈為虧。本集團之綜合虧損淨額主要是由於高科技產品分銷及服務分部的收入大幅減少，而營運成本並無以收入般的比率減少。

本年度之每股基本虧損約為10.7港仙，較去年每股基本盈利約0.3港仙轉盈為虧。於二零二四年三月三十一日，本公司每股普通股綜合資產淨值約為3.02港元，較二零二三年三月三十一日約3.16港元減少0.14港元。

以下為我們業務分部之財務及業務摘要。由於集團內公司間之銷售及費用已於綜合入賬時對銷，故以下披露之溢利／虧損數字並不包括任何該等款項。

### 高科技產品分銷及服務分部

本集團透過其全資附屬公司美亞電子科技有限公司（「美亞科技」）經營高科技產品分銷及服務業務。美亞科技營業超過30年，為亞洲領先之表面貼裝技術（「SMT」）設備及半導體製造設備分銷商及售後服務提供者。美亞科技由逾240名專業工程師及客戶服務員工組成，分佈於中國、越南、印度及其他東南亞國家逾25個城市，為其客戶之需求效力。客戶包括全球大部分主要電訊及電子設備製造商。隨着其中國製造商不斷增加，美亞科技具備之條件尤為有利。其供應商包括來自亞洲、美國及歐洲之領先設備及解決方案製造商。

### HI-TECH DISTRIBUTION AND SERVICES DIVISION

During the Year, the division's revenue was approximately HK\$1,147,992,000, representing a decrease of HK\$982,313,000 or 46.1%, compared to approximately HK\$2,130,305,000 in last year. The decrease in revenue was mainly due to continued sluggish demand in the global mobile phone market during the Year which directly impact the Group's mobile phone manufacturing customers. The Group experienced significant decline in orders received during the first half of the Year during which the customers have been delaying or scaling down their equipment acquisition plans, while the Group saw significant improvement in orders in the second half of the Year which contributed to a rebound of the division's revenue during that period in line with reported market trend.

Direct machine sales revenue was approximately HK\$1,026,289,000, representing a decrease of HK\$941,787,000 or 47.9%, compared to approximately HK\$1,968,076,000 in the last year. The division's spare part and software sales were approximately HK\$68,324,000, representing a decrease of HK\$13,894,000 or 16.9%, compared to approximately HK\$82,218,000 in the last year. The sales support service and other service income was approximately HK\$53,379,000, representing a decrease of HK\$26,632,000 or 33.3%, compared to approximately HK\$80,011,000 in last year. The significant decrease of direct machine sales revenue and sales support service and other service income was mainly due to the withdrawal or deferral of equipment investment plans by the division's customers in response to reduced orders from their customers who are mainly well known smartphone brands.

During the Year, the division recorded a net loss of approximately HK\$3,260,000, compared to a net profit of approximately HK\$60,594,000 last year.

### LEASING DIVISION

The Group conducts its leasing business through its wholly-owned subsidiaries, North Asia Financial Leasing (Shanghai) Co., Ltd. ("NAFL") in China Shanghai Pilot Free Trade Zone and Fuji North Asia Financial Leasing (Shenzhen) Co., Ltd. ("FNAFL") in Qianhai Shenzhen-Hongkong Modern Service Industry Cooperation Zone. The leasing division provides finance and operating lease arrangements to customers of the Group's hi-tech distribution and services division and other projects.

### 高科技產品分銷及服務分部 (續)

於本年度，該分部之收入約為1,147,992,000港元，較去年約2,130,305,000港元減少982,313,000港元或46.1%。收入減少主要由於本年度全球手機市場需求持續低迷導致本集團手機製造客戶直接受到影響所致。於本年度上半年期間，客戶一直推遲或縮減其設施採購計劃，導致本集團期內收到之訂單大幅下跌，而本集團於本年度下半年的訂單則有明顯改善，使該分部在期內收入有所回升，並與所報告的市場趨勢一致。

直接機器銷售收入約為1,026,289,000港元，較去年約1,968,076,000港元減少941,787,000港元或47.9%。該分部之零部件及軟件銷售約為68,324,000港元，較去年約82,218,000港元減少13,894,000港元或16.9%。銷售支援服務及其他服務收入約為53,379,000港元，較去年約80,011,000港元減少26,632,000港元或33.3%。直接機器銷售收入及銷售支援服務及其他服務收入大幅減少，主要是由於該分部客戶因應其客戶（主要為知名智能手機品牌）減少訂單，而撤回或延遲設備投資計劃。

於本年度，該分部錄得虧損淨額約3,260,000港元，而去年則錄得溢利淨額約60,594,000港元。

### 租賃分部

本集團透過其全資附屬公司北亞融資租賃(上海)有限公司(「北亞融資租賃」)於中國上海自由貿易試驗區，及富士北亞融資租賃(深圳)有限公司(「富士北亞融資租賃」)於前海深港現代服務業合作區經營租賃業務。租賃分部為本集團之高科技產品分銷及服務分部及其他項目之客戶提供融資及經營租賃安排。



## LEASING DIVISION (Continued)

During the Year, the leasing division noted that the short-term order surge from its customers has led to structural component shortages, posing challenges to planning and production. The leasing business has continued to face persistent challenges carried over from last year's market conditions. The leasing division's management has focused on enhancing service levels to address market changes, such as customized equipment retrofitting, equipment scheduling and technical support, while also making appropriate price adjustments, as well as expanding its product portfolio to include electronic components, devices and equipment. Due to increased customer price sensitivity and intensified price competition from rivals, the division's profitability remains under significant pressure.

Despite the challenging market environment, the division recorded revenue of approximately HK\$154,346,000 for the Year, representing an increase of 13.2% compared to approximately HK\$136,337,000 in the previous year. The increase was mainly attributable to revenue from machine sales of approximately HK\$116,386,000, representing an increase of 24% compared to approximately HK\$93,865,000 in the previous year. During the Year, the revenue from operating lease arrangements for the division decreased by 16.6% to approximately HK\$29,216,000 from approximately HK\$35,049,000 in the last year. The decline in operating lease revenue was primarily due to the continued rental price decrease that began last year.

Furthermore, in response to changes in market environment and interest rates, the leasing division has flexibly adjusted its strategies to achieve a balance between risk and business growth. The division has continued to expand its customer base to cover manufacturers and offer short-term (6-12 months) financing options to its customers. As of 31st March 2024, the division's finance leasing business showed slight growth, with the principal amount of finance lease receivables increasing by 2.1% to approximately HK\$79,986,000 from approximately HK\$78,350,000 as of 31st March 2023. During the Year, finance lease income increased by approximately 17.8% to approximately HK\$8,744,000 from approximately HK\$7,423,000 in the previous year.

With its efforts described above and cost management measure during the Year, the division managed to record a net profit of approximately HK\$5,002,000, compared to a net loss of approximately HK\$1,893,000 last year.

## 租賃分部 (續)

於本年度，租賃分部注意到客戶的短期訂單激增，導致結構性零件短缺，為其計劃及生產帶來挑戰。租賃業務繼續面臨著去年市場狀況遺留的挑戰。租賃分部的管理層在適當調整價格的同時，亦致力於提高服務水平，如定製設備改造、設備調度及技術支援等，以應對市場變化，以及擴充其產品組合以包含電子元件、裝置及設備。由於客戶對價格的敏感度提高以及競爭對手的價格競爭加劇，該分部的盈利能力仍然面臨巨大壓力。

雖然市場環境充滿挑戰，該分部於本年度仍錄得收入約154,346,000港元，較上年度約136,337,000港元增加13.2%。增加主要是來自機器銷售收入約116,386,000港元，較上年度約93,865,000港元增加24%。於本年度，該分部來自經營租賃安排的收入由去年約35,049,000港元減少16.6%至約29,216,000港元。經營租賃收入減少主要是由於租金價格由去年開始持續下跌。

此外，為應對市場環境及利率的變化，租賃分部靈活調整策略，在風險及業務增長之間取得良好平衡。該分部持續擴大其客戶群以涵蓋製造商，並向其客戶提供短期(六至十二個月)融資選項。於二零二四年三月三十一日，該分部之融資租賃業務出現輕微增長，融資租賃應收款項本金額由二零二三年三月三十一日約78,350,000港元增加2.1%至約79,986,000港元。於本年度，融資租賃收入較去年約7,423,000港元增加約17.8%至約8,744,000港元。

憑藉上述努力及本年度的成本管控措施，該分部錄得溢利淨額約5,002,000港元，而去年則錄得虧損淨額約1,893,000港元。

### ELECTRONIC PAYMENT SOLUTION DIVISION

The Group conducted its payment solution business through its wholly-owned subsidiary, Jarvix (Hong Kong) Limited (“Jarvix”). Jarvix is principally engaged in providing a payment solution to local merchants such that they can accept wide range of electronic payment methods. Jarvix has been focusing on various industries such as fitness, beauty and sports. Jarvix offers tailored market analysis and payment solutions to help its merchants effectively respond to market changes and capitalize on business opportunities.

In order to increase market share, the division has strategically increased its investment in advertising and manpower both to enable it to expand and diversify its client base within and beyond those three industries and to deliver prompt and client friendly services at competitive prices. The division undertook a comprehensive rebranding of Jarvix and enhanced its system functionalities, incurring approximately HK\$350,000 for these efforts. At the same time, we also initiated projects to establish and research new payment solution offerings, which resulted in some one-off legal costs of approximately HK\$333,000.

The local consumption after the end of pandemic has been disappointing during the Year. The division has noted an increase in outbound travel partially due to the attractiveness from depreciation of the Japanese and other Asian countries currencies against Hong Kong Dollar and the trend of local residents doing their shopping and spending in Shenzhen during weekend and holidays. The local government’s measures such as “Hello Hong Kong” and “Night Vibes Hong Kong” to stimulate the local economy and attract tourists have not yet brought noticeable economic benefit.

The division recorded a revenue of approximately HK\$3,082,000 and a net loss of approximately HK\$3,725,000 for the Year. This included a relatively significant non-cash expense, which was an amortisation expense of the division’s intangible asset on the Electronic Payment Application of approximately HK\$2,598,000.

### 電子支付解決方案分部

本集團透過其全資附屬公司Jarvix (Hong Kong) Limited (「Jarvix」)經營支付解決方案業務。Jarvix主要從事為本地商戶提供支付解決方案，使該等商戶能夠接受多種電子支付方式。Jarvix一直專注於健身、美容及體育等各個行業。Jarvix提供量身定製的市場分析及支付解決方案，協助其商戶有效應對市場變化並把握商機。

為擴大市場份額，該分部策略性地增加其於廣告及人力方面的投資，使其能夠在該三個行業內外擴大客戶群並使客戶群多樣化，同時以具有競爭力的價格提供快捷及方便客戶的服務。該分部對Jarvix進行全面的品牌重塑並增強其系統功能，並就該等事務產生支出約350,000港元。同時，我們亦已啟動建立及研究新支付解決方案產品的項目，因此產生約333,000港元的一次性法律費用。

疫情結束後，本年度的本地消費狀況令人失望。該分部注意到出境旅遊有所增加，部分因為日本及其他亞洲國家貨幣兌港元貶值的吸引力，以及本港居民於周末及假日前往深圳購物及消費的趨勢。本港政府為刺激本地經濟及吸引旅客所推出的「你好，香港！」及「香港夜繽紛」等措施尚未帶來明顯的經濟效益。

於本年度，該分部錄得收入約3,082,000港元及虧損淨額約3,725,000港元。當中包括一筆相對重大的非現金費用，即該分部有關電子支付應用程式的無形資產攤銷費用約2,598,000港元。



## OUTLOOK

International Data Corporation (“IDC”) has predicted in May 2023 that the worldwide smartphone shipments would recover by 4% to 1.21 billion units in 2024. In contrast, in its Worldwide Quarterly Mobile Phone Tracker forecast published in January 2024, it reported that the worldwide shipments of smartphones declined by 3.2% year on year in 2023.

In its latest Global Economic Prospect report in June 2024, World Bank projected that the global economic growth rate will hold steady at 2.6 percent in 2024 and economic growth in China is projected to slow down from 5.2 percent in 2023 to 4.8 percent in 2024. According to the National Bureau of Statistics (“NBS”) of China’s preliminary estimate in June 2024, the gross domestic product (“GDP”) for the first quarter of 2024 was up 5.3 percent year on year while the GDP for the year 2023 was up by 5.2 percent year on year. NBS also reported that the value-added output of the manufacturing industry increased 7.5 percent year-on-year in April 2024, accelerating from 5.1 percent year-on-year growth in March 2024. Meanwhile, several key manufacturing sectors experienced high levels of growth in added value output, including high-tech manufacturing, which increased by 11.3 percent year-on-year and automobile manufacturing, which grew by 16.3 percent year-on-year.

That said, the manufacturing Purchasing Manager Index (PMI) published by National Bureau of Statistics of China, remained below 50 during the Year except for September 2023 and March 2024 where PMI stood at 50.2 and 50.8 respectively. The rebound of PMI in March 2024 did not extend to later periods and has dropped below 50 again from May 2024, being a signal that the outlook of the manufacturing industry remained pessimistic.

However, the Group notes that President Xi, chairing the 4th meeting of the Central Financial and Economic Affairs Commission in February 2024, emphasized the need to promote a new round of large-scale equipment upgrades and the trade-in of consumer goods. Additionally, when setting this year’s economic targets at the National People’s Congress, Premier Li aims for around 5% stable growth in 2024.

## 展望

國際數據資訊有限公司(「IDC」)於二零二三年五月預測，全球智能手機於二零二四年的出貨量將回升4%至12.1億部。對比於二零二四年一月發佈的《全球季度手機追蹤器》預測，該預測則顯示全球智能手機出貨量於二零二三年按年減少3.2%。

世界銀行於其二零二四年六月的最新《全球經濟展望》報告中預測，全球經濟增長率將於二零二四年維持於2.6個百分點，而中國經濟增長則預計由二零二三年5.2個百分點下降至二零二四年4.8個百分點。根據中國國家統計局(「國家統計局」)於二零二四年六月的初步估計，二零二四年第一季度國內生產總值按年上升5.3個百分點，而於二零二三年的國內生產總值則按年上升5.2個百分點。國家統計局亦報告，製造業增值輸出於二零二四年四月按年增長7.5個百分點，與二零二四年三月按年增長5.1個百分點相比有所增長。同時，多個關鍵製造板塊都出現增值輸出的長足增長，包括高科技製造(按年增長11.3個百分點)及汽車製造(按年增長16.3個百分點)。

儘管如此，中國國家統計局發佈的製造業採購經理指數(PMI)顯示，於本年度，除二零二三年九月及二零二四年三月分別為50.2及50.8外，PMI均低於50。二零二四年三月PMI的反彈並無延續至較後期間，並於二零二四年五月再次跌至低於50，為製造業前景仍然悲觀的訊號。

然而，本集團得悉，習近平主席於二零二四年二月主持召開中央財經委員會第四次會議，強調要推動新一輪大規模設備更新及消費品以舊換新。此外，李強總理在全國人民代表大會上制定今年的經濟目標時，將二零二四年目標定為實現5%左右的穩定增長。

### OUTLOOK (Continued)

The Greater Bay Area blue print by President Xi outlines the future for growth and development for Hong Kong. Since the Group is motivated and optimistic about the future of Hong Kong and its role in the Greater Bay Area initiative, the Group will continue to build its businesses in Hong Kong and the Greater Bay Area. At the same time Group will also continue to monitor and where appropriate continue to set up operations in other parts of Asia, to seek to serve those of its customers that may continue to diversify their manufacturing bases to locations outside China.

The Group will continue to closely monitor its working capital, gross margin, operating cost and industry developments with a view to maintaining adequate cash flow, enhancing the operational efficiency of its various business divisions to improve their profitability, achieving long-term sustainability and growth of its business, ultimately to increase shareholders' value.

### Hi-Tech Distribution and Services Division

Most countries have set a net-zero emission target. To achieve this by 2030, some of these countries have codified this target in their laws. The Group expects the replacement of petroleum fuelled vehicles with electric vehicles will be accelerated in the coming years. The emerging electric vehicle manufacturing industry creates new opportunities for the Group since some of the Group's major customers are leading electric vehicle manufacturers, or their OEM manufacturers in China.

The Group also perceives there will be increasing demand for artificial intelligence (AI) chips and user devices such as AI notebook and AI smartphone and would then drive demand for SMT and semi-conductor manufacturing facilities. The Group's major SMT product, NXT III, will be phased out in 2025 and is to be replaced by a new generation model, NXTR, with higher performance that is suited for smart factory production. The division therefore expects a new wave of replacement demand in coming years.

The Group will continue to closely monitor its working capital, gross margin, operating cost and industry developments with a view to maintaining adequate cash flow, improving its results and achieving long-term sustainability and growth of its business.

### 展望 (續)

大灣區由習近平主席謀劃，概述了香港的未來增長及發展。由於本集團對香港的未來充滿信心，對其在大灣區計劃中的角色滿懷動力及熱情，本集團將繼續努力建立於香港及大灣區的業務。同時，本集團亦會繼續監測並在適當情況下繼續於亞洲其他地區設立業務，尋求為可能繼續將其生產基地分散至中國以外地區的客户提供服務。

本集團將繼續密切監察其營運資金、毛利率、經營成本及行業發展，以維持足夠現金流、提高不同業務分部之營運效率以改善其盈利能力，以及達致業務長期可持續發展及增長，最終提升股東價值。

### 高科技產品分銷及服務分部

大多數國家已制訂淨零排放目標。為於二零三零年達致此目標，部分國家已編纂此目標至其法律。本集團預期，電動汽車於未來數年將加快取代燃油汽車。新興的電動汽車製造行業可為本集團創造新機會，乃由於本集團部分主要客戶為中國領先的電動汽車製造商或其OEM製造商。

本集團亦認為，人工智能(AI)芯片以及AI筆記型電腦及AI智能手機等用戶設備的需求將會增加，從而或會帶動對SMT及半導體製造設備的需求。本集團的主要SMT產品NXT III將於二零二五年被淘汰，並將被性能更佳且適合智能工廠生產的新一代型號NXTR取而代之。因此，該分部預期，未來幾年將出現新一波換機需求。

本集團將繼續密切監察其營運資金、毛利率、經營成本及行業發展，以維持足夠現金流、改善業績以及達致業務長期可持續發展及增長。

## OUTLOOK (Continued)

### Leasing Division

Starting from 2024, the equipment leasing market has seen a notable turnaround, as many customers demanded leasing over outright equipment purchases to meet their short-term order needs. However, whether this shift towards leasing can be sustained and lead to a stable and upward operating environment for the overall leasing industry still requires observation over a longer time frame to assess if it can truly stabilize the industry conditions.

Given the uncertain market environment, the Group will remain cautious in developing its leasing business in 2024/25. The leasing division will continue to focus on improving equipment utilization rates and diversifying leasing offerings. It will provide value-added services through self-developed and customized modifications, and maintain customer relationships through the Group's core competencies and exclusivity. For direct finance leases, the division will increase risk control by diversifying business areas, focusing on high-tech products with good growth potential, and expanding short-term (6-12 months) financing. In addition, the division will seek to increase diversified cooperation with partners to improve equipment disposal and leasing rates on a prudent basis.

### Electronic Payment Solution Division

While Jarvix's customers who are all merchants in Hong Kong have been negatively impacted by the post pandemic shift of consumption pattern in Hong Kong, in particular, the popular trend of traveling north in addition to overseas travel, the division is committed towards providing high quality and competitive services to attract more merchants and to roll out new mobile applications that enables Jarvix to expand its services to more merchants and consumers.

The Global Payments Report published by Worldpay, a subsidiary of financial technology solutions provider FIS, shows that credit cards remain the primary payment method in Hong Kong. However, electronic wallets are expected to replace credit cards as the most popular online transaction payment method in Hong Kong by 2026. Another emerging payment method, Buy Now, Pay Later (BNPL), is anticipated to gradually increase in usage, with related e-commerce payment volumes projected to grow by 1.56 times, from USD258 million in 2022 to USD659 million in 2026.

## 展望(續)

### 租賃分部

從二零二四年開始，設備租賃市場出現明顯的轉機，不少客戶要求租賃而非直接購置設備以應付其短期訂單需求。然而，轉向租賃的情況能否持續，並為整個租賃行業帶來穩定向上的經營環境，仍需更長時間觀察，以評估此情況是否確實能夠穩定行業的狀況。

鑒於市況不明朗，本集團在二零二四／二五年將繼續審慎發展租賃業務。租賃分部將繼續專注於提高設備利用率及將租賃產品多元化。其將通過自主開發及定製改造提供增值服務，並通過本集團的核心競爭力和獨家優勢維持客戶關係。融資直租方面，該分部將通過分散業務範疇、專注於具有良好增長潛力的高科技產品以及擴大短期（六至十二個月）融資以加強風險控制。此外，該分部將以審慎基礎尋求加強與合作夥伴的多方面合作，從而提升設備處置率及租賃率。

### 電子支付解決方案分部

縱使 Jarvix 的客戶均為位於香港的商戶，並受到疫情過後香港消費模式轉變的負面影響（尤其是北上旅遊以及海外度假的熱潮），該分部仍致力於提供高質素且具競爭力的服務，以吸引更多商戶，並推出全新手機應用程式，以擴展 Jarvix 服務至更多商戶及消費者。

金融技術解決方案供應商 FIS 的附屬公司 Worldpay 所發表的《全球支付報告》顯示，信用卡仍是香港的首選支付方式。不過，預計到二零二六年，電子錢包將取代信用卡，成為香港最流行的在線交易支付方式。另一種新興支付方式「先買後付」（BNPL）的使用率預計將逐步上升，相關的電子商務支付額預計將增長 1.56 倍，從二零二二年的 258,000,000 美元增至二零二六年的 659,000,000 美元。

#### Electronic Payment Solution Division *(Continued)*

Jarvis will continue to enhance its systems and application technologies, including both online and offline payment modes, to adapt to future developments and strive to become one of the most comprehensive system and competitive payment solution in Hong Kong.

### LIQUIDITY AND FINANCIAL RESOURCES

During the Year, the Group generally finance its operation with internally generated resources and banking facilities provided by its principal bankers in Hong Kong. As at 31st March 2024, the Group had no secured other borrowings (2023: HK\$1,800,000, which are denominated in RMB). As at 31st March 2024, the Group had banking facilities of approximately HK\$711,845,000 (2023: approximately HK\$870,268,000) from several banks for trade financing. As at 31st March 2024, banking facilities of approximately HK\$145,090,000 (2023: approximately HK\$147,350,000) were utilised by the Group. These facilities were secured by corporate guarantees of approximately HK\$973,288,000 (2023: approximately HK\$1,130,270,000) provided by the Company. As at 31st March 2024, the Group had total assets of approximately HK\$1,957,058,000 (2023: approximately HK\$2,079,936,000) and total liabilities of approximately HK\$583,320,000 (2023: approximately HK\$644,600,000). The Group had net cash position as at 31st March 2024 and 2023.

#### 電子支付解決方案分部 *(續)*

Jarvis 將繼續提升系統及應用技術(包括線上及線下支付模式)以適應未來的發展,致力成為香港最完善的系統及最具競爭力的支付解決方案之一。

### 流動資金及財務資源

於本年度,本集團一般以內部產生之資源及其香港主要往來銀行提供之銀行融資撥付其營運資金。於二零二四年三月三十一日,本集團並無有抵押其他借貸(二零二三年:1,800,000港元,有關借貸以人民幣計值)。於二零二四年三月三十一日,本集團之銀行融資約為711,845,000港元(二零二三年:約870,268,000港元),乃來自多間銀行,作貿易融資用途。於二零二四年三月三十一日,本集團已動用銀行融資約145,090,000港元(二零二三年:約147,350,000港元)。此等融資乃以本公司提供之公司擔保約973,288,000港元(二零二三年:約1,130,270,000港元)作擔保。於二零二四年三月三十一日,本集團之資產總值約為1,957,058,000港元(二零二三年:約2,079,936,000港元),而負債總額約為583,320,000港元(二零二三年:約644,600,000港元)。本集團於二零二四年及二零二三年三月三十一日維持淨現金狀況。

## CONTINGENT LIABILITIES

As at 31st March 2024, pledged deposits of HK\$2,100,000 (2023: HK\$4,490,000) were held as security at a bank in respect of performance bonds in favour of certain contract customers. The guarantee given by the Group to a bank in respect of a performance bond in favour of a supplier amounted to HK\$4,549,000 (2023: HK\$5,207,000).

## NET ASSET VALUE

Consolidated net asset value per ordinary share attributable to ordinary shareholders of the Company was approximately HK\$3.02 as at 31st March 2024, decreased by HK\$0.14 from approximately HK\$3.16 as at 31st March 2023.

## NUMBER OF EMPLOYEES AND REMUNERATION POLICIES

As at 31st March 2024, the Group employed 338 (2023: 388) staff. Salaries and annual bonuses are determined according to positions and performance of the employees. Remuneration policies are reviewed annually by the management and remuneration packages are structured to take into account the comparable level of the market. The Group provides on-the-job training and training subsidies to its employees in addition to pension schemes and medical insurance. Total staff costs including contribution to retirement benefit schemes incurred during the year amounted to approximately HK\$147,870,000 (2023: HK\$194,215,000).

The Company operates share option schemes for the purpose of providing incentives and rewards to Directors, employees and eligible participants who contributed or will contribute to the Group. Details of the share option schemes are set out in the Report of Directors under the section of "Equity-Linked Agreements".

The Company endeavours to maintain high standards of corporate governance in the interests of shareholders, and follows the principles set out in the Corporate Governance Code (the “Code”) contained in Appendix C1 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “GEM Listing Rules”).

The Board will continue reviewing and updating its corporate governance practices from time to time to ensure compliance with applicable codes and standards. The Company is committed to developing a corporate culture that is aligned with its purpose, vision, strategy and value. The Group’s employees have to thrive on the culture that enable the Company to achieve long-term sustainability growth and maximize the value of the shareholders and balance the interest of the stakeholders at the same time.

**Purpose:** To establish a leading one-stop service provider for customers, merchants, electronic manufacturers and equipment suppliers.

**Vision:** To be an expert service provider in future smart manufacturing industry and community.

**Strategy:** Achieve long-term sustainability and maintain commitment to responsibilities towards shareholders and stakeholders like employees and suppliers and relevant local government.

**Value:** Integrity, gender diversification, excellence in performance, internal and external collaboration and professionalism.

Throughout the year ended 31st March 2024 (the “year”), the Company complied with all the Code provisions with the exceptions addressed below and, where appropriate, adopted the recommended best practices set out in the Code.

Code provision C.2.1 stipulates that the roles of chairman and chief executive should be separate and should not be performed by the same individual. However, the Board’s decisions are implemented under the leadership of the Chairlady with the involvement and support of the chief executive officer(s) and general manager(s) of the Company’s operating companies. The Board believes that the balance of authority and division of responsibility are adequately ensured by the operations of the Board and management which comprise experienced and high calibre individuals.

#### Board Meetings

The Board regularly meets in person or through other electronic means of communication at least four times every year to determine overall strategic direction and objectives and approve quarterly, interim and annual results, budgets and other significant matters. At least 14 days' notice of regular Board meetings are given to all Directors, who are all given an opportunity to attend and include matters in the agenda for discussion. Apart from formal meetings, matters requiring Board approval are also arranged by means of circulation of written resolutions. Senior management from time to time provides to the Directors information on activities and development of the business of the Group. The company secretary takes detailed minutes of the meetings and keeps records of matters discussed and decisions resolved at the meetings.

The Directors can seek independent professional advice in performing their duties at the Company's expense, if necessary. According to the current Board's practices, should a potential conflict of interest involving a substantial shareholder of the Company or Director arise, the matter is discussed in a Board meeting, as opposed to being dealt with by written resolution. Independent non-executive Directors with no conflict of interest should be present at meetings dealing with conflict issues. When the Board considers any proposal or transaction in which a Director has a conflict of interest, the Director should declare his interest and abstains from voting.

#### Roles and responsibilities

The Board has the responsibility for leadership and control of the Company. They are collectively responsible for promoting the success of the Group by directing and supervising the Group's affairs. The Board is accountable to shareholders for the strategic development of the Group with the goal of maximizing long-term shareholders' value, while balancing broader stakeholder interests. Given the diversity and volume of the Company's business, responsibilities for execution and daily operations are delegated to management.

The Directors have distinguished themselves in their field of expertise, and have exhibited high standards of personal and professional ethics and integrity. The Board is of reasonable size and composition to provide checks and balances that safeguard the interests of the shareholders and the Company as a whole. All the Directors have given sufficient time and attention to the Company's affairs.

During the year, the executive Directors were responsible for the day-to-day management of the Group's operations. These Directors conducted regular meetings with the senior management of the Company and its subsidiaries, at which operational issue and financial performance were evaluated. The non-executive Directors provided the Company with a wide range of expertise and experience. They brought advice and judgment on issues relating to the Group's strategy, performance, risk and management process, and corporate governance through their contribution at Board and committee meetings.

According to the Bye-laws of the Company, newly appointed Directors shall hold office until the next following general meeting and shall be eligible for re-election at that meeting. Every Director, including those appointed for a specific term, should be subject to retirement by rotation at least once every three years.

### Independence

The Company has established mechanisms to ensure independent views and input are available to the Board. The Board shall review the implementation and effectiveness of such mechanisms on annual basis.

During the year and up to the date of this report, the Company had at least three independent non-executive Directors. Amongst the independent non-executive Directors, at least one of whom had appropriate financial management expertise.

According to code provision B.2.3 of the Corporate Governance Code, if an independent non-executive director has served more than nine years, such director's further appointment should be subject to a separate resolution to be approved by the shareholders. For the year ended 31st March 2024, (i) Mr. Joseph Liang Hsien Tse has been appointed as independent non-executive Director for more than 9 years since 2013; and (ii) Mr. Joseph Chan Nap Kee has been appointed as non-executive Director in February 2013 and was re-designated as independent non-executive Director in March 2016. As such, Mr. Chan has continued to serve the Company for more than 9 years. The Company has received annual confirmations of independence from each of the existing independent non-executive Directors in accordance with Rule 5.09 of the GEM Listing Rules. Taking into consideration of three independent non-executive Directors' independent scope of work in the past years, the Board considers all of them to be independent under the guidelines set out in the GEM Listing Rules despite the fact that two of them have served the Company for more than 9 years. Up to the date of this report, the Board has not been aware of the occurrence of any events which would cause it to believe that their independence has been impaired. The three independent non-executive Directors have confirmed that they will continue to devote sufficient time for the discharge of their functions and responsibilities as independent non-executive Directors. With their background, the three independent non-executive Directors are fully aware of the responsibilities and expected amount of time dedicated to the Company. Based on the foregoing, the Board believes that their positions outside the Company will not affect them in maintaining their current roles in, and their functions and responsibilities for the Company. The Board also believes that their continued tenure will bring considerable stability to the Board and the Board has benefited greatly from the presence of all of them who have over time gained valuable insight of the Group.

During the year ended 31st March 2024, the remuneration committee of the Company has reviewed and recommended the grant of options under the 2014 Scheme (including those to Directors and senior managers) mentioned above. The remuneration committee has noted that the purpose of the 2014 Scheme is to reward the Grantees for their contribution to the Company and the scheme rules do not restrictively define contribution. In recommending the grant of those options, the remuneration committee therefore took into account each Grantee's contribution to the Group for the past financial periods (i.e. an assessment of that Grantee's performance) and that options can provide incentive to that Grantee to work towards enhancing the value of the Company such that it could be reflected in the price of the Shares, thereby aligning the interest of that Grantee with those of the Company and its shareholders. Further, the remuneration committee considered that it would be impracticable or inappropriate to include specific performance targets given the roles and responsibilities of the relevant grantees who are executive Directors or senior managers and the market conditions under which the Group is operating while performance targets may compromise the independence of the independent non-executive Director grantee.

Accordingly, having taken into account the factors above and the fact that the market for and price of Shares is not under the Company's control, the remuneration committee of the Company considered that notwithstanding the absence of performance targets and the limited clawback mechanism, the options granted during the year ended 31st March 2024 can incentivize the Grantees to strive for the future development of the Company, was in line with the purpose of the 2014 Scheme, was market competitive and was consistent with the Company's customary practice.

### Remuneration of Directors and Senior Management

For the year ended 31st March 2024, total Directors' remuneration amounted to approximately HK\$21,938,000 (2023: HK\$25,158,000). Remuneration of the executive Directors is prudently designed to attract, motivate and retain them to formulate strategies and to oversee operational matters of the Group and to reward them for enhancing value to the shareholders. Details of the remuneration of the Directors for the year are set out in note 8 to the accompanying financial statements.

於截至二零二四年三月三十一日止年度內，本公司薪酬委員會曾審視及建議上文所述根據二零一四年計劃授出購股權(包括授予董事及高級管理人員)提出建議。薪酬委員會注意到，二零一四年計劃的目的是就承授人對本公司的貢獻作出獎勵，而該計劃的規則並無嚴格界定「貢獻」。因此，薪酬委員會在建議授出該等購股權時，曾考慮到各承授人在過往財政期間對本集團的貢獻(即評價承授人的績效)，致使購股權可激勵該承授人努力提升本公司價值，並可在股份價格中反映，因而使承授人的利益與本公司及其股東一致。此外，薪酬委員會認為，鑑於擔任執行董事或高級管理人員的相關承授人的角色及職責，以及本集團所經營市場的狀況，績效目標或會損害獨立非執行董事承授人的獨立性，故包含績效目標並不可行或不恰當。

因此，考慮到上述因素，加上股份市場及價格非本公司所能控制的事實，本公司薪酬委員會認為，儘管不設績效目標而回撥機制亦有限，惟於截至二零二四年三月三十一日止年度內授出的購股權仍可激勵承授人為本公司未來發展努力，與二零一四年計劃的目的之一致、具市場競爭力並符合本公司的慣例。

### Audit Committee

During the year and up to the date of this report, the Company's audit committee comprised not less than three members at all time. The members of the audit committee comprised Mr. Joseph Liang Hsien Tse (who served as committee chairman and has appropriate professional qualifications and experience in financial matters), Mr. Joseph Chan Nap Kee and Dr. Cai Qing, all being independent non-executive Directors.

The Board has adopted a set of the revised terms of reference of the audit committee to align with the provisions set out in the Code in February 2024. The committee's principal duties are to ensure the adequacy and effectiveness of the accounting and financial controls of the Group, oversee the performance of internal control systems, risk management and financial reporting process, monitor the integrity of the financial statements and compliance with statutory and listing requirements and to oversee independence and qualifications of the external auditors.

The audit committee meets at least four times a year to discuss any area of concern during the audits or reviews and at least twice of the meetings shall be with the external auditors. The audit committee reviews the quarterly (if prepared for publication), interim and annual reports before submission to the Board. Senior representatives of the external auditors, executive Directors and senior management are invited to attend the meetings, if required.

## AUDITOR'S REMUNERATION

The Company reviews the appointment of external auditor on an annual basis including a review of the audit scope and approval of the audit fee. During the year, the fee payable to the Company's external auditor for the audit of the Company and its subsidiaries amounted to approximately HK\$2,930,000 (2023: HK\$2,800,000) and fee for non-audit related activities of the Company and its subsidiaries amounted to approximately HK\$587,000 (2023: HK\$525,000).

## RISK MANAGEMENT AND INTERNAL CONTROLS

During the year, the Group has complied with Principle D.2 of the Corporate Governance Code by establishing appropriate and effective risk management and internal control systems. Management is responsible for the design, implementation and monitoring of such systems, while the Board oversees management in performing its duties on an ongoing basis.

### Risk Assessment System

The Group adopts a risk management system which manages the risk associated with its strategic, financial, operations, compliance and significant environmental, social and governance ("ESG") issues. The system comprises the following phases:

- Phase 1: Identify ownership of risks, business objectives and risks that could affect the achievement of objectives
- Phase 2: Analyze the likelihood and impact of risks and evaluate the risk portfolio accordingly
- Phase 3: Consider the risk responses and ensure effective communication to the Board
- Phase 4: On-going monitor the residual risks

Based on the risk assessments conducted in 2023, no significant risk was identified.

本公司每年檢討外聘核數師之委任，包括檢討審核範圍及批准核數費用。於本年度內，就本公司及其附屬公司之核數及非核數相關活動應付本公司外聘核數師之費用分別為約2,930,000港元(二零二三年：2,800,000港元)及約587,000港元(二零二三年：525,000港元)。

#### Internal Control System

The Company has in place an internal control system which is compatible with the Committee of Sponsoring Organizations of the Treadway Commission (“COSO”) 2013 framework. The framework enables the Group to achieve objectives regarding effectiveness and efficiency of operations, reliability of financial reporting and compliance with applicable laws and regulations. The components and main features of the framework are shown as follow:

#### Control Environment

- Proper structures, reporting lines and appropriate authorities and responsibilities in the pursuit of objectives are established.

#### Risk Assessment

- Changes in risk that could significantly impact the system of internal control are identified using the abovementioned risk management system.

#### Control Activities

- Formal policy and procedures, such as financial reporting, revenue and receipts, are established, implemented and communicated throughout the Group.

#### Information and Communication

- Proper safeguards are established for handling and dissemination inside information. For example, confidentiality agreements are in place when the Group enters into significant negotiations, and the executive Directors are designated to speak on behalf of the Group when communicating with external parties such as the media, analysts or investors.

#### Monitoring

- Internal control deficiencies are communicated to the responsible departments in a timely manner for taking corrective action.

Based on the internal control reviews conducted in 2023, no significant control deficiency was identified.

The abovementioned risk assessment and internal control systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

### Internal Audit Function

The Group has engaged an independent professional internal control consultant firm (the “Internal Control Consultant”) to review the entity level policies, risk assessment and internal control systems of major business processes of the Group for financial year ended 31st March 2024. The Internal Control Consultant performs the review, reports the relevant findings and recommendations to the Board and Audit Committee and follows up on management responses to the recommendations on an ongoing basis. Overall, the Board considers the risk management and internal control system of the Group are effective and adequate.

The Group does not have an internal audit department and the Board has reviewed the need for an internal audit function and considered that it more cost-effective to appoint external independent professionals to independently review and continuously evaluate the Group’s internal monitoring systems and risk management systems, taking into account the size and nature of the Board. The Board will review the need for an internal audit department at least annually.

According to the established plan approved by the Board, review of the risk management and internal control systems is conducted annually and the results are reported to the Board/Audit Committee afterwards.

During the year, the audit committee reviewed the effectiveness of the internal control system through the following processes and subsequently reported the review results to the Board:

- discussions with the executive management on areas of risk identified
- review of risks reported by the Internal Control Consultant
- review of the external audit plans

### 內部審核職能

本集團已委聘獨立專業的內部監控顧問公司（「內部監控顧問」）審閱本集團截至二零二四年三月三十一日止財政年度於主要業務過程的實體層面政策、風險評估及內部監控制度。內部監控顧問進行審查，向董事會及審核委員會報告相關的調查結果及推薦建議，並持續跟進管理層對建議的回應。整體而言，董事會認為本集團的風險管理及內部監控制度屬有效及充足。

本集團並無設立內部審核部門，而董事會已檢討內部審核職能的需要，並認為考慮到董事會的規模及性質，委聘外部獨立專業人士獨立審閱及持續評估本集團內部監察制度及風險管理制度更具成本效益。董事會將至少每年檢討一次是否需要設立內部審核部門。

Based on the result of the review for the year ended 31st March 2024, the Board considered that the risk management system and internal control system of the Group, including the adequacy of resources, qualifications and experience of staff of the accounting and financial reporting function, and their training programs and budget, are adequate and effective and have complied with the provisions of the Code during the year.

### COMPANY SECRETARY

The company secretary supports the Chairlady, the Board and Board committees by ensuring good information flow within the Board and that Board policy and procedures are followed. The company secretary reports to the Board and assists the Board in functioning effectively and efficiently. He also advises the Board on governance matters and facilitates the induction and professional development of Directors. All Directors of the Company may call upon the company secretary for advice and assistance at any time in respect to their duties and the effective operation of the Board and the Board committees.

Mr. Law Wai Fai is the chief financial officer and company secretary of the Company. He is a full time employee of the Company and had day-to-day knowledge of the Company's affairs. Mr. Law undertook not less than 15 hours of relevant professional training during the year.

### 公司秘書

公司秘書支援主席、董事會及董事委員會，確保董事會內部資訊流通無阻以及董事會政策及程序得到遵循。公司秘書向董事會報告，並協助董事會有效及具效率地運作。彼亦就管治事宜向董事會提供意見，並協助安排董事之入職及專業發展。本公司全體董事可隨時要求公司秘書提供有關其職責及致使董事會及董事委員會有效運作之意見及協助。

## NOMINATION POLICY

The Company has adopted a nomination policy in November 2018 which sets out the criteria and procedures for nominating candidates for election as Directors.

### Selection Criteria

1. The factors listed below would be used as reference by the Nomination Committee (“NC”) in assessing the suitability of a proposed candidate.
  - Reputation for integrity
  - Accomplishment and experience in relation to the Company’s line of business
  - Commitment in respect of available time
  - Diversity in all its aspects, including but not limited to gender, age (18 years or above), cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service

These factors are for reference only, and not meant to be exhaustive and decisive. The NC has the discretion to nominate any person, as it considers appropriate.

2. Retiring independent non-executive Directors (“INEDs”), save for those who have served as INEDs for a period of 9 consecutive years, are eligible for nomination by the Board to stand for re-election at a general meeting. For the avoidance of doubt, (a) the 9-year period for determining the eligibility of an INED for nomination by the Board to stand for election at a general meeting would count from his/her date of first appointment as an INED until the date of the forthcoming annual general meeting when his/her current term of service will expire at the end of that meeting; and (b) an INED who has been serving on the Board for a period of 9 consecutive years or more may continue to hold office until expiry of his/ her current term.

### 甄選準則

1. 提名委員會(「提委會」)於評估建議候選人之合適性時，將參考下列因素。

  - 各方面之多元化，包括但不限於性別、年齡(18歲或以上)、文化及教育背景、種族、專業經驗、技能、知識及服務年期等方面

該等因素僅供參考，並不旨在涵蓋所有因素，也不具決定性作用。提委會可酌情提名任何其認為合適之人士。

2. 即將退任的獨立非執行董事(「獨立非執行董事」)(已連續九年擔任獨立非執行董事者除外)均合資格獲董事會提名在股東大會上再度參選董事。為免產生疑問，(a)決定一名獨立非執行董事是否合資格獲董事會提名在股東大會上參選的九年期限，乃由該董事首次獲委任為獨立非執行董事之日起計，至即將舉行的股東週年大會的日期止(該董事的現有任期將於股東週年大會結束時屆滿)；及(b)已任職董事會連續九年或以上的獨立非執行董事可繼續擔任該職位，直至其現有任期屆滿為止。

- Proposed candidates will be asked to submit the necessary personal information, together with their written consent to be appointed as a Director and to the public disclosure of their personal data on any documents or the relevant websites for the purpose of or in relation to their standing for election as a Director.
- The NC may request candidates to provide additional information and documents, if considered necessary.

#### Nomination Procedures

- The Secretary of the NC shall call a meeting of the NC, and invite nominations of candidates from Board members if any, for consideration by the NC prior to its meeting. The NC may also put forward candidates who are not nominated by Board members.
- For filling a casual vacancy, the NC shall make recommendations for the Board's consideration and approval. For proposing candidates to stand for election at a general meeting, the NC shall make nominations to the Board for its consideration and recommendation.
- Until the issue of the shareholder circular, the nominated persons shall not assume that they have been proposed by the Board to stand for election at the general meeting.
- In order to provide information of the candidates nominated by the Board to stand for election at a general meeting, a circular will be sent to shareholders. The names, brief biographies (including qualifications and relevant experience), independence, proposed remuneration and any other information, as required pursuant to the applicable laws, rules and regulations, of the proposed candidates will be included in the circular to shareholders.

8. As there may be more candidates than the vacancies available, and the "gross-vote" method will be used to determine who shall be elected as a Director, shareholder proposed resolutions shall therefore take the same form as the resolutions proposed for the candidates recommended by the Board.

Any final dividend for a financial year will be subject to shareholders' approval and the Company may declare and pay dividends by way of cash or scrip or by other means that the Board considers appropriate. Any dividend unclaimed shall be forfeited and shall revert to the Company in accordance with the Bye-Laws of the Company.

The Board will review the Dividend Policy as appropriate from time to time.

*Impairment assessment of goodwill and other intangible assets*

As at 31st March 2024, the Group had goodwill and other intangible assets of approximately HK\$393.7 million relating to the cash-generating units ("CGUs") of hi-tech distribution and services and electronic payment solution. In accordance with HKAS 36 Impairment of Assets, management is required to test goodwill for impairment annually and to test other intangible assets for impairment where an indication of impairment exists.

We focused on this area because the carrying amount of goodwill and other intangible assets of the CGUs are significant to the Group and this impairment test and assessment is based on the recoverable amount of the CGUs as determined in value-in-use calculations, which required significant management judgement and estimates with respect to pre-tax cash flow projection based on financial budget approved by management covering a five-year period. The projection is largely based on management expectations and estimates of future results of the CGUs.

Disclosures in relation to goodwill and other intangible assets are included in notes 4 and 15 to the consolidated financial statements.

Our audit procedures included the assessment of the valuation methodology and the key assumptions, such as the continuance of distribution rights of hi-tech distribution and services operation, revenue growth rate, budgeted gross margin and the discount rates, based on our knowledge of the business and industry.

We checked the input data to supporting evidence, such as the approved budgets and the recent historical results of the CGUs. We also involved our internal valuation specialists to assist us with the assessment of the methodologies and the discount rates used to determine the recoverable amounts. We also assessed the adequacy of the disclosures in the financial statements.

於二零二四年三月三十一日，貴集團擁有高科技產品分銷及服務以及電子支付解決方案相關之現金產生單位（「現金產生單位」）之商譽及其他無形資產約393,700,000港元。根據香港會計準則第36號資產減值，管理層須每年就商譽進行減值測試，並對有減值跡象的其他無形資產進行減值測試。

### 1. CORPORATE AND GROUP INFORMATION

North Asia Strategic Holdings Limited (the “Company”) and its subsidiaries (collectively, the “Group”) are principally engaged in the following businesses during the year:

- **hi-tech distribution and services:** trading of surface mount technology (“SMT”) assembly machinery and spare parts and provision of related installation, training, repair and maintenance services for SMT assembly machinery;
- **leasing:** provision of finance to its customers via a wide array of assets under finance lease arrangements and operating lease arrangements, and trading of lease assets;
- **electronic payment solution:** provision of payment solution that bridges online payment acquirers and the merchants; and
- **property and investment holding.**

The Company is a limited liability company incorporated in Bermuda as an exempted company under the Bermuda Companies Act 1981 (the “Companies Act”). The address of its registered office is Clarendon House, 2 Church Street, Hamilton HM 11, Bermuda and that of its principal place of business is Suite 1618, 16th Floor, Jardine House, 1 Connaught Place, Central, Hong Kong.

The Company’s ordinary shares are listed on GEM of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”).

These financial statements have been approved and authorised for issue by the Company’s board of directors on 27th June 2024.

### 1. 企業及集團資料

- **租賃：**透過融資租賃安排及經營租賃安排下之各種資產向其客戶提供融資以及租賃資產貿易；
- **電子支付解決方案：**提供支付解決方案，連結網上支付收單機構與商戶；及
- **物業及投資控股。**

The nature and the impact of the new revised HKFRSs are described below:

- (a) Amendments to HKAS 1 require entities to disclose their material accounting policy information rather than their significant accounting policies. Accounting policy information is material if, when considered together with other information included in an entity's financial statements, it can reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements. Amendments to HKFRS Practice Statement 2 *Making Materiality Judgements* provide non-mandatory guidance on how to apply the concept of materiality to accounting policy disclosures. Upon initial application of these amendments, the Group recognised (i) a deferred tax asset for all deductible temporary differences associated with lease liabilities (provided that sufficient taxable profit is available), and (ii) a deferred tax liability for all taxable temporary differences associated with right-of-use assets as at 1st April 2022. The amendments are effective for annual periods beginning on or after 1st January 2024 and shall be applied retrospectively to sale and leaseback transactions entered into after the date of initial application of HKFRS 16 (i.e., 1st January 2019). Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

The 2020 Amendments clarify the requirements for classifying liabilities as current or non-current, including what is meant by a right to defer settlement and that a right to defer must exist at the end of the reporting period. Classification of a liability is unaffected by the likelihood that the entity will exercise its right to defer settlement. The amendments also clarify that a liability can be settled in its own equity instruments, and that only if a conversion option in a convertible liability is itself accounted for as an equity instrument would the terms of a liability not impact its classification. The 2022 Amendments further clarify that, among covenants of a liability arising from a loan arrangement, only those with which an entity must comply on or before the reporting date affect the classification of that liability as current or non-current. Additional disclosures are required for non-current liabilities that are subject to the entity complying with future covenants within 12 months after the reporting period. The amendments shall be applied retrospectively with early application permitted. An entity that applies the 2020 Amendments early is required to apply simultaneously the 2022 Amendments, and vice versa. The Group is currently assessing the impact of the amendments and whether existing loan agreements may require revision. Based on a preliminary assessment, the amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to HKAS 7 and HKFRS 7 clarify the characteristics of supplier finance arrangements and require additional disclosure of such arrangements. Earlier application of the amendments is permitted. The consolidated financial statements include the financial statements of the Company and its subsidiaries for the year ended 31st March 2024. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

綜合財務報表包括本公司及其附屬公司截至二零二四年三月三十一日止年度之財務報表。附屬公司乃本公司直接或間接控制之實體(包括結構性實體)。當本集團承擔或享有來自參與被投資對象之可變回報之權利及能透過對被投資對象之權力(即賦予本集團現有有能力操控被投資對象之相關活動之現有權利)影響該等回報時，則達致控制權。

倘本公司擁有被投資對象少於大多數之投票或類似權利，則本集團於評估其是否對被投資對象擁有權力時會考慮一切相關事實及情況，包括：

- (a) 與被投資對象之其他投票持有之合約安排；
- (b) 其他合約安排所產生之權利；及
- (c) 本集團之投票權及潛在投票權。

附屬公司之財務報表乃就與本公司相同之報告期間編製，並採用一致之會計政策。附屬公司之業績由本集團取得控制權之日起綜合入賬，並繼續綜合入賬至該等控制權終止之日。

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises the related assets (including goodwill), liabilities, any non-controlling interest and the exchange fluctuation reserve and recognises the fair value of any investment retained and any resulting surplus or deficit in the statement of profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to the statement of profit or loss or accumulated losses, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

損益及其他全面收益之各個組成項目乃歸屬於本集團母公司擁有人及非控制性權益，即使這會導致非控制性權益出現虧絀結餘。與本集團成員公司間進行之交易相關之所有集團內公司間資產與負債、權益、收入、開支及現金流量已於綜合賬目時悉數對銷。

倘有事實及情況顯示上述三項控制因素中有一項或多項出現變動，則本集團會重新評估其是否對被投資對象擁有控制權。如附屬公司擁有權益出現變動，但未有喪失控制權，則入賬列作權益交易。

倘本集團喪失一間附屬公司之控制權，則其撤銷確認相關資產(包括商譽)、負債、任何非控制性權益及匯兌波動儲備；及確認任何所保留投資之公允值及損益表內任何因此產生之盈餘或虧絀。先前於其他全面收益內確認之本集團應佔部分按倘本集團直接出售相關資產或負債而原須採用之相同基準重新分類至損益表或累計虧損(按適用)。

#### ***Business combinations and goodwill***

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

The Group determines that it has acquired a business when the acquired set of activities and assets includes an input and a substantive process that together significantly contribute to the ability to create outputs.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

業務合併乃採用收購法入賬。所轉撥之代價按收購日期之公允值計量，即本集團所轉撥之資產、本集團對被收購方原擁有人產生之負債及本集團就交換被收購方之控制權所發行之股權於收購日期之公允值總和。於各業務合併中，本集團選擇以公允值或被收購方可識別資產之應佔比例，計算於被收購方之非控制性權益。非控制性權益之所有其他部分按公允值計量。收購相關成本於產生時列為開支。

當所收購之一系列活動及資產包括對創造產出能力有重大貢獻的投入及實質性進程，本集團認為其已收購一項業務。

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in the statement of profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31st March. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

倘業務合併分階段進行，早前持有之股權將按其於收購日期之公允值重新計量，而任何產生之盈虧將於損益內確認。

任何將由收購方轉讓之或然代價均於收購日期以公允值確認。獲分類為資產或負債之或然代價將按公允值計量，而公允值之變動將於損益內確認。獲分類為權益之或然代價將不會獲重新計量，而後結算將於權益內入賬。

商譽初次按成本計量，即已轉讓代價、已確認非控制性權益及先前由本集團持有之被收購方股權之公允值總額，超過與所收購可識別資產淨值及所承擔負債之差額。倘此代價及其他項目之總和低於所收購資產淨值之公允值，於重新評估後其差額將於損益表內確認為議價收購收益。

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash-generating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation of and the portion of the cash-generating unit retained.

### 2.5 Fair value measurement

The Group measures its financial assets at fair value through profit or loss at fair value at the end of each reporting period.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

當商譽已獲分配至一個現金產生單位(或一組現金產生單位)，而當該單位之部分業務被出售時，有關出售業務之附帶商譽計入該業務之賬面值內，以釐定該項出售之盈虧。在此等情況下，出售之商譽乃根據所保留之現金產生單位業務及部分之相對價值計量。

本集團於各報告期末按公允值計量其按公允值計入損益之金融資產。

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

Level 1 – based on quoted prices (unadjusted) in active markets for identical assets or liabilities

Level 2 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly

Level 3 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

For assets and liabilities that are recognised in the financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by reassessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

Where an indication of impairment exists, or when annual impairment testing for non-financial asset is required (other than inventories, deferred tax assets and financial assets), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs.

In testing a cash-generating unit for impairment, a portion of the carrying amount of a corporate asset (e.g., a headquarters building) is allocated to an individual cash-generating unit if it can be allocated on a reasonable and consistent basis or, otherwise, to the smallest group of cash-generating units.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the statement of profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

除存貨、遞延稅項資產及金融資產外，倘非金融資產有減值跡象或須每年進行減值測試，則估計該資產之可收回金額。資產之可收回金額為資產或現金產生單位之使用價值及其公允值減出售成本兩者中之較高者，並視乎個別資產而釐定，除非該資產並無產生大致獨立於其他資產或資產組別之現金流入，於此情況下就資產所屬之現金產生單位釐定可收回金額。

A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years.

Property, plant and equipment are stated at cost less accumulated depreciation and any accumulated impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the statement of profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other repair and maintenance costs are charged to the statement of profit or loss during the financial period in which they are incurred.

物業、廠房及設備按成本減累計折舊及任何累計減值虧損入賬。物業、廠房及設備項目成本包括其購買價及使該等資產達致運作狀態及位置以用作擬定用途直接應佔之成本。

物業、廠房及設備項目投入運作後產生之支出(如維修及保養)一般於產生期間在損益表內列為支出。在符合確認條件之情況下,主要檢驗支出亦作為重置於資產之賬面值內資本化。倘物業、廠房及設備之重要部分須定期更換,則本集團將有關部分確認為具有特定可使用年期之獨立資產,並相應計算折舊。

Depreciation is calculated using the straight-line method to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. Their estimated useful lives are as follows:

The assets' residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at the end of each reporting period.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with carrying amounts and are recognised in the statement of profit or loss.

### 2.9 Investment properties

Investment properties are interests in land and buildings (including right-of-use assets) held to earn rental income and/or for capital appreciation. Such properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at cost less subsequent accumulated depreciation and any accumulated impairment losses.

Depreciation is calculated on the straight-line basis to write off the cost of investment properties over their estimated useful lives. The principal annual rates used for this purpose are as follows:

Buildings	2.5%

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use and no future economic benefits are expected from its disposal. Any gain or loss arising on derecognition of property (calculated as difference between the net disposal proceeds and the carrying amount of the asset) is included in profit or loss in the period in which the property is derecognised.

Any impairment losses on investment properties are included in the statement of profit or loss in the year in which they arise.

投資物業於出售時或當投資物業不再可供使用及預期出售事項將無法帶來未來經濟利益時取消確認。終止確認物業產生之任何盈虧(計算為出售所得款項淨額與該資產賬面值間差額)計入物業終止確認期間之損益內。

投資物業之任何減值虧損均計入其產生年度之損益表。

### 2.10 Intangible assets (other than goodwill)

Intangible assets acquired separately are measured on initial recognition at cost. The cost of intangible assets acquired in a business combination is the fair value at the date of acquisition. The useful lives of intangible assets are assessed to be either finite or indefinite. Intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at each financial year end.

Intangible assets with indefinite useful lives are tested for impairment annually either individually or at the cash-generating unit level. Such intangible assets are not amortised. The useful life of an intangible asset with an indefinite life is reviewed annually to determine whether the indefinite life assessment continues to be supportable. If not, the change in the useful life assessment from indefinite to finite is accounted for on a prospective basis.

Amortisation of intangible assets is calculated using the straight-line method to allocate the cost over their estimated useful lives as follows:

單獨取得之無形資產於初始確認時按成本計量。業務合併中所收購之無形資產成本為於收購日期之公允值。無形資產之可使用年期被評估為有限或無限。可使用年期有限之無形資產其後按可使用經濟年期進行攤銷，並於無形資產可能存在減值跡象時進行減值評估。可使用年期有限之無形資產攤銷期限及攤銷方法至少須於各財政年度末進行審閱。

可使用年期無限之無形資產每年單獨或在現金產生單位層面進行減值測試。該等無形資產不予攤銷。每年就年期無限之無形資產的可使用年期進行審閱，以確定無限可使用年期評估是否持續可靠。若否，可使用年期評估由無限變更至有限則按前瞻性基準入賬。

### 2.11 Leases

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

#### Group as a lessee

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

#### (a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease terms and the estimated useful lives of the assets as follows:

If ownership of the leased asset transfers to the Group by the end of the lease term or the cost reflects the exercise of a purchase option, depreciation is calculated using the estimated useful life of the asset.

本集團於合約開始時評估合約是否為或包含租賃。倘合約為換取代價而給予在一段時間內控制使用已識別資產之權利，則該合約為或包含租賃。

#### 本集團作為承租人

本集團對所有租賃採取單一確認及計量方法，惟短期租賃及低價值資產租賃除外。本集團確認租賃負債以作出租賃付款，而使用權資產指使用相關資產之權利。

#### (a) 使用權資產

使用權資產於租賃開始日期(即相關資產可供使用之日期)確認。使用權資產按成本減任何累計折舊及任何減值虧損計量，並就租賃負債之任何重新計量作出調整。使用權資產之成本包括已確認租賃負債金額、已發生初始直接成本及於開始日期或之前支付之租賃付款減已收取之任何租賃優惠。使用權資產於估計使用年期及租賃期(以較短者為準)內以直線法折舊如下：

倘租賃資產之所有權於租賃期末轉移至本集團或成本反映行使購買權，則使用該資產之估計使用年期計算折舊。

##### (b) Lease liabilities

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate the lease. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

##### (b) 租賃負債

租賃負債於租賃開始日期按於租賃期內作出之租賃付款現值確認。租賃付款包括固定付款(包括實質固定付款)減任何應收租賃優惠、取決於某一指數或比率之可變租賃付款及預期根據在剩餘價值擔保中將支付之金額。租賃付款亦包括本集團合理確定行使購買選擇權之行使價，並倘租賃期反映了本集團行使終止租賃選擇權，則須就終止租賃支付罰款。並非取決於某一指數或比率之可變租賃付款於觸發付款之事件或狀況出現期間確認為開支。

於計算租賃付款現值時，由於租賃中所隱含之利率不易釐定，本集團於租賃開始日期使用其增量借貸利率。於開始日期後，租賃負債金額增加，以反映利息增加及就所付之租賃付款減少。此外，倘出現修改、租期變動、租賃付款變動(如指數或比率變動所致之未來租賃付款變動)或購買相關資產之選擇權評估更改，租賃負債之賬面值將重新計量。

##### (c) Short-term leases and leases of low-value assets

The Group applies the short-term lease recognition exemption to its short-term leases of office properties and warehouses (that is those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the recognition exemption for leases of low-value assets to leases that are considered to be of low value. Lease payments on short-term leases and leases of low-value assets are recognised as an expense on a straight-line basis over the lease term.

#### **Group as a lessor**

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. Rental income is accounted for on a straight-line basis over the lease terms and is included in other income and gains in the statement of profit or loss due to its non-operating nature. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. Contingent rents are recognised as revenue in the period in which they are earned.

##### (c) 短期租賃及低價值資產租賃

本集團將短期租賃確認豁免應用於其辦公室物業及倉庫之短期租賃(即自開始日期起租期為12個月或以下且不包含購買選擇權之租賃)。本集團亦將低價值資產租賃之確認豁免應用於被視為低價值之辦公室設備租賃。短期租賃之租賃付款及低價值資產租賃在租期內以直線法確認為開支。

#### **本集團作為出租人**

當本集團作為出租人時，其於租賃開始時(或出現租賃修改時)將其租賃各自分類為經營租賃或融資租賃。

本集團不會轉讓資產擁有權附帶之絕大部分風險及回報之租賃分類為經營租賃。當合約包含租賃及非租賃部分時，本集團根據相對獨立售價將合約中之代價分配予各部分。租金收入於租期內以直線法入賬，並因其非經營性質而於損益表中列為其他收入及收益。磋商及安排經營租賃所產生之初始直接成本加入租賃資產之賬面值，並於租期內按相同基準確認為租金收入。或然租金於產生期間確認為收益。

#### **Group as a lessor (Continued)**

Leases that transfer substantially all the risks and rewards incidental to ownership of an underlying asset to the lessee are accounted for as finance leases. At the commencement date, the cost of the leased asset is capitalised at the present value of the lease payments and related payments (including the initial direct costs), and presented as a receivable at an amount equal to the net investment in the lease. The finance income on the net investment in the lease is recognised in the statement of profit or loss so as to provide a constant periodic rate of return over the lease terms.

### 2.12 Investments and other financial assets

#### **Initial recognition and measurement**

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value, plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under HKFRS 15 in accordance with the policies set out for "Revenue recognition" below.

凡將相關資產擁有權之絕大部分風險及回報撥歸承租人之租賃，均列為融資租賃。於開始日期，租賃資產之成本按租賃付款及相關付款(包括初始直接成本)之現值撥充資本並呈列為應收款項，金額等同於租賃之投資淨額。租賃之投資淨額之財務收入於損益表內確認，以便於租期內提供固定定期回報率。

### 2.12 投資及其他金融資產

#### **初步確認及計量**

金融資產於初步確認時分類為隨後按攤銷成本計量及按公允值計入損益。

金融資產於初步確認時的分類視乎金融資產合約現金流量的特徵及本集團管理該等資產的業務模式。除並無重大融資成分或本集團並未就此應用不調整重大融資成分影響實際權宜方法的貿易應收款項外，本集團初步按其公允值加(倘並非按公允值計量且其變動計入損益的金融資產)交易成本計量金融資產。按下文「收益確認」所載政策，並無重大融資成分或本集團並未就此應用實際權宜方法的貿易應收款項按香港財務報告準則第15號釐定的交易價格計量。

#### *Initial recognition and measurement (Continued)*

In order for a financial asset to be classified and measured at amortised cost or fair value through other comprehensive income, it needs to give rise to cash flows that are solely payments of principal and interest (“SPPI”) on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

The Group’s business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

Purchase or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset.

#### *初步確認及計量(續)*

為使金融資產按攤銷成本或按公允值計量且其變動計入其他全面收入分類及計量，需產生僅為支付本金及未償還本金利息(「SPPI」)的現金流量。不論其業務模式如何，現金流量不僅為支付本金及未償還本金利息之金融資產按公允值計入損益分類及計量。

本集團管理金融資產的業務模式指為產生現金流量管理金融資產的方式。業務模式釐定現金流量會否來自收取合約現金流量、出售金融資產或以上兩者。按攤銷成本分類及計量之金融資產於目的為持有金融資產以收取合約現金流量的業務模式持有，而按公允值計入其他全面收益分類及計量之金融資產於目的為持有以收取合約現金流量及出售的業務模式持有。並非於上述業務模式持有之金融資產按公允值計入損益分類及計量。

需在市場規例或慣例規定的一般期限內交付資產的金融資產買賣均於交易日(即本集團承諾購買或出售資產之日)確認。

The subsequent measurement of financial assets depends on their classification as follows:

#### **Financial assets at amortised cost (debt instruments)**

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in the statement of profit or loss when the asset is derecognised, modified or impaired.

#### **Financial assets at fair value through profit or loss**

Financial assets at fair value through profit or loss are carried in the statement of financial position at fair value with positive net changes in fair value presented as other income and gains and negative net changes in fair value presented as other expense in the statement of profit or loss.

金融資產的後續計量視乎以下分類：

#### **按攤銷成本列賬的金融資產(債務工具)**

按攤銷成本列賬的金融資產隨後使用實際利率法計量，並可予減值。收益及虧損於資產終止確認、修改或減值時於損益表中確認。

#### **按公允值計入損益之金融資產**

按公允值計入損益之金融資產，在財務狀況表中以公允值列示，公允值正變動淨額於損益表內呈列為其他收入及收益，而公允值負變動淨額則呈列為其他費用。

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e. removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates, if and to what extent, it has retained the risks and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the asset is recognised to the extent of the Group's continuing involvement in the asset. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

金融資產(或(倘適用)一項金融資產之一部分或一組類似金融資產之一部分)主要於下列情況下終止確認(即從本集團之綜合財務狀況表中移除):

- 從該資產收取現金流量之權利已到期; 或
- 本集團已轉讓其從該資產收取現金流量之權利, 或已根據「轉付」安排承擔責任向第三方全數支付所收取之現金流量, 而不得出現重大延誤; 且 (a) 本集團已轉讓該資產之絕大部分風險及回報; 或 (b) 本集團並無轉讓或保留該資產之絕大部分風險及回報, 惟已轉讓該資產之控制權。

倘本集團已轉讓其從資產收取現金流量之權利或已訂立轉付安排, 其將評估其是否保留該資產擁有權之風險及回報以及保留之程度。倘其並無轉讓或保留該資產之絕大部分風險及回報, 亦無轉讓該資產之控制權, 則以本集團持續參與該資產之程度為限確認該資產。在此情況下, 本集團亦確認相關負債。已轉讓資產及相關負債乃按可反映本集團所保留權利及責任之基準計量。

### 2.14 Impairment of financial assets

The Group recognises an allowance for expected credit losses (“ECLs”) for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

#### **General approach**

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

本集團就所有並非按公允值計入損益持有的債務工具確認預期信貸虧損(「預期信貸虧損」)撥備。預期信貸虧損乃以根據合約應付的合約現金流量與本集團預期收取的所有現金流量之間的差額為基準，按原有實際利率相近的差額貼現。預期現金流量將包括來自銷售所持有抵押品或其他信用增級的現金流量，此乃合約條款不可或缺的部分。

#### **一般方法**

預期信貸虧損於兩個階段進行確認。對於自初步確認後並無顯著增加的信貸風險，預期信貸虧損就可能於未來12個月內(12個月預期信貸虧損)出現的違約事件計提撥備。對於自初步確認後有顯著增加的信貸風險，須在信貸虧損風險預期的剩餘年期計提虧損撥備，不論違約事件於何時發生(全期預期信貸虧損)。

於各報告日期，本集團評估自初始確認後金融工具的信貸風險是否顯著增加。於進行評估時，本集團將於報告日期金融工具發生之違約風險與初始確認日起金融工具發生之違約風險進行比較，並會考慮合理且可支持的資料，包括無需付出不必要的成本或努力而可得之歷史及前瞻性資料。

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables which apply the simplified approach as detailed below.

Stage 1 – Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs

Stage 2 – Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs

Stage 3 – Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs

For finance lease receivables included in trade and other receivables that contain a significant financing component, the Group chooses as its accounting policy to adopt the general approach in calculating ECLs with policies as described above.

本集團將合約付款逾期90日的金融資產視作違約。然而，於若干情況下，當內部或外部資料顯示本集團不可能在本集團採取任何信貸提升安排前悉數收回未償還合約金額時，本集團亦可能認為該金融資產違約。當合理預期不會收回合約現金流量時，金融資產將予撇銷。

按攤銷成本計量的金融資產，在一般方法下可能會發生減值，並且除了採用簡化方法的貿易應收款項(以下詳述)外，彼等在以下階段分類用於預期信貸虧損計量。

第一階段 – 金融工具自初始確認以來信貸風險未顯著增加，且其虧損撥備按相等於12個月預期信貸虧損之金額計量

第二階段 – 金融工具自初始確認後信貸風險顯著增加，但並非信貸減值金融資產且其虧損撥備按相等於全期預期信貸虧損之金額計量

第三階段 – 於報告日期信貸減值的金融資產(但非購買或原始信貸減值)，其虧損撥備按相等於全期預期信貸虧損之金額計量

就計入包含重大融資成分的貿易及其他應收款項之融資租賃應收款項而言，本集團會計政策選擇採用一般方法根據上述政策進行預期信貸虧損計量。

#### **Simplified approach**

For trade receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

### 2.15 Financial liabilities

#### **Initial recognition and measurement**

Financial liabilities are classified, at initial recognition, as loans and borrowings, or payables, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

The Group's financial liabilities include trade and other payables and borrowings.

#### **Subsequent measurement**

The subsequent measurement of financial liabilities depends on their classification as follows:

#### **簡化方法**

對於不包含重大融資成分的貿易應收款項，或本集團採用實際權宜之計，不會就重大融資成分的影響調整時，本集團採用簡化方法進行預期信貸虧損計量。根據簡化方法，本集團不會追蹤信貸風險的變化，而是於各報告日期根據全期預期信貸虧損確認虧損撥備。本集團已根據其歷史信貸虧損經驗建立撥備矩陣，並根據債務人及經濟環境的前瞻性因素作出調整。

### 2.15 金融負債

#### **初步確認及計量**

金融負債於初步確認時分類為貸款及借貸或應付款項(倘適用)。

所有金融負債初步按公允值確認，而貸款及借貸及應付款項則於扣除直接應佔交易成本後確認。

本集團之金融負債包括貿易應付款項及其他應付款項以及借貸。

#### **其後計量**

### 2.15 Financial liabilities (Continued)

#### **Financial liabilities at amortised cost (trade and other payables, and borrowings)**

After initial recognition, trade and other payables, and interest-bearing borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in the statement of profit or loss.

### 2.16 Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the statement of profit or loss.

#### **按攤銷成本計量之金融負債(貿易應付款項及其他應付款項以及借貸)**

於初步確認後，貿易應付款項及其他應付款項以及計息借貸其後採用實際利率法按攤銷成本計量，惟倘貼現之影響並不重大，則在此情況下按成本列賬。終止確認負債及透過實際利率攤銷過程中產生之盈虧會於損益表內確認。

計算攤銷成本時會考慮收購所產生之任何折讓或溢價，亦包括作為實際利率不可或缺部分之費用或成本。實際利率攤銷計入損益表內之財務費用。

### 2.16 終止確認金融負債

金融負債在該負債項下之責任獲履行、被取消或到期時終止確認。

倘同一貸款人以另一項具重大條款差異之金融負債取代現有金融負債，又或現有負債之條款被大幅修改，則該等取代或修改被視為終止確認原負債並確認新負債，而有關賬面值之差額於損益表內確認。

### 2.17 Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

### 2.18 Share capital

Ordinary shares and non-redeemable preference shares are classified as equity.

Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

### 2.19 Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the first-in, first-out basis. Net realisable value is based on estimated selling price less any estimated costs to be incurred to completion and disposal.

### 2.20 Cash and cash equivalents

Cash and cash equivalents in the statement of financial position comprise cash on hand and at banks, and short-term highly liquid deposits with a maturity of generally within three months that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and held for the purpose of meeting short-term cash commitments.

### 2.17 抵銷金融工具

當現時存在一項可依法強制執行之權利可抵銷已確認金額，且亦有意以淨額基準結算或同時變現資產並償付負債時，則金融資產及金融負債可予抵銷，而其淨額於財務狀況表內呈報。

### 2.18 股本

普通股及不可贖回優先股分類為權益。

直接歸屬於發行新股或購股權之遞增成本在權益內列為所得款項之減少(扣除稅項)。

### 2.19 存貨

存貨按成本及可變現淨值兩者中之較低者列賬。成本按先進先出基準釐定。可變現淨值乃按估計售價減完成及出售將產生之任何估計成本而計算得出。

### 2.20 現金及現金等值項目

財務狀況表內之現金及現金等值項目由手頭現金及銀行存款以及到期日一般為三個月內之短期高流動性存款組成，該等存款可隨時轉換為已知金額現金、須承擔價值變動之風險不大及為滿足短期現金承擔而持有。

#### 2.20 Cash and cash equivalents (Continued)

For the purpose of the consolidated statement of cash flow, cash and cash equivalents comprise cash on hand and at banks, and short-term deposits as defined above, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

#### 2.21 Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in the statement of profit or loss.

#### 2.22 Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the tax authorities, based on tax rates (and tax laws) that have been enacted or substantially enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

就綜合現金流量表而言，現金及現金等值項目由手頭及銀行現金以及上文所界定的短期存款組成，減須按要求償還並構成本集團現金管理組成部分的銀行透支。

當因以往事件而承擔現有法律或推定責任，且較可能需要有未來資源外流以償付責任，惟在可可靠估計該責任金額之前提下，將會確認撥備。

當貼現影響屬重大時，就撥備確認之金額為預期將須償付責任之未來開支於報告期末之現值。隨時間流逝所產生之已貼現現值金額增加在損益表中列為財務費用。

#### 2.22 所得稅

Deferred tax is provided, using the liability method, on all temporary differences at the end of each reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss and does not give rise to equal taxable and deductible temporary differences; and
- in respect of taxable temporary differences associated with investments in subsidiaries, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax assets are recognised for all deductible temporary differences, and the carryforward of unused tax credits and any unused tax losses. Deferred tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carryforward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss and does not give rise to equal taxable and deductible temporary differences; and

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and deferred tax liabilities are offset if a legally enforceable right exists to set off current tax assets against current tax liabilities and the deferred taxes relate to the same taxable entity and the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

### 2.23 Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, for which it is intended to compensate, are expensed.

### 2.24 Revenue recognition

#### *Revenue from contracts with customers*

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

倘可合理確定將會收取政府補助且將遵守所有附帶條件，則該補助按其公允值確認。當該補助與開支項目有關時，其於擬予補償之成本支銷期間內以系統性基準確認為收入。

### 2.24 收入確認

#### *來自客戶合約的收益*

來自客戶合約的收益乃於商品或服務的控制權轉讓予客戶時確認，該金額能反映本集團預期就交換該等商品或服務有權獲得的代價。

當合約中的代價包含可變金額時，代價金額於本集團向客戶轉讓商品或服務而有權獲得交換時估計。可變代價於合約開始時估計並受到約束，直至與可變代價相關的不確定因素得到解決時，確認的累積收益金額極有可能不會發生重大收益回撥。

#### *Revenue from contracts with customers (Continued)*

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

#### (a) *Sale of goods*

Revenue from the sale of goods is recognised at the point in time when control of the asset is transferred to the customer.

Incidental to the sale of machinery, the Group also provides installation services in accordance with the terms of the contracts with customers. These services, which are not separately provided by the Group and are bundled together with the sale of machinery to customers, are combined with the sale of machinery into a functional machinery for which the customers have contracted. Accordingly, revenue from the sale of machinery with installation services is recognised at the point in time when the respective installation services are completed.

當合約中包含融資成分，該融資成分為客戶提供超過一年的商品或服務轉讓融資的重大利益時，收益按應收款項的現值計量，使用貼現率折現，該貼現率將反映在本集團與客戶在合同開始時的單獨融資交易中。當合約中包含融資部分，該融資部分為本集團提供一年以上的重大財務利益時，合約項下確認的收益包括按實際利息法在合約負債上加算的利息。就客戶付款至轉讓承諾商品或者服務的期限為一年或者更短的合約而言，交易價格採用香港財務報告準則第15號中實際權宜之計，不會對重大融資部分的影響作出調整。

#### (a) *銷售貨品*

銷售貨品之收入於資產控制權轉移至客戶之時間點確認。

附帶於銷售機器，本集團亦根據客戶合約之條款提供安裝服務。該等服務並非由本集團獨立提供而是向客戶銷售機器捆綁提供。該等服務與銷售機器結合在一起，成為客戶已簽約之功能性機器。因此，於完成相關安裝服務之時間點確認來自銷售具有安裝服務機器之收入。

(b) *Sales support services*

Revenue from the provision of sales support services is recognised at the point in time when the installation services in relation to the underlying machinery are completed.

(c) *E-payment service income*

Revenue from the provision of payment solution is recognised at the point in time when the e-payment services are completed.

(d) *Other service income*

Other service income is recognised over time because the customer simultaneously receives and consumes the benefits provided by the Group. Given that this service is generally completed within a short period of time, the revenue from the provision of this service is generally recognised when the service has been rendered.

#### **Revenue from other sources**

Finance leasing income is recognised on an accrual basis using the effective interest method by applying the rate that discounts the estimated future cash receipts through the expected life of the net investment of the finance lease or a shorter period, when appropriate, to the net carrying amount of the net investment of the finance lease.

Rental income is recognised on a time proportion basis over the lease terms.

(b) 銷售支援服務

提供銷售支援服務之收入於與相關機器有關的安裝服務完成時之時間點確認。

(c) 電子支付服務收入

(d) 其他服務收入

其他服務收入隨著時間確認，原因為客戶同時收取及消耗由本集團提供之利益。鑑於該服務一般於短時間內完成，提供該服務之收入一般於提供服務時予以確認。

#### **其他收入來源**

融資租賃收入乃按累計基準於融資租賃淨投資之預計年期或較短期間(倘適用)確認，其採用實際利率法將估計未來現金收入貼現至融資租賃淨投資賬面淨值。

租金收入按時間比例於租期確認。

#### Other income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

Dividend income is recognised when the shareholders' right to receive payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.

### 2.25 Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

### 2.26 Share-based payments

The Company operates a share option scheme. Employees (including directors) of the Group receive remuneration in the form of share-based payments, whereby employees render services as consideration for equity instruments ("equity-settled transactions"). The cost of equity-settled transactions with employees for grants is measured by reference to the fair value at the date at which they are granted. The fair value is determined by an external valuer using a binomial model.

#### 其他收入

採用實際利率法計算按累計基準確認的利息收入，利率在金融工具的預期壽命或更短期間(倘適用)內可將估計未來現金收入準確折現至金融資產賬面淨值。

股息收入於確立股東收取付款的權利、股息涉及的經濟利益可能流入本集團，且股息數額能可靠地計量時確認。

### 2.25 合約負債

合約負債於本集團轉移相關貨品或服務前向客戶收取付款或應收付款(以較早者為準)時確認。當本集團履行合約(即相關貨品或服務之控制權轉移予客戶)時，合約負債確認為收益。

### 2.26 以股份支付

本公司設立一項購股權計劃。本集團僱員(包括董事)以股份支付形式收取酬金，而僱員提供服務作為股本工具之代價(「股權結算交易」)。就授出與僱員進行股權結算交易之成本乃參考其授出日期之公允值計量。有關公允值乃由外聘估值師按二項式模式釐定。

The cost of equity-settled transactions is recognised in employee benefit expense, together with a corresponding increase in equity, over the period in which the performance and/or service conditions are fulfilled. The cumulative expense recognised for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group's best estimate of the number of equity instruments that will ultimately vest. The charge or credit to the statement of profit or loss for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group's best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be non-vesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service and/or performance conditions.

For awards that do not ultimately vest because non-market performance and/or service conditions have not been met, no expense is recognised. Where awards include a market or non-vesting condition, the transactions are treated as vesting irrespective of whether the market or non-vesting condition is satisfied, provided that all other performance and/or service conditions are satisfied.

股權結算交易之成本連同股權相應增幅於履約及／或服務條件達成期間內確認於僱員福利開支。於各報告期末直至歸屬日期止就股權結算交易確認之累計開支反映歸屬期已屆滿及本集團對最終將歸屬之股本工具數目之最佳估計。期內扣除或計入損益表指於該期初及期末確認之累計開支變動。

於釐定獎勵之授出日期公允值時，並不會考慮服務及非市場表現條件，惟達成條件之可能性作為本集團對最終將歸屬之股本工具數目之最佳估計一部分予以評估。市場表現條件反映於授出日期公允值。獎勵附帶之任何其他條件(惟並無相關服務規定)被視為非歸屬條件。非歸屬條件反映於獎勵之公允值，並導致獎勵立即支銷，惟亦有服務及／或表現條件之情況下則另當別論。

Where the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified, if the original terms of the award are met. In addition, an expense is recognised for any modification that increases the total fair value of the share-based payments, or is otherwise beneficial to the employee as measured at the date of modification. Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately.

The dilution effect of outstanding options is reflected as additional share dilution in the computation of earnings per share.

#### 2.27 Employee benefits

##### (a) Employees' leave entitlement

Employees' entitlement to annual leave and long service leave is recognised when it accrues to employees. A provision is made for the estimated liability for annual leave and long service leave as a result of services rendered by employees up to the end of the reporting period.

Employees' entitlement to sick leave and maternity leave is not recognised until the time of leave.

#### (b) Pension obligations

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the “MPF Scheme”) under the Mandatory Provident Fund Schemes Ordinance for all of its employees. Contributions are made based on a percentage of the employees’ basic salaries and are charged to the statement of profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group’s employer contributions vest fully with the employees when contributed into the MPF Scheme.

The employees of the Group’s subsidiaries which operate in Chinese Mainland are required to participate in a central pension scheme operated by the local municipal government. The subsidiaries are required to contribute a percentage of the payroll costs to the central pension scheme. The contributions are charged to the statement of profit or loss as they become payable in accordance with the rules of the central pension scheme.

#### (c) Bonus plans

The Group recognises a liability and an expense for bonuses. It recognises a provision where contractually obliged or where there is a past practice that has created a constructive obligation.

#### (b) 退休金責任

本集團根據強制性公積金計劃條例為其所有僱員設立一項界定供款強制性公積金退休福利計劃(「強積金計劃」)。根據強積金計劃之規則，供款乃按僱員基本薪酬之若干百分比計算，並於應付時在損益表內扣除。強積金計劃的資產與本集團的資產分開，並由獨立管理之基金持有。本集團之僱主供款於對強積金計劃作出供款時悉數歸屬予僱員。

本集團於中國內地營運之附屬公司之僱員須參與由地方市政府營運之中央退休金計劃。該等附屬公司須按相關薪金成本之若干百分比向中央退休金計劃作出供款。該等供款根據中央退休金計劃之規則於應付時在損益表內扣除。

#### (c) 獎金計劃

### 2.28 Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

### 2.29 Dividends

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting.

Proposed final dividends are disclosed in the notes to the financial statements.

### 2.30 Foreign currency translation

These financial statements are presented in Hong Kong dollars, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

The functional currencies of certain group companies are currencies other than the Hong Kong dollar. As at the end of the reporting period, the assets and liabilities of these entities are translated into Hong Kong dollars at the exchange rates prevailing at the end of the reporting period and their statements of profit or loss are translated into Hong Kong dollars at the weighted average exchange rates for the year.

The resulting exchange differences are recognised in other comprehensive income and accumulated in the “Cumulative translation adjustments” under reserves. On disposal of an operation, the cumulative amount in the reserve relating to that particular operation is recognised in the statement of profit or loss.

Any goodwill arising on the acquisition of a foreign operation and any fair value adjustments to the carrying amounts of assets and liabilities arising on acquisition are treated as assets and liabilities of the foreign operation and translated at the closing rate.

For the purpose of the consolidated statement of cash flows, the cash flows of certain group companies with functional currency other than the Hong Kong dollar are translated into Hong Kong dollars at exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of these group companies which arise throughout the year are translated into Hong Kong dollars at the weighted average exchange rates for the year.

The Group's activities expose it to a variety of financial risks: market risk (including foreign exchange risk, fair value interest rate risk and cash flow interest rate risk), credit risk and liquidity risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

Risk management is carried out by the finance department of the Company under policies approved by the board of directors. The finance department identifies, evaluates and hedges financial risks in close co-operation with the Group's operating units. The board of directors provides written principles for overall risk management, as well as written policies covering specific areas, such as foreign exchange risk, interest rate risk, credit risk, the use of derivative financial instruments and non-derivative financial instruments, and investment of excess liquidity.

##### (a) Market risk

###### (i) Foreign exchange risk

The Group operates principally in Hong Kong and Chinese Mainland and is exposed to foreign exchange risk arising from various currency exposures, primarily with respect to the United States dollar (the "US dollar"), Japanese Yen, and Renminbi ("RMB"). Foreign exchange risk arises from future commercial transactions, recognised assets and liabilities and net investments in foreign operations.

Management has set up a policy to require entities within the Group to manage their foreign exchange risk against their functional currencies. Foreign exchange risk arises when future commercial transactions or recognised assets or liabilities are denominated in a currency that is not the entity's functional currency.

As the Group has no significant interest-bearing assets at floating rates except for cash and cash equivalents, its income and operating cash flows are substantially independent of changes in market interest rates.

The cash and cash equivalents earn interest at floating rates and expose the Group to cash flow interest rate risk.

The finance lease receivables earn interest at fixed rates and expose the Group to fair value interest rate risk.

The interest rate risk from financial liabilities arises from borrowings. Borrowings that are subject to variable rates expose the Group to cash flow interest rate risk.

Credit risk arises from cash and cash equivalents, trade receivables, finance lease receivables and certain other receivables.

The Group has policies in place to ensure that sales are made to customers with an appropriate financial strength and an appropriate percentage of down payment. It also has other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, the Group regularly reviews the recoverable amount of each individual receivable to ensure that adequate loss allowance is made for irrecoverable amounts. The Group implements its industry risk management system according to its plan based on the actual situation with a focus on industry research, customer credit rating, and understanding of the lessee's operations and financial condition. The Group also obtained deposits from lessees as disclosed in note 26 to the financial statements. The Group has no significant concentrations of credit risk, with exposure spreading over a number of counterparties and customers.

No credit limits were exceeded during the reporting period, and management does not expect any losses from non-performance by counterparties, except as disclosed in note 17 to the financial statements. The Group does not hold any collateral as security except for finance leasing operation, for which in the event of default, the Group may demand return of finance lease assets, repossession of finance lease assets or disposal of finance lease assets, whichever is appropriate.

#### 3.2 Capital risk management

The Group's objectives for managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns for shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

In order to maintain or adjust the capital structure, the Group may adjust the dividend payment to shareholders, return capital to shareholders, issue new shares or sell assets to reduce debt.

During the year ended 31st March 2024, the Group's strategy, which was unchanged from last year, was to maintain a net cash position. Net cash position is calculated as cash and cash equivalents less other borrowings and lease liabilities. The net cash positions as at 31st March 2024 and 2023 were analysed as follows:

Management has assessed that the fair values of cash and cash equivalents, pledged deposits, trade, bills and other receivables, trade and other payables and other borrowings approximate to their carrying amounts largely due to short term maturities of these instruments.

The Group's corporate finance team is responsible for determining the policies and procedures for the fair value measurement of financial instruments. The corporate finance team reports directly to the chief financial officer and the audit committee. At each reporting date, the corporate finance team analyses the movements in the values of financial instruments and determines the major inputs applied in the valuation. The valuation is reviewed and approved by the chief financial officer. The valuation process and results are discussed with the audit committee twice a year for interim and annual financial reporting.

The fair values of the financial assets and liabilities are included at the amount at which the instrument could be exchanged in a current transaction between willing parties, other than in a forced or liquidation sale. The following methods and assumptions were used to estimate the fair values:

The fair values of finance lease receivables have been calculated by discounting the expected future cash flows using rates currently available for instruments with similar terms, credit risk and remaining maturities. The Group uses a provision matrix to calculate ECLs for trade receivables. The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns (i.e., by customer type).

The provision matrix is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. At the reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The assessment of the correlation among historical observed default rates and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forward-looking information. The Group's historical credit loss experience and forward-looking estimates may also not be representative of a customer's actual default in the future. The information about the ECLs on the Group's trade receivables is disclosed in note 17 to the financial statements.

### 4.2 Impairment assessment of goodwill and other intangible assets

The Group tests annually whether goodwill is impaired and tests other intangible assets for impairment when an indication of impairment exists in accordance with the accounting policies stated in note 2.4 to the financial statements. For the purposes of impairment testing, goodwill and other intangible assets acquired has been allocated to an individual cash-generating unit which is reviewed for impairment based on forecast operating performance and cash flows. The recoverable amount of an asset or a cash-generating unit has been determined based on value-in-use calculations. Cash flow projection is prepared on the basis of reasonable assumptions reflective of prevailing and future market conditions, and cash flows are discounted appropriately.

#### **Performance obligations**

Information about the Group's performance obligations is summarised below:

##### *Sales of goods*

The performance obligation is satisfied when the control of the goods is transferred, generally on delivery of goods and when the respective installation services are completed. Payment is generally due within 5 to 180 days from completion of installation. Payment in advance is normally required.

##### *Sales support services*

The performance obligation is satisfied when the installation services in relation to the underlying machinery are completed. Payment is made based on the terms stipulated in the relevant agreements.

##### *E-payment service income*

The performance obligation is satisfied when the payment processing services on payment platform are completed. Payment is made based on the terms stipulated in the relevant agreements.

##### *Other service income*

The performance obligation is satisfied over time as services are rendered and payment is generally due upon completion of services, except for new customers, where payment in advance is normally required.

The amount of unsatisfied performance obligation principally comprises the balance of contract liabilities as at 31st March 2024 and 2023, which is expected to be recognised in one year.

#### 5.2 Operating segment information

For management purposes, the Group is organised into three major reportable operating segments — hi-tech distribution and services, leasing and electronic payment solution. The hi-tech distribution and services operating segment derives revenue from the sale of goods, sales of support services and other service income. The leasing operating segment derives revenue from finance lease and operating lease arrangements, and trading of lease assets. The electronic payment solution operating segment derives revenue from the provision of payment solution that bridges online payment acquirers and the merchants.

Management monitors the results of the Group's operating segments separately for the purpose of making decisions about resource allocation and performance assessment. Segment performance is evaluated based on reportable segment profit/loss, which is a measure of adjusted profit/loss before income tax. The adjusted profit/loss before income tax is measured consistently with the Group's profit/loss before income tax except that finance income, finance costs, fair value gain/loss from the Group's financial instruments as well as corporate and other unallocated expenses are excluded from such measurement.

Segment assets consist primarily of property, plant and equipment, intangible assets, right-of-use assets, other non-current assets, inventories and trade and other receivables. Unallocated assets comprise investment properties, deferred tax assets, financial assets at fair value through profit or loss, pledged deposits, cash and cash equivalents and corporate and others.

Segment liabilities consist primarily of trade and other payables, deposits received, lease liabilities and other non-current liabilities. Unallocated liabilities comprise deferred tax liabilities, income tax liabilities, other borrowings and corporate and others.

Capital expenditure comprises additions to property, plant and equipment, investment properties, intangible assets and right-of-use assets excluding assets acquired from the acquisition of a subsidiary.

**Discount rate** — The discount rate used is pre-tax and reflects specific risks relating to the unit.

In the opinion of the Company's directors, a decrease in the revenue amount in the first year of cash flow projection by 5% would cause the carrying amount of the cash-generating unit to exceed its recoverable amount by approximately HK\$2,813,000, and any reasonably possible change in the other key assumptions on which the recoverable amount is based would not cause the cash-generating unit's carrying amount to exceed its recoverable amount.

Pursuant to the enterprise income tax law of the PRC, a 10% withholding tax is levied on dividends declared to foreign investors from the foreign investment enterprises established in Chinese Mainland. The requirement is effective from 1st January 2008 and applies to earnings after 31st December 2007. A lower withholding tax rate may be applied if there is a tax treaty between Chinese Mainland and the jurisdiction of the foreign investors. For the Group, the applicable rate is 5% or 10%. The Group is therefore liable for withholding taxes on dividends distributed by those subsidiaries established in Chinese Mainland in respect of earnings generated from 1st January 2008.

As at 31st March 2024, the aggregate amount of temporary differences associated with investments in subsidiaries in Chinese Mainland for which deferred tax liabilities have not been recognised totalled approximately HK\$178,953,000 (2023: HK\$176,876,000). In the opinion of the directors, it is not probable that these subsidiaries will distribute these unremitted earnings that are subject to withholding taxes in the foreseeable future.
