## 主席報告 Chairman's Statement

致各股東：

本人謹此代表慕詩國際集團有限公司（「慕詩」或「本公司」）董事會（「董事會」）提呈本公司及其附屬公司（統稱「本集團」）截至二零二四年三月三十一日止年度（「本年度」）之業績。

### 市場概覽

於本年度，經營環境仍然複雜多變。新冠肺炎疫情後的復甦遜於預期。一些發達國家的主要中央銀行為求竭力抑制居高不下的通脹而將利率繼續維持於高水平。地緣政治緊張局勢亦不斷升溫。在中國，政府仍在努力振興經濟，尤其是正在應對房地產行業危機。

雖然中國的國內生產總值達到二零二三年的增長目標，但經濟仍有待增強，才能恢復消費者信心。中國政府需調低利率以刺激經濟及在中美關係緊張局勢下促進貿易，因而令人民幣兌美元匯率走低，中國的貨幣疲弱影響了其出境旅客的購買力。

Dear Fellow Shareholders,

On behalf of the board of Directors (the "Board") of Moisselle International Holdings Limited ("Moisselle" or the "Company"), I present the results of the Company and its subsidiaries (which are collectively referred to as the "Group") for the year ended 31 March 2024 (the "Year").

### MARKET OVERVIEW

The business environment remained volatile and complicated during the Year. The post-COVID-19 pandemic recovery fell short of expectations. Interest rates stayed at high levels as major central banks of some developed countries tried hard to rein in the irrepressibly high inflation. Geopolitical tensions were escalating. In China, the government was still endeavouring to revive the economy and, specifically, to cope with the ongoing crisis in the property sector.

Although China met the gross domestic product growth target in 2023, its economy had yet to be strengthened enough to restore consumer confidence. Its currency renminbi weakened against the United States dollar as the Chinese government needed to cut interest rates to stimulate the economy and boost trade amid the strained Sino-United States relations. The weakened Chinese currency affected the buying power of the outbound Chinese tourists.

中國內地旅客佔到訪香港旅客的絕大多數，然而，香港旅遊業及零售市場仍未回復至疫情前水平。這裏有幾個原因：首先，二零二三年的訪港旅客人數僅恢復至二零一九年疫情爆發前水平的約60%。其次，人民幣走弱、以及國內生意及就業前景黯淡，令訪港的內地旅客無論在人數、購買力及平均客單價均較疫情前有所下降；此外，他們現時更偏好於觀光而非購物。其三，香港居民北上中國內地休閒消費已蔚然成風，對本地零售及餐飲市場亦造成影響。

因此，香港及中國內地的高端服裝零售市場尚未完全恢復。

除宏觀經濟及地緣政治局勢的影響外，近年亦有其他因素正在重塑時裝行業，包括人口變化趨勢，例如年輕一代的消費者湧現，他們的消費行為及偏好與較年長的消費者不同；人口老齡化及更為長壽；以及互聯網、電子商務及社交媒體等資訊科技的普及等。迎合年輕一代及更長壽和富有青春活力的中年人的喜好，並充分利用資訊科技推廣及銷售產品，是時裝行業適應市場轉變的必由之路。

In Hong Kong, where Mainland Chinese tourists accounted for a significant majority of the city's visitor arrivals, both the tourism and retail market had yet to recover to the pre-pandemic levels. For one thing, the visitor arrivals in Hong Kong in 2023 only recovered to about 60% of the pre-pandemic level in 2019. Secondly, there were decreases in the number of the Mainland Chinese tourists in Hong Kong and in terms of their buying power and the average transaction size compared with the pre-pandemic levels due to the weaker renminbi and the bleaker business outlook and employment prospect; their interest also shifted more to sightseeing from shopping. Thirdly, the growing trend of Hong Kong's residents' northbound cross-border travel to Mainland China for relaxation and consumption also affected the city's local retail and catering markets.

As a result, the high-end apparel retail markets of Hong Kong and Mainland China had yet to fully recover.

In addition to the impact of the macroeconomic and geopolitical situation, a number of other factors have also been reshaping the fashion apparel industry in recent years, including demographic trends such as the emergence of a younger generation of consumers whose consumption behaviour and preferences are different from those of the older generations; population aging and longer life expectancy; and the advent of information technologies such as the internet, electronic commerce and social media. Catering to the preferences of both the younger generation and the youthful, energetic middle-aged people with longer life expectancy as well as making full use of the information technologies to promote and sell the products are the way forward for the industry.

### 業績

慕詩之主要業務為零售高檔及中高檔女士時尚服飾。為適應市場變化，在迎合中年客戶喜好的同時，亦更着重設計和銷售迎合年輕一代客戶的流行服裝。於本年度，由於香港及中國內地的高端服裝零售市場尚未完全恢復至疫情爆發前水平，慕詩仍然錄得虧損。在佔本集團總銷售收入約61%的香港，服裝零售市場正逐漸改善，但中國內地遊客的購買力較疫情爆發前有所下降。

本集團於本年度錄得虧損約49,000,000港元，較截至二零二三年三月三十一日止的上一個財政年度（「上一個財政年度」）的虧損有所增加，其營業額增長7%至約137,000,000港元。經營虧損上升約17%至約29,000,000港元。

本集團於不同地區市場的業務於本年度表現參差。香港業務的收益增長18%至約84,000,000港元；來自澳門業務的收益則因受店舖遷址的影響而下跌26%至約11,000,000港元；於中國內地，消費者信心尚未完全恢復，以及當地貨幣人民幣兌港元走弱，導致本集團中國內地業務的收益輕微減少至約31,000,000港元；於台灣，本集團將店舖搬遷至更合適的地點，以及加強當地業務的管理，其於當地的收益上升14%至約11,000,000港元。

本集團於香港的業務佔其收益約61%，而於中國內地的業務則佔約23%；澳門及台灣的業務分別各佔其收益約8%。毛利率於本年度為81%，而於上一個財政年度則為73%。

### RESULTS

Moiselle mainly engages in retailing women's fashion apparel to high-end and upper-middle markets. To adapt to the changes in the market, it has also been gearing itself more towards the design and sale of on-trend apparel targeted at the younger generation of customers while catering to the preferences of the middle-aged customers. For the Year, Moiselle still recorded a loss because the retail markets of Hong Kong and Mainland China for high-end apparel had yet to fully recover to the pre-pandemic levels. In Hong Kong, where the Group derived about 61% of its total sales revenues, the apparel retail market was improving gradually but the Mainland Chinese tourists had lower buying power than they used to have before the pandemic outbreak.

For the year, the Group recorded a loss of approximately HK\$49 million, with increase in loss as compared with that in the previous financial year ended 31 March 2023 (the "Previous Financial Year"), and its turnover increased by 7% to approximately HK\$137 million. Operating loss increased by about 17% to approximately HK\$29 million.

The Group's operations in various geographical markets had uneven performances for the Year. Its operations in Hong Kong recorded an 18% increase in revenue to approximately HK\$84 million; its revenue from Macau dropped by 26% to approximately HK\$11 million as its business there was affected by the relocation of its stores; revenue from its operations in Mainland China decreased slightly to approximately HK\$31 million because consumer confidence had yet to fully recover and the weaker local currency renminbi against the Hong Kong dollar resulted in a slight decrease in revenue; the Group's revenue from Taiwan rose by 14% to approximately HK\$11 million due to relocation of stores to more suitable spots and the operations' strengthened management there.

The Group's operations in Hong Kong accounted for about 61% of its revenue while those in Mainland China contributed to about 23%; operations in Macau and Taiwan made up about 8% each. Gross profit margin was 81% for the Year, compared with the 73% for the Previous Financial Year.



### 業務回顧

為應對時尚服飾市場的根本變化和複雜波動的經營環境，本集團已重新定位其主要自家品牌 *MOISELLE*，以迎合年輕一代客戶的喜好和消費模式，積極推進電子商務的發展，透過社交媒體、手機應用程式及與網上購物平台營運商聯盟，並執行將店舖網絡維持於小而精佈局之策略，繼續其於過去五年梳理零售網絡的工作。

客戶群中，年輕一代消費者日益成為主導力量，他們較喜歡設計簡約的中檔、流行時尚服裝，而不是華麗設計的經典服飾。同時，越來越多富有青春活力、更長壽的中年人也喜愛時尚服飾。因此本集團自二零二零年起透過兩條服裝產品線將其主要自家品牌 *MOISELLE* 重新塑造為突顯亞洲女性線條美的品牌，其一為經典優雅的時尚服飾，另一則為展現年輕形象的時尚潮流和別樹一格的服飾。於截至二零二一年三月三十一日止的財政年度，本集團為其季節性時裝系列創作了一個營銷主題以豐富其重新定位的概念，旨在彰顯個性和自我覺醒，以標語「我就是慕詩」做推廣。

### BUSINESS REVIEW

To cope with the fundamental changes in the fashion apparel market and the complicated, volatile business environment, the Group has repositioned its major house brand *MOISELLE* to cater for the preferences and consumption patterns of a younger generation of customers, sped up the development of its electronic commerce business as a more cost-effective means of sales and marketing with the help of social media, mobile application and alliances with online shopping platform operators, and pursued the strategy of running its store network at an optimal minimum as part of its rationalization drive in the past five years.

In the customer base, there has been a growing trend of a predominance of the younger generation of consumers, who prefer mid-range, on-trend fashion apparel of simpler design to the classic one of elaborate design. Meanwhile, there is a growing number of youthful, energetic middle-aged people with longer life expectancy who also like trendy wear. The Group, therefore, has repositioned its major house brand *MOISELLE* as a brand that accentuates the beauty of Asian women's silhouette through two fashion lines, namely the classic and elegant fashion apparel on the one hand and the on-trend, unique fashion apparel that projects a youthful image on the other hand since 2020. It also enriched the concept of its repositioning by inventing a theme for marketing its seasonal collection which was about manifesting the wearers' personalities and self-awakening in the financial year ended 31 March 2021. The concept is summed up in a slogan "C'est MOI, MOISELLE" ("我就是慕詩" in Chinese).

為迎合年輕一代的喜好，本集團已將中檔、流行和別樹一格的時尚服裝在其庫存單位（「SKU」）總數中的比例由截至二零二零年三月三十一日止財政年度的約30%增加至自截至二零二一年三月三十一日止財政年度以來約50%此一最理想水平。於二零二三年十一月及十二月，本集團推出以「M27」為主題的MOISELLE二零二四年特設度假服裝系列，共有逾50個庫存單位的產品，為本集團於二零二四年成立27週年誌慶。該產品系列包括高檔服飾、貼身剪裁背心、外套及牛仔褲，其圖案花樣靈感來自明代的鳳冠及青花瓷。整體而言，本集團增加產品類別和擴大價格範圍，更好地滿足客戶更多樣化的要求和需求。

本集團亦再加強營銷工作，在廣東省深圳市及雲南省昆明市分別舉辦了三場及一場時裝表演，展示其最新的豪華時尚服裝，例如連衣裙及外套等。本集團藉着此等時裝表演，不但可以向其客戶俱樂部的VIP會員推銷產品，還可以讓高端購物商場的潛在業主更了解MOISELLE的定位，從而能選擇合適的舖址，更精準地掌握目標客戶。

電子商務日益普及，而人們也越來越依靠互聯網獲取關於時裝潮流的信息，因此，本集團繼續經營電子商務業務，在此趨勢中把握機遇。本集團可利用其電子商務業務促進銷售、展開市場推廣活動、收集顧客意見，以及增進客戶關係。於截至二零二一年三月三十一日及二零二二年三月三十一日止兩個財政年度，本集團已開設了兩個網上平台，分別為其香港業務營銷及銷售MOISELLE產品，及為其香港概念店M CONCEPT零售該品牌旗下m.d.m.s.、

Gearing its products more towards the younger generation of customers, the Group has increased the portion of mid-range, on-trend and unique fashion apparel from about 30% of the total number of stock keeping units (“SKU”) in the financial year ended 31 March 2020 to the optimal level of about 50% since the financial year ended 31 March 2021. In November and December 2023, the Group launched the MOISELLE brand's special resort 2024 collection under the theme “M27” in more than 50 SKUs to celebrate its 27th anniversary in year 2024. The collection consisted of high-end, slim-fit vests, jackets and jeans that featured patterns inspired by the phoenix coronet and blue-and-white porcelain of the Ming dynasty. Overall, it broadened both the product range and price range to better meet the more varied wants and needs of the customers.

It also stepped up its marketing effort by holding three fashion shows in Shenzhen, Guangdong province and one in Kunming, Yunnan province. The Group's latest deluxe fashion apparel such as dresses and jackets were featured at the events. The fashion shows not only served as a means of marketing products to the VIP members of the Group's customer club but also let prospective landlords of high-end shopping malls to have a better understanding of MOISELLE's positioning. This would enable the Group to choose locations for its stores where it could zero in on target customers with a higher degree of precision.

The Group is running an electronic commerce business to capitalize on the growing trend of electronic commerce and people's increasing use of internet for obtaining information about fashion trends. That business serves as a means of boosting sales, conducting marketing campaigns, collecting customer feedback and fostering customer relationships. The Group had opened two online platforms respectively for the marketing and sales of the MOISELLE products for its Hong Kong operations and for the retailing of its diffusion lines under such

GERMAIN等副線品牌及LANCASTER之產品。於本年度，本集團亦繼續與一家專門從事限時減價促銷的網上購物網站營運商OnTheList短期合作，以促進銷售。於中國內地，本集團於二零二三年四月與多一家中國領先電子商務公司京東集團建立聯盟，以推廣及銷售其產品。多年來，本集團已於中國內地透過其分別與雲歡商城、唯品會所經營專門進行網上折扣銷售的VIP.com以及天貓此三家當地電子商務營運商所組成的聯盟，發展其電子商務業務。該等網上銷售及營銷平台可與本集團之手機應用程式結合，以建立客戶群及執行精準營銷。

為加強其於各地域市場業務的影響力，本集團持續梳理其於當地的零售網絡，維持小而精的佈局。於中國內地，基本上只於其有業務經營的各中國內地城市保留一家店舖，並短租舖位，從而更靈活地調整店舖網絡規模。於香港，本集團則執行另一策略，就是在具生意前景且租金合理的黃金地段擴張其零售網絡。本集團致力於將其在香港的零售店舖做精做強，提升其業績。本集團亦將環保意識、生活品味及藝術等元素融入店舖的室內設計，以提升購物體驗。此外，本集團於店舖舉辦小型手工藝課程，作為銷售及推廣工作的一個環節，以吸引更多年輕一代的新客戶購買其時尚潮流及高檔時裝。

brands as *m.d.m.s.*, GERMAIN and LANCASTER for its Hong Kong-based concept store, *M CONZEPT*, in the two financial years ended 31 March 2021 and 31 March 2022. It also continued to conduct short-term cooperation with an online shopping website operator, OnTheList, which specializes in flash sales to boost sales during the Year. In Mainland China, the Group formed an alliance with one more leading Chinese e-commerce company, JD.com, Inc. (“京東集團” in Chinese) in April 2023 to market and sell its products. Over the years, the Group has been developing its electronic commerce business in the country through its separate alliances with three local electronic commerce website operators, namely CloudHappy Mall (“雲歡商城” in Chinese), VIP.com which specializes in online discount sales and is operated by Vipshop (“唯品會” in Chinese) and Tmall. Such online platforms for sales and marketing can be combined with the Group's mobile phone-enabled application to build up a customer base and carry out precision marketing.

To strengthen its business presence in its various geographical markets, the Group kept on rationalizing its retail networks there and maintaining them to an optimal minimum. In Mainland China, it basically maintained one store in each of the Mainland Chinese cities where it operated, and rented shop spaces on short leases which offered the Group more flexibility in adjusting the scale of its store network. In Hong Kong, the Group pursued the strategy of expanding its retail network at prime locations with good prospect at reasonable rents. It aimed to build up its stores in the city by improving their performance. It also enhanced the shopping experience at its stores by incorporating such elements as environmental awareness, quality lifestyle and art into the interior decoration. As part of its sales and marketing efforts, the Group conducted small-scale handicraft courses at its stores with the aim of attracting more new customers of a younger generation to both its on-trend and high-end fashion apparel.

### 展望

本集團業務所在的服裝零售市場歷經了逾三年的嚴峻經營環境後，可能需要超過兩年才能完全復甦。

生意前景雖然仍因疫後復甦速度較預期緩慢、地緣政治局勢緊張、人民幣疲弱、高通脹及高利率等因素而不明朗，但已漸趨穩定。

中國內地及香港政府均已採取了一系列刺激經濟及內需的措施，其中，香港「個人遊」計劃增添了八個主要位處華北及華西的城市，雖然該項新措施對振興香港零售市道的成效尚有待觀察，但也不失為正面的發展。

考慮到上述諸因素和趨勢，本集團將繼續以審慎態度發展業務，並且著力拓寬收入來源，務求能在預期將會全面復甦的服裝零售市場把握機遇。

業務能否好轉，取決於收益增長，因此，本集團將執行以下措施。

為要加強在香港及中國內地的影響力，本集團將於有前景且租金合理的黃金地段開設新店，選擇合適的舖址，從而更精準地掌握目標客戶。

### OUTLOOK

Having undergone the harsh business environment for more than three years, the apparel retail markets in which the Group is operating may need to take more than two years to fully recover.

The business outlook has somehow stabilized even though it is still clouded by a slower than expected post-pandemic recovery, geopolitical tensions, the weaker renminbi, high inflation and high interest rates.

The governments of both Mainland China and Hong Kong have adopted a series of measures to stimulate the economy and domestic consumption. Specifically, eight more Mainland Chinese cities, mainly from the northern and western regions of the country, have been added to the solo traveller scheme in Hong Kong. Although the new measure has yet to prove its effectiveness in reviving Hong Kong's retail market, it is still a positive development.

It is against this backdrop that the Group will maintain its prudent approach to business development while seeking to broaden its income stream with a view to capitalizing on an anticipated full recovery in the apparel retail market in the future.

A turnaround in business hinges on growth in revenue. The Group, therefore, will forge ahead with the following initiatives.

To bolster its business presence in Hong Kong and Mainland China, the Group will open new shops at prime locations with good prospect at reasonable rents. It will choose locations for its stores where it could zero in on target customers with a higher degree of precision.

本集團將鞏固其電子商務業務，以促進銷售、展開市場推廣活動、收集顧客意見，以及增進客戶關係。網上購物平台亦有助吸引更多顧客光顧實體店。本集團亦將與更多國內網購平台營運商結成聯盟，以拓展其在當地的電子商務業務。

為擴闊收入來源，本集團將進一步開拓加拿大的時裝批發市場，向溫哥華一家分銷商銷售產品。

本集團亦將加強對員工的培訓，令他們了解其產品的特點及設計理念，以配合其發展步伐。

上述諸措施均旨在令本集團更具競爭力及更能適應市場變化。本集團將密切留意經濟狀況及時裝潮流，以適時調整上述計劃。

### Management Discussion and Analysis

#### 經營概覽

本集團專攻豪華及中檔服飾市場，經營自家品牌如 *MOISELLE*、*m.d.m.s.* 及 *GERMAIN*，亦分銷國際品牌 *LANCASTER* 的產品。本集團旗下各個品牌均擁有特定客戶群，自家品牌設有獨立及優秀的設計團隊，並且於黃金地段的店舖銷售不同品牌的產品。本集團於香港、中國內地一線及二線城市、澳門及台灣的零售店舖及專櫃數目於二零二四年三月三十一日為32間，與二零二三年三月三十一日的數目相同。本集團關閉一些表現欠佳的店舖，但也於一些具生意前景的地段開設店舖，以梳理其零售店舖網絡。

#### 按地區劃分之業務回顧

##### 香港業務

本集團在香港業務的收益於本年度增長18%至83,913,000港元。該增長可歸因於中港全面重新通關以及於二零二三年四月一日所有入境旅客的檢疫隔離措施被廢除之後訪港旅客數目的反彈。然而，二零二三年的訪港旅客人數僅為二零一九年疫情爆發前水平約六成。

由於人民幣疲弱，以及生意和就業前景黯淡，中國內地訪港遊客無論在人數、購買力及平均客單價方面均較二零一九年疫情前有所下降；此外，他們現時更偏好於觀光而非購物。另一問題是香港居民北上跨境前往中國內地休閒消費已蔚然成風，影響了香港本地零售及餐飲市場。因此，本集團於香港的業務尚未完全恢復。

#### OVERVIEW OF OPERATIONS

Targeting the markets for luxurious and mid-range apparel, the Group operates such house brands as *MOISELLE*, *m.d.m.s.* and *GERMAIN*, while engaging in distributorship for international brand *LANCASTER*. Each of the brands has its own distinctive consumer base and is being developed separately by the Group's dedicated and talented designer teams for house brands. The Group retails its products under the various brands at stores in prime locations. As at 31 March 2024, the Group had 32 stores and counters in Hong Kong, first- and second-tier cities of Mainland China, Macau and Taiwan, the same as its number of stores as at 31 March 2023. It closed some underperforming stores but also opened some stores in places with good prospect to rationalize its network of stores.

#### REVIEW OF OPERATIONS BY LOCATION

##### Operations in Hong Kong

The Group's operations in Hong Kong recorded an 18% increase in revenue to HK\$83,913,000 for the Year. The growth could be attributed to a rebound in visitor arrivals in the city after the full reopening of its border with Mainland China and the abolition of all quarantine measures for inbound travellers on 1 April 2023. However, the number of visitor arrivals in Hong Kong in 2023 was only about 60% of the pre-pandemic level in 2019.

Compared with the pre-pandemic levels in 2019, there were still decreases in the number of the Mainland Chinese tourists in Hong Kong and in terms of their buying power and the average transaction size due to the weaker renminbi and the bleaker business outlook and employment prospect. Moreover, their interest also shifted more to sightseeing from shopping. Another problem was the growing trend of Hong Kong residents' northbound cross-border travel to Mainland China for relaxation and consumption, which affected the city's local retail and catering markets. As a result, the Group's business in Hong Kong had yet to fully recover.

同時，即使疫情後的復甦尚未達到預期，但成本上漲的壓力已正在上升。黃金地段的舖位，尤其是高端購物商場，其租金正逐漸上漲。採購成本亦有所上升。

為應對該等問題，本集團已正在梳理店舖網絡，並積極發展其電子商務業務，從而促進銷售及進行營銷活動。本集團亦於本年度嘗試開拓加拿大的時裝批發市場，以期擴大收入來源，已於二零二三年十一月開始向位於溫哥華的一家分銷商供貨。

為鞏固其在香港的業務並把握未來本地服裝零售市場預期全面復甦的機遇，本集團一直在審慎尋找具有生意前景且租金合理的舖位。本集團亦於其店舖網絡執行小而精佈局的策略，繼續主要在位於黃金地段的高檔購物商場維持其店舖網絡。於本年度，本集團於二零二三年五月在中環新顯利大廈開設MOISELLE店舖；早於二零二二年十二月則在旺角新世紀廣場的MOKO商場開設國際品牌LANCASTER店舖。本集團繼續致力於將其在香港的零售店舖做精做強，提升其業績。此外，本集團於店舖舉辦小型手工藝課程，作為銷售及推廣工作的一個環節，以吸引更多年輕一代的新客戶購買其時尚潮流及高檔時裝。為能把握北上國內消費香港居民的需求，本集團亦於香港消費者經常光顧的中國內地城市的門店加強針對香港消費者的營銷活動。

Meanwhile, pressure of rising costs set in even after the post-pandemic recovery fell short of expectations. Rents of shop spaces at prime locations, especially the high-end shopping malls, increased gradually. Cost of procurement also rose.

To cope with such problems, the Group has been rationalizing its store network and actively developing its electronic commerce business for the purposes of boosting sales and conducting marketing campaigns. It also tried to broaden its income stream by developing the fashion apparel wholesale market in Canada during the Year. It started supplying goods to a distributor in Vancouver in November 2023.

To strengthen its business presence in Hong Kong and to capitalize on an anticipated full recovery in the local apparel retail market in the future, the Group had been prudently seeking for shop spaces with good prospect at reasonable rents. Meanwhile, it kept its store network to an optimal minimum by maintaining its presence mainly at high-end shopping malls in prime locations. During the Year, the Group opened a MOISELLE store in New Henry House in Central in May 2023. It had earlier opened a store for an international brand LANCASTER at a shopping mall called MOKO at a multicomplex named Grand Century Place in Mong Kok in December 2022. The Group continued to build up its stores in the city by improving their performance. As part of its sales and marketing efforts, the Group conducted small-scale handicraft courses at its stores with the aim of attracting more new customers of a younger generation to both its on-trend and high-end fashion apparel. To tap the demand of Hong Kong residents on their northbound travel to Mainland China, the Group also stepped up its marketing campaigns targeted at the Hong Kong consumers at its stores in some Mainland Chinese cities that they frequented.

本集團繼續發展其電子商務業務此一具有成本效益的銷售及營銷方式，於截至二零二一年三月三十一日及二零二二年三月三十一日止兩個財政年度開設了兩個網上平台，分別為其香港業務營銷及銷售MOISELLE產品，及為其香港概念店M CONZEPT零售該品牌旗下m.d.m.s.、GERMAIN等副線品牌及LANCASTER之產品。此外，於本年度，本集團亦繼續與專門從事限時減價促銷的一間網上購物網站營運商OnTheList進行短期合作，以促進銷售。本集團不僅可利用其網上購物平台銷售專為網上銷售而設計之產品，以及按折扣價銷售過季產品，還可通過該等網上購物平臺主動開展促銷活動並經營客戶關係，即透過手機通知客戶俱樂部會員關於其最新產品及促銷活動的信息。

截至二零二四年三月三十一日，本集團經營6間MOISELLE、2間m.d.m.s.、2間LANCASTER和2間M CONZEPT零售店舖，以及1間特賣場（截至二零二三年三月三十一日：本集團經營7間MOISELLE、2間m.d.m.s.、2間LANCASTER和2間M CONZEPT零售店舖，以及1間特賣場）。

#### 中國內地業務

本集團在中國內地業務的收益於本年度輕微減少至31,160,000港元，這是因為生意和就業前景黯淡，令消費者變得審慎。中國政府仍致力重振經濟，尤其是正在應對房地產行業危機。在中美關係緊張的情況下，中國亦需要減息來刺激經濟和促進貿易，因而令人民幣兌美元走弱，並導致本集團在國內業務的收入略微下降。

The Group continued to develop its electronic commerce business as a more cost-effective means of sales and marketing. It had already opened two online platforms respectively for the marketing and sales of the MOISELLE products for its Hong Kong operations and for the retailing of its diffusion lines under such brands as m.d.m.s., GERMAIN and LANCASTER for its Hong Kong-based concept store, M CONZEPT, in the two financial years ended 31 March 2021 and 31 March 2022. Moreover, it also continued to conduct short-term cooperation with an online shopping website operator, OnTheList, which specializes in flash sales to boost sales during the Year. The online shopping platforms not only allowed the Group to sell out-of-season products at discounts as well as the products specifically designed for online sales, but also enabled it to proactively conduct promotional campaigns and to maintain customer relationships, namely by notifying its customer club members of its latest offerings and promotional activities through their mobile phones.

As at 31 March 2024, the Group operated 6 MOISELLE, 2 m.d.m.s., 2 LANCASTER and 2 M CONZEPT retail stores as well as one outlet in the city (As at 31 March 2023, the Group operated 7 MOISELLE, 2 m.d.m.s., 2 LANCASTER and 2 M CONZEPT retail stores as well as one outlet).

#### Operations in Mainland China

Revenue from the Group's operations in Mainland China slightly decreased to HK\$31,160,000 during the Year. It was because consumers remained cautious in view of the bleaker business outlook and employment prospect. The Chinese government was still endeavouring to revive the economy and, specifically, to cope with the ongoing crisis in the property sector. It also needed to cut interest rates to stimulate the economy and boost trade amid the strained Sino-United States relations. This resulted in a weaker renminbi against the United States dollar and led to a slight decrease in revenue at the Group's operations in the country.

國內服裝零售市場競爭激烈，領先的服裝品牌競相要在各城市的一流購物商場中租賃黃金鋪位；此外，購物商場的業主於今年重新引入了商舖租賃安排，除了收取固定租金外，同時要求在某一水平以上的額外銷售收入中按若干百分比抽成，導致租金上漲。

為應對國內複雜波動的經營環境，本集團執行將店舖網絡維持於小而精佈局之策略，基本上只於其有業務經營的各中國內地城市保留一間店舖，並繼續梳理其於國內的零售網絡。於本年度上半年，本集團於浙江省溫州市開設一間店舖，並在廣州一家百貨公司開設一個專櫃，但也在安徽省合肥市關閉了一間店舖。於本年度下半年，本集團於雲南省昆明市開設一間店舖，並於江蘇省南京市一所高端購物商場開設一間店舖。

為要建設更能迎合消費者需求的店舖網絡，本集團透過社交媒體及其網上購物平台收集消費者的反應，以及邀請商場物業管理團隊參加其時裝表演，從而收集其對本集團產品的意見。本集團能從該等調查更清楚了解國內各個地區消費者的偏好。本集團亦到具潛力的鋪位實地考察，從而能選擇合適的鋪址，更精準地掌握目標客戶。

The apparel retail market was highly competitive and leading brands vied for prime locations at the top-ranking shopping malls in cities. This year, landlords at the shopping malls re-introduced a rental arrangement under which fixed rents and certain percentages of the surplus revenue from sales were charged. All these resulted in higher rents.

To cope with the volatile and complicated business environment in the country, the Group pursued the strategy of keeping its store network to an optimal minimum by basically maintaining one store in each of the Mainland Chinese cities where it operates. It also continued to rationalize its retail network in the country. During the first half of the Year, the Group opened one store in Wenzhou, Zhejiang province and one counter at a department store in Guangzhou, but closed one store in Hefei, Anhui province. In the second half of the Year, the Group opened one store in Kunming, Yunnan province, and one store in a high-end shopping mall in Nanjing, Jiangsu province.

To develop a store network that can better tap the consumer demand, the Group collected feedback from consumers through social media and its own online shopping platforms and opinions from property management teams of shopping malls whom it invited to its own fashion shows regarding its products. The surveys afforded the Group a better understanding of consumer preferences in various regions of the country. The Group also conducted on-site visits to prospective shop spaces. It would then be able to choose locations for its stores where it could zero in on target customers with a higher degree of precision.

本集團也繼續執行營銷工作，分別於二零二三年十月、二零二四年三月及五月在廣東省深圳市舉辦了三場時裝表演，並在雲南省昆明市舉辦一場時裝表演，展示其最新的豪華及重點時裝。本集團邀請了其客戶俱樂部的VIP會員以及來自一些主要城市的高端購物商場的物業管理團隊參加其舉辦的時裝表演，從而向目標客戶推銷產品，並讓潛在業主更了解MOISELLE的定位。

為要在中國內地電子商務的發展趨勢中進一步把握機遇，本集團於二零二三年四月與多一家中國領先電子商務公司京東集團建立聯盟，以推廣及銷售其產品。於過去數年，本集團已與三家網上購物網站營運商，包括雲歡商城、唯品會及天貓分別結成聯盟。

截至二零二四年三月三十一日，本集團於國內經營12間MOISELLE零售店舖（截至二零二三年三月三十一日：11間MOISELLE零售店舖）。

### 澳門業務

本集團位於澳門酒店及博彩度假村澳門威尼斯人的MOISELLE店舖遷址，影響了其於當地的業務，其營業額於本年度下跌26%至11,463,000港元。到訪澳門的旅客數目巨大，當中來自中國內地的游客更佔大多數，本集團預期此發展趨勢將能刺激其在當地的生意增長。截至二零二四年三月三十一日，本集團於澳門經營三間店舖，即位於澳門威尼斯人的一間MOISELLE及一間LANCASTER零售店舖，以及位於澳門巴黎人酒店的一間MOISELLE零售店舖（截至二零二三年三月三十一日：一間MOISELLE及一間LANCASTER零售店舖）。

As part of its marketing efforts, the Group held three fashion shows in Shenzhen, Guangdong province in October 2023, March and May 2024 respectively and one fashion show in Kunming, Yunnan province to feature its latest deluxe and key fashion apparel. VIP members of the Group's customer club and property management teams of high-end shopping malls from some major cities were invited to the fashion shows. This allowed the Group to market its products to target customers and to let prospective landlords have a better understanding of MOISELLE's positioning.

To further capitalize on the growing trend of electronic commerce in Mainland China, the Group formed an alliance with one more leading Chinese e-commerce company, JD.com, Inc. in April 2023 to market and sell its products. In the past several years, the Group had already formed separate alliances with three online shopping website operators, including CloudHappy Mall, Vipshop and Tmall.

As at 31 March 2024, the Group operated 12 MOISELLE retail stores in the country (As at 31 March 2023: 11 MOISELLE retail stores).

### Operations in Macau

For the Year, turnover at the Group's operations in Macau dropped by 26% to HK\$11,463,000 because its business was affected by the relocation of its MOISELLE store at The Venetian Macao, a hotel and casino resort in the city. The Group expects the business of its operations there to be buoyed up by a large number of inbound tourists in the city, especially those from Mainland China, in the future. As at 31 March 2024, the Group operated three shops in the city, namely one MOISELLE and one LANCASTER retail stores at The Venetian Macao, and one MOISELLE retail store at The Parisian Macao (As at 31 March 2023: one MOISELLE and one LANCASTER retail stores).

### 台灣業務

本集團台灣業務的收益上升14%至約10,775,000港元，佔本集團本年度營業額約8%。店舖搬遷至更合適的地點，以及當地業務的管理有所加強，促進了收益增長。截至二零二四年三月三十一日，本集團於當地經營三間MOISELLE和一間LANCASTER零售店舖（截至二零二三年三月三十一日：三間MOISELLE和一間LANCASTER零售店舖，以及1間特賣場）。

### 財務回顧

#### 概覽

截至二零二四年三月三十一日止年度，本集團之營業額較二零二三年增加約7%至約137,311,000港元（二零二三年：127,946,000港元）。香港分部所賺取之收益增加約18%至約83,913,000港元（二零二三年：70,846,000港元）。政府措施的放寬後各銷售點人流改善，令分部收益增加。該分部佔本集團總收益61%（二零二三年：55%）。

截至二零二四年三月三十一日止年度，香港境外分部之收益減少約6%，至約53,398,000港元（二零二三年：57,100,000港元），主要由於澳門零售店舖遷址令業績惡化所致。因此該分部貢獻率減少至39%（二零二三年：45%）。

### Operations in Taiwan

Revenue from the Group's operations in Taiwan rose by 14% to approximately HK\$10,775,000, which accounted for about 8% of the Group's turnover for the Year. The growth was due to relocation of stores to more suitable spots and the operations' strengthened management there. The Group operated 3 MOISELLE and one LANCASTER retail stores there as at 31 March 2024 (As at 31 March 2023: 3 MOISELLE and one LANCASTER retail stores as well as one outlet).

### FINANCIAL REVIEW

#### Overview

The Group's turnover increased by approximately 7% to approximately HK\$137,311,000 (2023: HK\$127,946,000) during the year ended 31 March 2024 as compared with 2023. The revenue earned from Hong Kong segment increased by approximately 18% to approximately HK\$83,913,000 (2023: HK\$70,846,000). The relaxation of government measures had contributed to increase of revenue of the segment under improved traffic of customers at all points of sales. The segment contributed to 61% (2023: 55%) of the Group's total revenue.

The revenue of the segment outside Hong Kong decreased by approximately 6% to approximately HK\$53,398,000 (2023: HK\$57,100,000) during the year ended 31 March 2024 mainly due to deteriorated performance in Macau under switch of locations of retail stores. The segment contribution decreased to 39% (2023: 45%) as a result.

於本年度，本集團之毛利率約為80.5%，而去年則為72.9%。毛利率大幅改善反映本財政年度對折扣銷售業務的依賴程度下降，促銷活動減少。截至二零二四年三月三十一日止年度，經營開支合共約為141,421,000港元，而二零二三年則約為132,781,000港元，增加約7%。儘管管理層已進行多項嚴謹成本管理措施以應付高企之經營開支（主要為員工薪酬及租金開支），本集團仍錄得經營虧損29,286,000港元（二零二三年：24,980,000港元）。

截至二零二四年三月三十一日止年度，權益股東應佔虧損約為48,100,000港元（二零二三年：42,857,000港元），錄得增加與經營虧損增加相符，亦受累於融資成本顯著增大。

### 流動資金及財務資源

截至二零二四年三月三十一日止年度，本集團以內部賺取之流動現金及銀行借貸應付其業務資金所需。本集團採取審慎之財務政策，以備於債務到期時可履行財務責任和保持足夠之營運資金作為本集團業務發展之用。於財政年度末，本集團之銀行存款及現金結存合共約為24,000,000港元（二零二三年：14,000,000港元）。本集團持有的現金及銀行存款主要為港元及人民幣。本集團之海外業務及若干資產淨值須承受外幣匯率波動之風險。管理層定期監控集團之外幣匯率風險，並於需要時可能考慮對沖。

During the year, the Group's gross profit margin was approximately 80.5%, as compared to 72.9% of the previous year. Significant improvement in gross profit margin reflected decreased reliance on businesses from discounted sales and fewer promotion activities during the financial year. Operating expenses for the year ended 31 March 2024 totalled approximately HK\$141,421,000, compared to approximately HK\$132,781,000 for 2023, increased by approximately 7%. Although the management had continued to conduct various measures in stringent cost management to counteract high operating expenses, mainly staff costs and rental expenses, the Group suffered an operating loss of HK\$29,286,000 (2023: HK\$24,980,000).

The loss attributable to the equity shareholders for the year ended 31 March 2024 was approximately HK\$48,100,000 (2023: HK\$42,857,000), increased in line with the increase in operating loss with impact from the significant increase in finance costs.

### Liquidity and financial resources

During the year ended 31 March 2024, the Group financed its operations with internally generated cash flows and bank borrowings. The Group adopts a prudent financial policy such that it can meet the financial obligations when they fall due and maintain a sufficient operating fund for the development of the Group's business. At the end of the financial year, the Group's aggregate fixed deposits and cash balances amounted to approximately HK\$24 million (2023: HK\$14 million). Cash and bank deposits were held mainly in Hong Kong dollars and Renminbi. The Group has foreign operations and certain of its net assets are exposed to the risk of foreign currency exchange rate fluctuations. The management regularly monitors the foreign currency exchange risk of the Group and may consider hedging activities when necessary.

於二零二四年三月三十一日，本集團獲多家商業銀行授出綜合銀行融資合共約73,000,000港元（二零二三年：73,000,000港元）。於二零二四年三月三十一日，在整體銀行融資中，本集團在營運附屬公司層面取得銀行借貸51,000,000港元（二零二三年：37,000,000港元），為其提供營運資金。於二零二四年三月三十一日，本集團亦受惠於動用銀行融資6,000,000港元（二零二三年：4,000,000港元），例如銀行擔保。

於年末，本集團之流動負債淨額為24,000,000港元（二零二三年：19,000,000港元），而流動資產少於流動負債。於二零二四年三月三十一日，資本負債比率（銀行借貸及租賃負債總額除以股東權益）約為23.5%（二零二三年：14.2%）。

### 資產抵押

於二零二四年三月三十一日，賬面值約111,000,000港元（二零二三年三月三十一日：122,000,000港元）之持作自用土地及建築物以及投資物業已抵押作為本集團獲授銀行借貸的擔保。

As at 31 March 2024, the Group was granted aggregate composite banking facilities of approximately HK\$73 million (2023: HK\$73 million) by various commercial banks. Within the overall banking facilities, the Group secured bank borrowings of HK\$51 million (2023: 37 million) at operating subsidiary level financing its working capital as at 31 March 2024. The Group was also benefited from the utilisation of banking facilities HK\$6 million (2023: HK\$4 million) such as banking guarantee as at 31 March 2024.

The Group ran into net current liabilities of HK\$24 million as at the year end (2023: HK\$19 million), with current assets being less than current liabilities. As at 31 March 2024, the gearing ratio (aggregate of bank borrowings and lease liabilities divided by shareholders' equity) was approximately 23.5% (2023: 14.2%).

### Charge on assets

As at 31 March 2024, land and buildings held for own use and investment properties with a carrying value of approximately HK\$111 million (31 March 2023: HK\$122 million) were pledged to secure bank borrowings granted to the Group.

### 僱員

於二零二四年三月三十一日，本集團共聘用302名（二零二三年：285名）員工，主要在香港及中國內地。僱員薪酬維持具競爭力之水平，並酌情發放花紅。其他僱員福利包括強制性公積金、法定及醫療保險以及培訓課程。

### 保障持份者之權益、共襄公益及促進業務持續發展

本集團除了一直遵守其經營地點（包括香港、中國內地、台灣及澳門）之所有法例及法規外，亦致力保障其持份者（包括其股東、僱員及客戶）之權利及權益，乃至為社會福祉作出貢獻。

除了為股東爭取最大回報之業務目標外，本集團亦盡力履行其企業社會責任。例如，本集團在採購原材料、生產至零售的整個業務過程中，竭力保障環境及客戶免受有害物質影響。本集團亦採取措施確保其於深圳龍華之廠房遵守當地管制工業廢氣及廢水排放之環保法規。該廠房只縫製服裝，並無從事任何面料染色。

本集團堅信客戶享用優質安全產品之權利。為實現此目標，本集團與信譽良好的原材料供應商及加工廠維持良好的關係，並向深圳市計量質量檢測研究院交付每個產品型號的樣本做檢驗。此外，本集團亦要求所有業務夥伴、原材料供應商及生產商遵守有關產品安全之所有相關法例及監管之規定。

### EMPLOYEES

As at 31 March 2024, the Group employed 302 (2023: 285) employees mainly in Hong Kong and Mainland China. Salaries of employees are maintained at competitive levels while bonuses are granted on a discretionary basis. Other employee benefits include mandatory provident fund, statutory and medical insurance cover and training programmes.

### COMMITMENT TO STAKEHOLDERS' INTERESTS, SOCIETY'S WELL-BEING AND SUSTAINABLE DEVELOPMENT

The Group is committed to ensuring the rights and interests of its stakeholders (including its shareholders, employees and customers) and the well-being of society at large while complying with all the laws and regulations of the places where it has operations, including Hong Kong, Mainland China, Taiwan and Macau.

In addition to its business objective of maximizing returns to shareholders, the Group also tries its best to fulfil its corporate social responsibility. For instance, the Group ensures protection of both environment and consumers against hazardous substances throughout the process of conducting its business, from raw material procurement, production to retail. The Group also has taken measures to ensure that its factory in Longhua, Shenzhen, complies with the local environmental regulations on industrial emissions and effluents. The factory is only responsible for sewing and is not engaged in any dyeing of fabrics.

The Group believes in consumers' entitlement to quality and safe products. To attain this goal, the Group maintains well-established relationships with trustworthy raw material suppliers and processing factories, and delivers a sample of each model of its products to Shenzhen Academy of Metrology and Quality Inspection for inspection. Besides, the Group also requires all business partners, raw material suppliers and production vendors to fulfill all relevant legal and regulatory requirements on product safety.

#### 守則條文第F.2.2條

Code Provision F.2.2 of the CG Code provides that the chairman of the Board should attend the annual general meeting of the company. Due to other engagements external to the company, Mr. Chan Yum Kit was unable to attend the annual general meeting of the company held on 27 September 2023.

### RETIREMENT SCHEME

The group operates a Mandatory Provident Fund Scheme (the "MPF scheme") under the Hong Kong Mandatory Provident Fund Schemes Ordinance for employees employed under the jurisdiction of the Hong Kong Employment Ordinance. The MPF scheme is a defined contribution retirement scheme administered by independent trustees. Under the MPF scheme, the employer and its employees are each required to make contributions to the scheme at 5% of the employees' relevant income, subject to a cap of monthly relevant income of HK\$30,000.

As stipulated by the regulations of the People's Republic of China ("PRC"), the group participates in defined contribution retirement plans organised by the relevant authorities for its Mainland China employees. The group is required to make contributions to the retirement plans which are calculated based on certain prescribed rates on the salaries, bonuses and certain allowances of its Mainland China employees. The group has no other material obligation for the payment of pension benefits associated with such plans beyond the annual contributions described above.

Employees of the subsidiary carrying on business in Taiwan chose to participate in a defined contribution scheme governed by the Labour Pension Act of Taiwan. This subsidiary contributes at 6% of the total salaries of participating employees who have chosen to participate in the defined contribution scheme, deposited into individual pension accounts at the Bureau of Labour Insurance of Taiwan.

Employees of the subsidiary in Singapore participate in the Central Provident Fund scheme (the "CPF") organised by the government of Singapore. This subsidiary and its employees are required to contribute a certain percentage of the employees' payroll to the CPF. The contributions are charged to profit or loss as they become payable in accordance with the rules of the CPF. The subsidiary has no further obligations for the actual pension payments or post-retirement benefits beyond its contributions.

Contributions to the defined contribution scheme are charged to profit or loss when incurred.

On 31 August 2023, Boo Gie Garment Factory Limited ("Boo Gie Garment"), a wholly-owned subsidiary of the company, entered into a goods supply and purchase agreement (the "Agreement") with Nice Power Asia Limited ("Nice Power") to regulate the supply and sales of menswear and ladieswear by Boo Gie Garment to Nice Power from April 2023 to end of March 2026. The Agreement covered three years each containing the seasons of fall, winter, spring and summer from fall 2023 to summer 2026, with annual cap set at HK\$8,000,000, HK\$9,600,000 and HK\$9,600,000 for financial year ending 31 March 2024, 2025 and 2026 respectively. During the year, the total transaction amount under the Agreement was approximately HK\$1,490,000.

定價政策以固定單價設立，與一般商業慣例相同。貨品按訂約方根據供應予獨立客戶之類似規格及性質之貨品價格共同協定之條款按離岸價收取。離岸價根據每種款式之出廠價釐定，利潤率為15%至73%，取決於訂單數量。15%的基本利潤率作為採購精美的原材料及配件以及提供採購服務之收費。當訂單低於50件的最低訂購數量時，將分別收取額外的利潤率，訂購數量20至49件的附加費為15%，訂購數量1至19件的附加費為50%。最低訂購量可根據布料及其他輔助材料是否可得而波動，並由訂約方協定。

威佳由本集團擁有20%、本集團高級管理人員陳栢熹先生擁有40%及獨立第三方擁有40%。陳栢熹先生乃本公司主席及執行董事陳先生及本公司執行董事徐女士之子，及本公司執行董事陳思俊先生之弟。威佳被視為本公司之關連人士，而寶琪時裝及威佳根據貨品供應協議進行之交易構成本公司之持續關連交易。

The pricing policies are set at fixed unit price, the same as in normal commercial practices. The goods were charged at FOB prices with terms mutually agreed by both parties based on prices of goods of similar specifications and natures supplied to independent customers. The FOB prices are determined based on ex-factory prices for each style with profit margin of 15% to 73% depending on the order quantity. Basic profit margin of 15% is charged for sourcing of exquisite raw materials and accessories and merchandising services provided. Additional profit margin is charged when order is lower than minimum order quantity of 50 pieces, at surcharge of 15% for order quantity from 20 to 49 pieces and of 50% for order quantity from 1 to 19 pieces respectively. Minimum order quantity can otherwise fluctuate depending on availability of fabric and other accessory materials and will be agreed by both parties.

Nice Power is 20% owned by the group, 40% owned by Mr. Chan Pak Hei, a senior management of the group, and 40% owned by an independent third party. Mr. Chan Pak Hei is the son of Mr. Chan, chairman and executive director of the company and Ms. Tsui, an executive director of the company, and is the brother of Mr. Chan Sze Chun, an executive director of the company. Nice Power is considered to be a connected person of the company, and the transactions between Boo Gie Garment and Nice Power under the Agreement constitute continuing connected transactions of the company.

**1. 一般資料**

慕詩國際集團有限公司（「本公司」；及其附屬公司統稱「本集團」）乃一家根據開曼群島公司法第22章（1961年第三號法例，經綜合及修訂）於開曼群島註冊成立之獲豁免有限公司，其股份於香港聯合交易所有限公司主板上市。其最終控股公司為Super Result Consultants Limited（「Super Result」），該公司為一家於英屬處女群島註冊成立之有限公司。本公司主席兼執行董事陳欽杰先生（「陳先生」）及本公司執行董事徐巧嬌女士（「徐女士」）各自於Super Result持有46.7%股權。本公司之註冊辦事處及主要營業地點之地址已於本公司之年報中公司資料一節披露。

本公司為一家投資控股公司。本公司附屬公司之主要業務為設計、製造及零售時尚服飾及配飾。有關本公司主要附屬公司之詳情載於附註33。

綜合財務報表乃以港元呈列，亦為本公司之功能貨幣。

**1. GENERAL INFORMATION**

Moiselle International Holdings Limited (the “Company”; and its subsidiaries collectively referred to as the “Group”) is an exempted company incorporated in the Cayman Islands with limited liability under the Companies Law, Chapter 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands and its shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited. Its ultimate holding company is Super Result Consultants Limited (“Super Result”), a limited company incorporated in the British Virgin Islands. Mr. Chan Yum Kit (“Mr. Chan”), the chairman and executive director of the Company, and Ms. Tsui How Kiu, Shirley (“Ms. Tsui”), executive director of the Company, each holds 46.7% equity interest in Super Result. The addresses of the registered office and principal place of business of the Company are disclosed in the section of Corporate Information in the Company’s annual report.

The Company acts as an investment holding company. The principal activities of the Company’s subsidiaries are design, manufacture and retail of fashion apparel and accessories. Details of the principal subsidiaries of the Company are set out in note 33.

The consolidated financial statements are presented in Hong Kong dollars (“HK\$”), which is also the functional currency of the Company.

- (ii) the Group also, as at 1 April 2022, recognised a deferred tax asset (to the extent that it is probable that taxable profit will be available against which the deductible temporary difference can be utilised) and a deferred tax liability for all deductible and taxable temporary difference associated with right-of-use assets and lease liabilities.

The application of the amendments has had no material impact on the Group’s financial position and performance, except that the Group discloses the related deferred tax assets of HK\$3,277,000 and deferred tax liabilities of HK\$3,277,000 on a gross basis as at 1 April 2022 in note 22 but it had no impact on the accumulated losses as at the earliest period presented.

本集團已於本會計期間首次應用該等修訂本。香港會計準則第1號「呈列財務報表」經過修訂後，在所有情況下以「重大會計政策資料」一詞取代「主要會計政策」。倘連同實體財務報表內其他資料一併考慮，有關之會計政策資料在合理預期下可影響通用財務報表之主要使用者以該等財務報表為基礎所作之決定，則該會計政策資料屬重大。

該等修訂本亦澄清，即使涉及款項並不重大，但基於相關交易之性質、其他事項或情況，會計政策資料仍可能屬重大。然而，並非所有與重大交易、其他事項或情況有關之會計政策資料本身屬重大。倘實體選擇披露非重大會計政策資料，有關資料不得掩蓋重大會計政策資料。

香港財務報告準則實務報告第2號「作出重大性判斷」（「實務報告」）亦經過修訂，以說明實體如何將「評估重大性流程四步法」應用於會計政策披露並判斷會計政策資料對其財務報表是否屬重大。實務報告已增加指導意見及實例。

應用該等修訂本對本集團財務狀況或表現並無重大影響，但已影響綜合財務報表附註3所載之本集團會計政策之披露。

Impacts on application of Amendments to HKAS 1 and HKFRS Practice Statement 2 “Disclosure of Accounting Policies”

The Group has applied the amendments for the first time in the current accounting period. HKAS 1 “Presentation of Financial Statements” is amended to replace all instances of the term “significant accounting policies” with “material accounting policy information”. Accounting policy information is material if, when considered together with other information included in an entity’s financial statements, it can reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements.

The amendments also clarify that accounting policy information may be material because of the nature of the related transactions, other events or conditions, even if the amounts are immaterial. However, not all accounting policy information relating to material transactions, other events or conditions is itself material. If an entity chooses to disclose immaterial accounting policy information, such information must not obscure material accounting policy information.

HKFRS Practice Statement 2 “Making Materiality Judgements” (the “Practice Statement”) is also amended to illustrate how an entity applies the “four-step materiality process” to accounting policy disclosures and to judge whether information about an accounting policy is material to its financial statements. Guidance and examples are added to the Practice Statement.

The application of the amendments has had no material impact on the Group’s financial positions and performance but has affected the disclosure of the Group’s accounting policies set out in note 3 to the consolidated financial statements.

應用香港會計師公會就《香港廢除強制性公積金（「強積金」）與長期服務金（「長服金」）對沖機制的會計影響》發佈之指引

本集團有若干附屬公司於香港營運，根據特定情況有義務向僱員支付長服金。與此同時，本集團向受託人作出強制性之強積金供款，該受託人管理專為每名個別僱員退休權益而設之信託資產。僱主可根據僱傭條例（第57章）使用僱主之強積金供款所產生之僱員累算退休權益來對沖長服金。於二零二二年六月，香港特別行政區政府（「政府」）就香港《2022年僱傭及退休計劃法例（抵銷安排）（修訂）條例》（「修訂條例」）刊憲，其將於二零二五年五月一日（「轉制日期」）正式生效。一旦修訂條例生效，僱主不得再使用其強積金計劃之強制性供款所產生之任何累算權益來減少僱員自轉制日期起提供服務所涉及之長服金（即廢除「對沖機制」）。另外，於轉制日期前提供服務所涉及之長服金將按僱員緊接轉制日期前及截至該日期止之服務年期之月薪計算。

於二零二三年七月，香港會計師公會發佈《香港廢除強積金與長服金對沖機制的會計影響》，當中就對沖機制以及廢除該機制之會計處理提供指引。

*Application of the HKICPA guidance on the accounting implications of the abolition of the Mandatory Provident Fund (“MPF”) – Long Service Payment (“LSP”) offsetting mechanism in Hong Kong*

The Group has several subsidiaries operating in Hong Kong which are obliged to pay LSP to employees under certain circumstances. Meanwhile, the Group makes mandatory MPF contributions to the trustee who administers the assets held in a trust solely for the retirement benefits of each individual employee. Offsetting of LSP against an employee’s accrued retirement benefits derived from employers’ MPF contributions was allowed under the Employment Ordinance (Cap.57). In June 2022, the Hong Kong SAR Government (the “Government”) gazetted the Hong Kong Employment and Retirement Schemes Legislation (Offsetting Arrangement) (Amendment) Ordinance 2022 (the “Amendment Ordinance”), which will come into effect from 1 May 2025 (the “Transition Date”). Once the Amendment Ordinance takes effect, an employer can no longer use any of the accrued benefits derived from its mandatory contributions to MPF scheme to reduce LSP in respect of an employee’s service from the Transition Date (the abolition of the “offsetting mechanism”). In addition, the LSP in respect of the service before the Transition Date will be calculated based on the employee’s monthly salary immediately before the Transition Date and the years of service up to that date.

In July 2023, the HKICPA published “Accounting implications of the abolition of the MPF-LSP offsetting mechanism in Hong Kong” that provides accounting guidance relating to the offsetting mechanism and the abolition of the mechanism.

該指引特別指出，實體可將預期用於減少應付予僱員長服金之強積金強制性供款所產生之累算權益視為該僱員對長服金之供款而入賬。

就應用此做法而言，自二零二二年六月制定修訂條例起，不得再採用香港會計準則第19號「僱員福利」第93(b)段中之可行權宜方法，該可行權宜方法過往容許於作出供款時之期間將有關之視作供款確認為服務成本之扣減（負服務成本）；取而代之，該等視作供款應如同長服金權益總額歸屬於服務期內。

為了更能反映廢除對沖機制之實質內容，本集團已更改其與長服金負債相關之會計政策，並已採用上述香港會計師公會指引。隨著修訂條例之制定，停止應用香港會計準則第19號第93(b)段中之可行權宜方法導致於二零二二年六月對迄今產生之服務成本作出追加損益調整。由於追加損益調整金額並不重大，故本集團並無重列綜合財務報表之比較數字。

In particular, the guidance indicates that entities may account for the accrued benefits derived from mandatory MPF contributions that are expected to be used to reduce the LSP payable to an employee as deemed contributions by that employee towards the LSP.

Applying this approach, upon the enactment of the Amendment Ordinance in June 2022, it is no longer permissible to apply the practical expedient in paragraph 93(b) of HKAS 19 “Employee Benefits” that previously allowed such deemed contributions to be recognised as reduction of service cost (negative service cost) in the period the contributions were made; instead these deemed contributions should be attributed to periods of service in the same manner as the gross LSP benefit.

To better reflect the substance of the abolition of the offsetting mechanism, the Group has changed its accounting policy in connection with its LSP liability and has applied the above HKICPA guidance. The cessation of applying the practical expedient in paragraph 93(b) of HKAS 19 in conjunction with the enactment of the Amendment Ordinance resulted in a catch-up profit or loss adjustment in June 2022 for the service cost up to that date. Since the amount of the catch-up profit or loss adjustment was not material, the Group did not restate the comparative figures in the consolidated financial statements.

The 2022 Amendments also defer the effective date of applying the 2020 Amendments to annual reporting periods beginning on or after 1 January 2024. Based on the Group’s outstanding liabilities as at 31 March 2024, the application of the 2020 and 2022 Amendments will not result in reclassification of the Group’s liabilities.

綜合財務報表已按照香港會計師公會頒佈之香港財務報告準則所編制。就編制綜合財務報表之目的而言，當可合理預期該等資料會影響主要使用者之決策，該等資料則被視為屬重大。此外，綜合財務報表亦符合包括香港聯合交易所有限公司證券上市規則及香港公司條例所規定之適當披露事項。

在編制綜合財務報表時，鑑於本集團於二零二四年三月三十一日之流動負債超出其流動資產約24,456,000港元，董事已審慎考慮本集團之未來流動資金。

截至二零二四年三月三十一日止年度，本集團產生經營現金流量約6,390,000港元。於二零二四年三月三十一日，(i)本集團持有現金及現金等價物合共約23,558,000港元；(ii)約36,500,000港元為循環借貸；(iii)可動用之未動用銀行融資約為16,225,000港元；及(iv)賬面總值約為365,536,000港元之持作自用土地及建築物及投資物業為可供抵押。董事認為，彼等正通過展期及／或為現有銀行融資下之現有借貸進行再融資，積極及定期檢討本集團之債務結構，並將考慮於必要時利用未抵押資產獲得額外銀行融資。

### 3. BASIS OF PREPARATION OF CONSOLIDATED FINANCIAL STATEMENTS AND MATERIAL ACCOUNTING POLICY INFORMATION

#### 3.1 Basis of preparation of consolidated financial statements

The consolidated financial statements have been prepared in accordance with HKFRSs issued by the HKICPA. For the purpose of preparation of the consolidated financial statements, information is considered material if such information is reasonably expected to influence decisions made by primary users. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and by the Hong Kong Companies Ordinance.

In preparing the consolidated financial statements, the Directors have given careful consideration to the future liquidity of the Group in light of the fact that the Group's current liabilities exceeded its current assets by approximately HK\$24,456,000 as at 31 March 2024.

For the year ended 31 March 2024, the Group generated operating cash flows of approximately HK\$6,390,000. As at 31 March 2024, (i) total cash and cash equivalents of approximately HK\$23,558,000 were held by the Group, (ii) approximately HK\$36,500,000 of borrowings were revolving in nature, (iii) unutilised bank facilities amounted to approximately HK\$16,225,000 were available, and (iv) approximately HK\$365,536,000 aggregate carrying value of land and buildings held for own use and investment properties were available for pledge. The Directors are of the view that they are actively and regularly reviewing the Group's debt structure through roll-over and/or re-financing its existing borrowings under current bank facilities, and will consider make use of the unpledged assets to obtain additional banking facilities, when necessary.

根據上述因素及未來十二個月之現金流量預測考量，於批准綜合財務報表時，董事合理預期本集團有足夠資源於可見將來繼續營運。因此，本集團將繼續按持續經營基準編製綜合財務報表。

如下文之會計政策所載，除投資物業以及持作自用土地及建築物於各報告期末以公允值計量外，綜合財務報表乃按歷史成本法編制。

歷史成本一般以換取貨物及服務之公允值代價為根據。

公允值指於計量日市場參與者在進行有序交易中出售資產所收取或轉移負債所支付之價格，無論該價格是否為可直接觀察或使用其他估值方法估計。在估算一項資產或負債的公允值時，本集團考量資產或負債之特點，若於計量日市場參與者在釐定資產或負債價格時也考量該等特點。就該等綜合財務報表內計量及／或披露而言的公允值均根據該基準釐定，惟香港財務報告準則第2號「股份為基礎支付」範圍內之以股份為基礎支付之交易、根據香港財務報告準則第16號「租賃」列作租賃之交易、及與公允值存在某些相似之處之計量但並非公允值，例如香港會計準則第2號「存貨」之可變現淨值或香港會計準則第36號「資產減值」之使用價值除外。

Based on the aforesaid factors and consideration of the cash flow forecast for the coming twelve months, the Directors have, at the time of approving the consolidated financial statements, a reasonable expectation that the Group has adequate resources to continue in operational existence for the foreseeable future. Thus, the Group will continue to adopt a going concern basis of accounting when preparing the consolidated financial statements.

The consolidated financial statements have been prepared on the historical cost basis, except for the investment properties and land and buildings held for own use, which are measured at fair values at the end of each reporting period, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 "Share-based Payment", leasing transactions that are accounted for in accordance with HKFRS 16 "Leases", and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 "Inventories" or value in use in HKAS 36 "Impairment of Assets".

非金融資產的公允值計量須計及市場參與者使用該資產以達致最大限度及最佳用途而產生的經濟效益之能力，或將該資產出售予其他市場參與者以使用該資產以達致最大限度及最佳用途。

就以公允值交易之投資物業以及持作自用之土地及建築物及使用不可觀察的輸入數據之估值方法以計量往後期間之公允值，估值方法會標定以使估值方法的結果等同交易價格。

此外，就財務報告而言，根據公允值計量輸入數據之可觀察程度及輸入數據對整體公允值計量之重要性，公允值計量可分類為第1級、第2級或第3級，詳情如下：

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

For investment properties and land and buildings held for own use which are transacted at fair value and a valuation technique that unobservable inputs is to be used to measure fair value in subsequent periods, the valuation technique is calibrated so that the results of the valuation technique equals the transaction price.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

The financial statements of subsidiaries are included in the consolidated financial statements from the date on which control commences until the date on which control ceases.

Intra-group balances and transactions, and any unrealised income and expenses (except for foreign currency transaction gains or losses) arising from intra-group transactions, are eliminated. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains, but only to the extent that there is no evidence of impairment.

Changes in the Group's interests in a subsidiary that do not result in a loss of control are accounted for as equity transactions.

When the Group loses control of a subsidiary, it derecognises the assets and liabilities of the subsidiary, and any related non-controlling interests and other components of equity. Any resulting gain or loss is recognised in profit or loss. Any interest retained in that former subsidiary is measured at fair value when control is lost.

In the Company's statement of financial position, an investment in a subsidiary is stated at cost less impairment losses.

Gains or losses arising from a change in fair value or from the retirement or disposal of an investment property is recognised in profit or loss for the period in which they arise.

When the Group holds a property interest under an operating lease to earn rental income and/or for capital appreciation, the interest is classified and accounted for as an investment property on a property-by-property basis.

If a property becomes an owner-occupied property because its use has been changed as evidenced by commencement of owner-occupation, the fair value of the property at the date of change in use is considered as the deemed cost for subsequent accounting.

- when a deficit arises on revaluation, it will be charged to profit or loss to the extent that it exceeds the amount held in the reserve in respect of that same asset immediately prior to the revaluation; and
- when a surplus arises on revaluation, it will be credited to profit or loss to the extent that a deficit on revaluation in respect of that same asset had previously been charged to profit or loss.

Any related revaluation surplus is transferred from the property revaluation reserve to accumulated losses and is not reclassified to profit or loss.

##### Ownership interests in leasehold land and building

When the Group makes payments for ownership interests of properties which includes both leasehold land and building elements, the entire consideration is allocated between the leasehold land and the building elements in proportion to the relative fair values at initial recognition. To the extent the allocation of the relevant payments can be made reliably, interest in leasehold land is presented as "right-of-use assets" in the consolidated statement of financial position except for those that are classified and accounted for as investment properties under the fair value model. Covid-19-related rent concessions

In relation to rent concessions that occurred as a direct consequence of the Covid-19 pandemic, the Group has elected to apply the practical expedient not to assess whether the change is a lease modification if all of the following conditions are met:

- the change in lease payments results in revised consideration for the lease that is substantially the same as, or less than, the consideration for the lease immediately preceding the change;
- any reduction in lease payments affects only payments originally due on or before 30 June 2022; and
- there is no substantive change to other terms and conditions of the lease.

A lessee applying the practical expedient accounts for changes in lease payments resulting from rent concessions the same way it would account for the changes applying HKFRS 16 if the changes are not a lease modification. Forgiveness or waiver of lease payments are accounted for as variable lease payments. The related lease liabilities are adjusted to reflect the amounts forgiven or waived with a corresponding adjustment recognised in profit or loss in the period in which the event occurs.

##### 租賃之分類及計量

本集團為出租人之租賃乃分類為融資或經營租賃。當租賃條款將相關資產擁有權附帶的絕大部分風險及回報轉移至承租人時，該合約乃分類為融資租賃。所有其他租賃乃分類為經營租賃。

經營租賃之租金收入乃按有關租賃協議之租期以直線法於損益中確認。協商及安排所產生之初步直接成本乃加至租賃資產之賬面值，有關成本於租賃期內按直線法確認為開支，惟按公允價值模式計量的投資物業除外。

##### 將合約代價分配至各組成部分

當合約包括租賃及非租賃部份時，本集團應用香港財務報告準則第15號「來自客戶合約之收益」將合約的代價分配至租賃及非租賃部分。非租賃部分因彼等的相對單獨價格而有別於租賃部分。

##### Classification and measurement of leases

Leases for which the Group is a lessor are classified as finance or operating leases. Whenever the terms of the lease transfer substantially all the risks and rewards incidental to ownership of an underlying asset to the lessee, the contract is classified as a finance lease. All other leases are classified as operating leases.

Rental income from operating leases is recognised in profit or loss on a straight-line basis over the term of the relevant lease. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset, and such costs are recognised as an expense on a straight-line basis over the lease term except for investment properties measured under fair value model.

##### Allocation of consideration to components of a contract

When a contract includes both lease and non-lease components, the Group applies HKFRS 15 "Revenue from Contracts with Customers" to allocate consideration in a contract to lease and non-lease components. Non-lease components are separated from lease component on the basis of their relative stand-alone selling prices.

##### Refundable rental deposits

Refundable rental deposits received are accounted for under HKFRS 9 and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments from lessees.

The recoverable amount of property, plant and equipment and right-of-use assets are estimated individually. When it is not possible to estimate the recoverable amount individually, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs.

In testing a cash-generating unit for impairment, corporate assets are allocated to the relevant cash-generating unit when a reasonable and consistent basis of allocation can be established, or otherwise they are allocated to the smallest group of cash generating units for which a reasonable and consistent allocation basis can be established. If the recoverable amount of an asset (or a cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or a cash-generating unit) is reduced to its recoverable amount. For corporate assets or portion of corporate assets which cannot be allocated on a reasonable and consistent basis to a cash-generating unit, the Group compares the carrying amount of a group of cash-generating units, including the carrying amounts of the corporate assets or portion of corporate assets allocated to that group of cash-generating units, with the recoverable amount of the group of cash-generating units. 存貨以成本及可變現淨值兩者中的較低數額入賬。

成本以先進先出法計算，其中包括所有採購成本、加工成本及將存貨送達至目前地點和變成現狀的其他成本。

可變現淨值是以日常業務過程中的估計售價減去完成生產及銷售所需的估計成本後所得之數。進行出售所需成本包括銷售直接應佔增量成本及本集團進行銷售必須產生的非增量成本。

For the purposes of the consolidated statement of cash flows, cash and cash equivalents consist of cash and cash equivalents as defined above.

###### Inventories

Inventories are carried at the lower of cost and net realisable value.

Cost is calculated using the first-in-first-out formula and comprises all costs of purchase, costs of conversion and other costs incurred in bringing the inventories to their present location and condition.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale. Cost necessary to make the sale include incremental costs directly attributable to the sale and non-incremental costs which the Group must incur to make the sale.

When inventories are sold, the carrying amount of those inventories is recognised as an expense in the period in which the related revenue is recognised. The amount of any write-down of inventories to net realisable value and all losses of inventories are recognised as an expense in the period the write-down or loss occurs. The amount of any reversal of any write-down of inventories is recognised as a reduction in the amount of inventories recognised as an expense in the period in which the reversal occurs.

All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the market place.

Financial assets and financial liabilities are initially measured at fair value except for trade receivables arising from contracts with customers which are initially measured in accordance with HKFRS 15. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition.

The effective interest method is a method of calculating the amortised cost of a financial asset or financial liability and of allocating interest income and interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts and payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial asset or financial liability, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

Financial assets that meet the following conditions are subsequently measured at amortised cost:

- the financial asset is held within a business model whose objective is to collect contractual cash flows; and

###### Amortised cost and interest income

Interest income is recognised using the effective interest method for financial assets measured subsequently at amortised cost. 本集團根據預期信貸虧損(「預期信貸虧損」)模式對金融資產(包括已付按金、應收賬款及其他應收款以及銀行結餘)(根據香港財務報告準則第9號須受限於減值評估)進行減值評估。預期信貸虧損的金額於各報告日期更新,以反映自初始確認後信貸風險的變化。

全期預期信貸虧損指相關工具的預期使用期內所有可能的違約事件將產生之預期信貸虧損。相對地,12個月預期信貸虧損(「12個月預期信貸虧損」)指預期於報告日期後12個月內可能發生的違約事件所導致之全期預期信貸虧損的該等部分。評估乃根據本集團的歷史信貸虧損經驗進行,並根據債務人特有的因素、一般經濟狀況、同時對報告日期當前狀況及未來狀況預測的評估作出調整。

##### Impairment of financial assets

The Group performs impairment assessment under expected credit loss (“ECL”) model on financial assets (including deposits paid, trade and other receivables and bank balances) which are subject to impairment assessment under HKFRS 9. The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of the relevant instrument. In contrast, 12-month ECL (“12m ECL”) represents the portion of lifetime ECL that is expected to result from default events that are possible within 12 months after the reporting date. Assessments are done based on the Group’s historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current conditions at the reporting date as well as the forecast of future conditions.

The Group always recognises lifetime ECL for trade receivables. The ECL on these assets are assessed individually.

For all other financial assets, ECL is measured at 12m ECL unless there has been a significant increase in credit risk since initial recognition, in which case the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increases in the likelihood or risk of a default occurring since initial recognition.

於評估信貸風險自初始確認以來有否顯著增加時，本集團比較金融工具於報告日期出現違約的風險與該金融工具於初始確認日期出現違約的風險。作此評估時，本集團會考慮合理有據的定量及定性資料，包括過往經驗及毋須花費不必要成本或工作即可獲得的前瞻性資料。

尤其是，評估信貸風險有否顯著增加時會考慮下列資料：

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The Group recognises a deferred tax asset related to lease liabilities to the extent that it is probable that taxable profit will be available against which the deductible temporary difference can be utilised and a deferred tax liability for all taxable temporary differences.

The carrying amount of a deferred tax asset is reviewed at the end of each reporting period and is reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow the related tax benefit to be utilised. Any such reduction is reversed to the extent that it becomes probable that sufficient taxable profits will be available.

**Foreign currencies**

Foreign currency transactions during the year are translated at the foreign exchange rates ruling at the transaction dates. Monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at the end of the reporting period. Exchange gains and losses are recognised in profit or loss.

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated using the foreign exchange rates ruling at the transaction dates. Non-monetary assets and liabilities denominated in foreign currencies that are stated at fair value are translated using the foreign exchange rates ruling at the dates the fair value was measured.

The results of operations outside Hong Kong are translated into Hong Kong dollars at the average exchange rate for the period unless exchange rate fluctuate significantly during the period in which case the exchange rates at the date of transactions are used. Statement of financial position items are translated into Hong Kong dollars at the closing foreign exchange rates at the end of the reporting period. The resulting exchange differences are recognised in other comprehensive income and accumulated separately in equity in the exchange reserve.

On disposal of an operation outside Hong Kong, the cumulative amount of the exchange differences relating to that operation outside Hong Kong is reclassified from equity to profit or loss when the profit or loss on disposal is recognised.

###### Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets until such time as the assets are substantially ready for their intended use or sale.

Any specific borrowing that remain outstanding after the related asset is ready for its intended use or sale is included in the general borrowing pool for calculation of capitalisation rate on general borrowings. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation. All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

##### 投資物業的遞延稅項

就計量採用公允價值模式計量的投資物業所產生的遞延稅項而言，董事已檢討本集團之投資物業組合並認為本集團若干投資物業根據業務目標是隨時間消耗投資物業所包含的絕大部分經濟利益的業務模式持有。因此，在計量本集團投資物業之遞延稅項時，董事決定透過銷售收回全部採用公允價值模式計量位於中國內地之投資物業之賬面值之假設已被推翻。就「銷售」之假定未被推翻之若干香港投資物業而言，本集團並未就香港投資物業的超出合資格成本的公允價值變動確認任何遞延所得稅，原因是本集團毋須於出售香港之投資物業時就其超出合資格成本的公允價值變動繳納任何所得稅。

##### Deferred taxation on investment properties

For the purposes of measuring deferred tax arising from investment properties that are measured using the fair value model, the Directors have reviewed the Group's investment property portfolios and concluded that certain of the Group's investment properties are held under a business model whose objective is to consume substantially all of the economic benefits embodied in the investment properties over time. Therefore, in measuring the Group's deferred taxation on investment properties, the Directors have determined that the presumption that the carrying amounts of investment properties in Mainland China measured using the fair value model are recovered entirely through sale is rebutted. For certain investment properties in Hong Kong on which the "sale" presumption is not rebutted, the Group has not recognised any deferred tax on changes in fair value of investment properties in Hong Kong above the qualified cost as the Group is not subject to any income taxes on the fair value changes of the investment properties in Hong Kong above the qualified cost on disposal.

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that may have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

本集團定期評估使用權資產以及物業、廠房及設備有否減值跡象。倘出現有關跡象，該等資產所屬之現金產生單位之可收回金額將參考使用價值或公允值減出售成本之較高者釐訂。使用價值採用現金流貼現法釐訂。由於以若干增長率作為關鍵輸入數據之未來現金流量之時間性及數量及公允值減出售成本之估算所固有之風險，資產之估計可收回金額或會有別於其實際可收回金額，而溢利或虧損可能受估算之準確程度所影響。此外，經營環境仍然複雜多變—通脹高居不下、部分發達國家之主要央行加息應對、地緣政治衝突加劇，以及在中國方面，房地產行業之危機持續，對本集團之零售業務造成潛在干擾。

董事根據獨立合資格專業物業估值師參考資本化率及可資比較市場交易所編製之估值評估本集團之投資物業以及持作自用土地及建築物之公允值。物業估值師所採用的估值模型使用市場輸入數據。倘市場輸入數據發生變化，則投資物業以及持作自用土地及建築物的估值亦將相應改變。

**Impairment of right-of-use assets and property, plant and equipment**

The Group assesses regularly whether right-of-use assets and property, plant and equipment have any indication of impairment. If such indication exists, the recoverable amounts of the cash-generating units to which these assets belong would be determined by reference to the higher of their value in use or fair value less costs of disposal. Value in use is determined using the discounted cash flow method. Due to inherent risk associated with estimations in the timing and magnitude of the future cash flows calculated with certain growth rate as key input and fair value less costs of disposal, the estimated recoverable amount of the assets may be different from their actual recoverable amount and profit or loss could be affected by the accuracy of the estimations. Furthermore, the still volatile and complicated business environment which was marked by irrepressibly high inflation, interest rate hikes by major central banks as a response in some developed countries, escalating geopolitical conflicts and, in the case of China, the ongoing crisis in the property sector, there are potential disruptions to the Group's retail operations.

**Valuation of investment properties and land and buildings held for own use**

The fair values of the Group's investment properties and land and buildings held for own use are assessed by the Directors based on valuations prepared by an independent firm of qualified professional property valuers by making reference to the capitalisation rate and comparable market transactions. The valuation models used by the property valuer make use of market inputs. Should changes be made to the market inputs, the corresponding valuation of investment properties and land and buildings held for own use would change.

##### 存貨估值

本集團定期參考存貨賬齡分析及過往消費趨勢審閱存貨之賬面值。根據此審閱，倘若存貨之估計可變現淨值減至低於賬面值，則會撇減存貨。由於市場趨勢不斷轉變，實際之消費模式可能與估計有所差異，此估計之準確性可能影響損益。

本集團主要透過其零售店銷售予客戶時尚服飾及配飾。截至二零二四年及二零二三年三月三十一日止年度，銷售時尚服飾及配飾之收益於貨品交付予客戶時按時間點確認。

##### 客戶合約之履約責任

當貨品控制權轉移時，即於客戶購買及直接於零售店帶走貨品之時點或當貨品運輸至客戶之特定地點(交付)時確認銷售時尚服飾及配飾之收益。於客戶取得相關產品之控制權之前之運輸及其他相關活動視為履約活動。客戶於零售店購買貨品時一般須立即支付交易價格。於貨品已交付予客戶之前，本集團就須交付貨品收取之交易價格確認為合約負債。

##### Valuation of inventories

The Group performs regular review of the carrying amounts of inventories with reference to aged inventories analysis and historical consumption trends. Based on this review, write-down of inventories will be made when the estimated net realisable value of inventories decline below their carrying amounts. Due to changes in market trends, actual consumption may be different from estimation and profit or loss could be affected by accuracy of this estimation.

#### 5. REVENUE AND SEGMENT INFORMATION

The Group generated sales of fashion apparel and accessories with customers mainly through its own retail stores. For the years ended 31 March 2024 and 2023, revenue from sales of fashion apparel and accessories is recognised at a point in time when the goods are delivered to the customers.

##### Performance obligations for contracts with customers

Revenue from sales of fashion apparel and accessories is recognised when control of the goods has transferred, being the point where the customer purchases and takes the goods at the retail stores directly or when the goods have been transported to the customers' specified location (delivery). Transportation and other related activities that incurred before customers obtain control of the related products are considered as fulfilment activities. Payment of the transaction price is generally due immediately at the point the customer purchases the goods in the retail stores. The transaction price received by the Group for goods that require delivery is recognised as a contract liability until the goods have been delivered to the customer.

**客戶忠誠度計劃**

**Customer loyalty programme**

The Group operates a customer loyalty programme for sales through the Group's retail stores where customers accumulate award points for purchases made which entitle them to redeem award points as sales discounts in the future. The transaction price is allocated to the product and the award points on a relative stand-alone selling price basis. The award points expire every year and customers can redeem the award points any time before the specified expiration date. Revenue from the award points is recognised when the award points are used or expired. Contract liabilities, presented under "accrued charges", are recognised until the award points are used or expired.

**Transaction price allocated to the remaining performance obligation for contracts with customers**

Contracts with customers with unsatisfied performance obligations, including award points under the customer loyalty programme, have original expected durations of one year or less. As permitted under HKFRS 15, the transaction prices allocated to these unsatisfied performance obligations are not disclosed.

##### Segment information

The Group manages its businesses by geographical locations. In a manner consistent with the way in which information is reported internally to the Group's senior executive management for the purposes of resource allocation and performance assessment, the Group has presented the following two reportable segments. No operating segments have been aggregated to form the following reportable segments.

- The Hong Kong operation represents the sales of house brands and imported brands in Hong Kong.
- The outside Hong Kong operation represents the manufacture of house brands in Mainland China and sales of house brands and imported brands in Mainland China, Macau and Taiwan.

For the purposes of assessing segment performance and allocating resources between segments, the Group's senior executive management monitors the results attributable to each reportable segment on the following bases:

Revenue and expenses are allocated to the reportable segments with reference to sales generated by those segments and the expenses incurred by those segments or which otherwise arise from the depreciation of assets attributable to those segments.

The measure used for reportable segment profit/loss is profit/loss from operations with the exclusion of other income, other gains and losses and certain administrative and other operating expenses. Income tax is not allocated to reportable segments.

The Directors consider the amount involved upon implementation of the two-tiered profits tax rates regime as insignificant to the consolidated financial statements. Accordingly, Hong Kong Profits Tax for subsidiaries operating in Hong Kong is calculated at 16.5% of the estimated assessable profit for both years. No provision for Hong Kong Profits Tax had been made in the consolidated financial statements as the Group did not have assessable profits arising in Hong Kong or the assessable profits were absorbed by tax losses for both years.

Under the law of the PRC on Enterprise Income Tax (“EIT”) and Implementation Regulation of the EIT law, the tax rate of Mainland China subsidiaries is 25% for both years.

Macau Complementary Tax is levied at progressive rates ranging from 3% to 9% on the taxable income above Macau Pataca ("MOP") 32,000 (equivalent to HK\$31,000) but below MOP300,000 (equivalent to HK\$291,000), and thereafter at a fixed rate of 12%. For the years ended 31 March 2024 and 2023, a special complementary tax incentive was provided to the effect that the tax free income threshold was MOP600,000 (equivalent to HK\$582,000) with profit above MOP600,000 (equivalent to HK\$582,000) being taxed at a fixed rate of 12%.

Taxation arising in other jurisdiction including Taiwan is calculated at the rate prevailing in the relevant jurisdiction. During the year ended 31 March 2024, the applicable tax rates for subsidiaries domiciled in Taiwan is 17% (2023: 17%).

The Group is subject to withholding tax at a rate of 10% (unless reduced by treaty) on distribution of profits generated after 31 December 2007 from the Group's foreign-invested enterprises in Mainland China. As all of the Group's foreign-invested enterprises are directly and wholly owned by Hong Kong incorporated subsidiaries, a reduced rate of 5% is applicable in the calculation of this withholding tax. Deferred tax liabilities of HK\$7,058,000 (2023: HK\$7,115,000) have not been recognised in respect of the tax that would be payable on the distribution of these retained profits since, in the opinion of the Directors, these earnings are not intended to be distributed in the foreseeable future.

The fair value measurement is positively correlated to the market rental value and negatively correlated to the capitalisation rate.

Revaluation deficit of HK\$16,269,000 (2023: deficit of HK\$1,781,000) arising from revaluation of land and buildings held for own use is recognised in other comprehensive income during the year ended 31 March 2024. Had the above land and buildings held for own use been carried at historical cost less accumulated depreciation, the carrying amounts would have been HK\$44,141,000 (2023: HK\$42,249,000) at 31 March 2024.

因2019冠狀病毒病疫情的直接後果產生的該等租金減免符合香港財務報告準則第16.46B號的所有條件，故本集團應用可行權宜方法不評估有關變動是否構成租賃修訂。截至二零二三年三月三十一日止年度，由於出租人就相關租賃寬減或豁免3,403,000港元，故租賃付款變動的影響確認為負可變租賃付款（計入其他收入）。

##### 減值評估

由於本集團零售店舖表現欠佳，本集團管理層認為存在減值跡象，並對相關使用權資產以及物業、廠房及設備之可收回金額進行減值評估。

各現金產生單位可收回金額乃根據使用價值計算而釐定。該計算使用現金流量預測，有關預測已獲本集團管理層批准，涵蓋各現金產生單位剩餘租賃期限的財務預算，和於二零二四年三月三十一日的除稅前貼現率13.5%（二零二三年：13.5%）為基準。使用價值計算另一項主要假設為預算毛利率，其根據各現金產生單位過往表現以及管理層對市場發展的預期而釐定。

The overall financial effect of using variable payment terms is that higher rental costs are incurred by retail shops with higher sales. Variable rent expenses are expected to continue to represent a similar proportion of retail shops sales in future years.

##### Rent concessions

During the prior year ended 31 March 2023, lessors of various retail stores and department store counters provided rent concessions to the Group through rent reductions ranging from 10% to 100% over 1 to 6 months.

These rent concessions occurred as a direct consequence of Covid-19 pandemic and met all of the conditions in HKFRS 16.46B, and the Group applied the practical expedient not to assess whether the changes constitute lease modifications. The effects on changes in lease payments due to forgiveness or waiver by the lessors for the relevant leases of HK\$3,403,000 were recognised as negative variable lease payments (included in other income) during the year ended 31 March 2023.

##### Impairment assessment

Due to adverse performance of the Group's retail operations, the management of the Group concluded there was indication for impairment and conducted impairment assessment on recoverable amounts of relevant right-of-use assets and property, plant and equipment.

The recoverable amount of each cash-generating units has been determined based on a value in use calculation. That calculation uses cash flow projections based on financial budgets approved by the management of the Group covering the remaining lease term of each cash-generating unit with a pre-tax discount rate of 13.5% (2023: 13.5%) as at 31 March 2024. Another key assumption for the value in use calculated is the budgeted gross margin, which is determined based on each cash-generating units' past performance and management expectations for the market development.

The subsidiaries in Mainland China participate in a defined contribution scheme organised by the local government. These subsidiaries are required to make contributions at certain prescribed rates of the relevant Mainland China employees' salaries to the scheme. Contributions to the scheme vest immediately.

Employees of the subsidiary carrying on business in Taiwan chose to participate in a defined contribution scheme governed by the Labour Pension Act of Taiwan. This subsidiary contributes at 6% of the total salaries of the participating employees who have chosen to participate in the defined contribution scheme, the contribution deposited into individual pension accounts at the Bureau of Labour Insurance of Taiwan.

Contributions to the defined contribution scheme are charged to profit or loss when incurred. Details of the contribution scheme amount are disclosed in note 9.

#### Obligation to pay LSP under Hong Kong Employment Ordinance (Chapter 57)

For the Group's subsidiaries operating in Hong Kong, pursuant to the Employment Ordinance, Chapter 57, the Group has the obligation to pay LSP to qualifying employees in Hong Kong under certain circumstances (e.g. dismissal by employers or upon retirement), subject to a minimum of 5 years employment period, based on the following formula:

Last monthly wages (before termination of employment) × 2/3 × Years of service

Last monthly wages are capped at HK\$22,500 while the amount of long service payment shall not exceed HK\$390,000. This obligation is accounted for as a post-employment defined benefit plan.

Furthermore, the Mandatory Provident Fund Schemes Ordinance passed in 1995 permits the Group to utilise the Group's mandatory MPF contributions, plus/minus any positive/negative returns thereof, for the purpose of offsetting LSP payable to an employee.

The Amendment Ordinance was gazetted on 17 June 2022, which abolishes the use of the accrued benefits derived from employers' mandatory MPF contributions to offset the LSP. The Abolition will officially take effect on the Transition Date (i.e., 1 May 2025). Separately, the Government is also expected to introduce a subsidy scheme to assist employers for a period of 25 years after the Transition Date on the LSP payable by employers up to a certain amount per employee per year.

Under the Amendment Ordinance, the Group's mandatory MPF contributions, plus/minus any positive/negative returns, after the Transition Date can continue to be applied to offset the pre-Transition Date LSP obligation but are not eligible to offset the post-Transition Date LSP obligation. Furthermore, the LSP obligation before the Transition Date will be grandfathered and calculated based on the last monthly wages immediately preceding the Transition Date and the years of service up to that date. The Amendment Ordinance has impact on the Group's LSP liability with respect to employees that participate in MPF Scheme and the Group has accounted for the offsetting mechanism and its abolition during the year ended 31 March 2024.

#### 26. 或有負債

#### 26. CONTINGENT LIABILITIES

In October 2015, a subsidiary of the Group in Hong Kong (the “Hong Kong Subsidiary”) received a notice that it was being sued by a fabric manufacturer under a writ of summons in the High Court of the Hong Kong Special Administrative Region in respect of alleged infringement of copyright. The generally indorsed writ of summons was subsequently served on the Hong Kong Subsidiary but the statement of claim has not yet been served up to the date of issue of these consolidated financial statements and the Hong Kong Subsidiary continues to deny any liability in respect of the above claim. An external counsel has been engaged to defend the said claim and the Directors will continue to seek advice from the Group’s external counsel. No provision has therefore been made in respect of this claim as at 31 March 2024 and 2023.

The Group's primary objectives when managing capital are to safeguard the Group's ability to continue as a going concern, so that it can continue to provide returns for shareholders and benefits for other stakeholders, by pricing products and services commensurately with the level of risk and by securing access to finance at a reasonable cost.

The Group actively and regularly reviews and manages its capital structure to maintain a balance between the higher shareholder returns that might be possible with higher levels of borrowings and the advantages and security afforded by a sound capital position, and makes adjustments to the capital structure in light of changes in economic conditions.

During 2024, the Group's strategy in monitoring its capital structure, which was unchanged from 2023, was to maintain a sufficient cash level to meet its liquidity requirements. In order to maintain or adjust the cash level, the Group may adjust the amount of dividends payable to shareholders, issue new shares, raise new debt financing or sell assets to increase the cash level.

The Group's maximum exposure to credit risk which will cause a financial loss to the Group due to failure to discharge an obligation by the counterparties is arising from the carrying amount of the respective recognised financial assets as stated in the consolidated statement of financial position.

##### Trade receivables

Retail sales are mainly on a cash basis, either in cash, debit card or credit card payments. In order to minimise the credit risk in regard of balances with trade receivables debtors, which mainly consist of credit card institutions, department stores and malls, the management of the Group has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, the management of the Group reviews the recoverable amount of each individual debt at the end of each reporting period to ensure that adequate impairment losses are made for irrecoverable amounts. The Group applies simplified approach on trade receivables to assess for ECL prescribed by HKFRS 9. To measure ECL of trade receivables at amortised cost, the Group applies internal credit rating for its counterparties and they are assessed individually by reference to past default experience, current past due exposure of the debtors and an analysis of the debtors' current financial position. The ECL rates are estimated based on historical observed default rates over the expected life of the debtors and are adjusted for forward-looking information (for example, the current and forecasted global economy which reflect the general economic conditions of the industry in which the debtors operate) that is available without undue cost or effort. Such forward-looking information is used by the management of the Group to assess both the current as well as the forecast direction of conditions at the reporting date.

The credit risk on credit card receivables is limited because the counterparties are bank/financial institutions with high external credit ratings assigned by international credit-rating agencies. As at the end of the reporting period, there is no credit-impaired balance of trade receivables (2023: nil). In addition, the management of the Group considers those not credit-impaired trade receivables were collectible based on historical observed default rates over the expected life of the debtors and adjusted for forward-looking information. The Directors are of the opinion that allowance for impairment on the remaining trade receivables was insignificant and thus negligible to be made.

The Group has concentration of credit risk on the trade receivables. As at 31 March 2024, 14% (2023: 14%) of trade receivables is due from the Group's largest counterparty and 51% (2023: 40%) of trade receivables is due from the five largest counterparties. The management of the Group closely monitors the subsequent settlement by the counterparties.

**Other financial assets at amortised costs**

For other receivables and rental and other deposits, the Directors make periodic individual assessment on the recoverability of significant balances based on historical settlement records, past experience, and also available reasonable and supportive forward-looking information. The Directors believe that there is no material credit risk inherent in the Group's outstanding balance of other receivables and deposits. Based on assessment by the management of the Group, the ECL for other receivables and deposits is insignificant.

The bank balances are placed in various authorised financial institutions either with high credit ratings or good financial background and the Directors consider the credit risk of such authorised financial institutions is low.

##### Liquidity risk

As at 31 March 2024, the Group's current liabilities exceeded its current assets by approximately HK\$24,456,000 (2023: HK\$18,659,000). For the year ended 31 March 2024, the Group generated operating cash flows of approximately HK\$6,390,000 (2023: HK\$6,184,000). As at 31 March 2024, the total cash and cash equivalents of HK\$23,558,000 (2023: HK\$13,775,000) were held by the Group and unutilised bank facilities amounted to approximately HK\$16,225,000 (2023: HK\$31,357,000) were available.
