The conversion price of the CB is subject to a reset mechanism, the details of which are set out in the Company's circular dated 12 December 2023. As disclosed in the Company's announcement dated 28 June 2024, the payment-in-kind interest accrued for the CB as at 1 July 2024 is US\$1,882,157, which increased the outstanding principal amount of the CB to US \$127,359,290, and the CB Conversion Price adjusted to HK\$0.8 per Share in accordance with the terms of the CB Indenture, both of which took effect on 1 July 2024.
