For illustration purpose, the closing price of the Company's ADSs on the trading day immediately prior to the date of change (i.e., August 19, 2024 (U.S. Eastern Time)) was used to present the closing market price of the ADSs, which is US\$7.94 per ADS, or US\$1.59 per share (one ADS represents five shares). The 39,970 shares are issued out of the 22,527,740 shares under the issuance mandate approved at the annual general meeting of 2024 to be issued to the affected clients who accepted the settlement offer as of April 16, 2024 (being the latest practicable date for ascertaining certain information for inclusion in the circular of the annual general meeting of 2024 before publication).
