### **SUPPLEMENTAL ANNOUNCEMENT IN RELATION TO ANNUAL REPORT 2023**

Reference is made to the annual report of Platt Nera International Limited (the “**Company**”) for the year ended 31 December 2023 (the “**2023 Annual Report**”). Capitalised terms used herein shall have the same meanings as those defined in the 2023 Annual Report unless the context requires otherwise.

In addition to the information disclosed in the 2023 Annual Report, the board (the “**Board**”) of directors (the “**Directors**”) of the Company would like to provide to the shareholders of the Company and the potential investors with the following supplementary information to the 2023 Annual Report:

#### **USE OF PROCEEDS FROM RIGHTS ISSUE**

Apart from the information disclosed on page 10 of the 2023 Annual Report in relation to the use of proceeds from the Rights Issue completed on 14 September 2023, the Board wishes to elaborate on the usage and intended timeline for spending of the remaining HK\$4.6 million among the Unused Proceeds.

The Company had explained in the 2023 Annual Report that the funds planned for utilization towards New Projects turned out to be less than earlier planned, and the Company has begun to work towards major new projects which may require the Company to utilize the Unused Proceeds for such projects as they come onstream. The Company hereby wishes to update and clarify that the Company plans to review the usage of Unused Proceeds towards New Projects in late August 2024 in conjunction with the review of the Company’s financial position and results as at 30 June 2024, and thereafter make the relevant update announcement in relation thereto.

Further, the Company would like to take this opportunity to update that the HK\$1.8 million among the Unused Proceeds which was assigned for repayment of overdraft and other short-term loans has already been fully utilized as at the date of this announcement.
