According to the public information available to the Directors, The Issuer was incorporated in the Cayman Islands with limited liability. The shares of the Issuer are listed on the Stock Exchange (stock codes: 700 (HKD counter) and 80700 (RMB counter)). The Issuer is an investment holding company. The Issuer's group is principally engaged in the provision of value-added services, online advertising services and financial technology and business services. The largest shareholder of the Issuer is MIH Internet Holdings B.V., which holds approximately 24.96% of the issued shares of the Issuer. MIH Internet Holdings B.V. is controlled by Naspers Limited and held through its non-wholly-owned subsidiary, Prosus N.V.. Naspers Limited is a company incorporated in the Republic of South Africa in 1915 and has transformed into a global consumer internet company and one of the largest technology investors in the world. Naspers Limited's group is a global technology group with businesses and investments in growth markets around the world. Naspers Limited has its primary listing on the The Johannesburg Stock Exchange (stock code: NPN.SJ) and a secondary listing on A2X Markets (stock code: NPN.AJ) in the Republic of South Africa.

As at the date of this announcement, to the best of the knowledge, information and belief of the Directors, having made all reasonable enquiries, the Issuer and its respective ultimate beneficial owners are Independent Third Parties.

BASIS OF DETERMINATION OF THE CONSIDERATION

Since the Disposals were conducted on the open market at the prevailing market price, the Directors consider that the Disposals are on normal commercial terms and its terms including the consideration are fair and reasonable.

INFORMATION OF THE GROUP

The Group is principally engaged in the provision of brokerage services, margin financing services, corporate finance services, asset management services and financial products and investments.

REASONS AND BENEFITS FOR THE DISPOSALS

The investment strategy of the Group is, among others, to generate stable return to the Group within

an acceptable risk level by investing in a broad diversification of portfolio, including but not limited to stocks, bonds, funds, structured products and derivatives in different business sectors to broaden its revenue streams and to seek sustainable business which increase value for its shareholders. In addition, the Group has sought an opportunity to balance and diversify its investment portfolio when opportunities arose and would, from time to time, realise its investment which to do so will be in the best interests of the Group.

The Disposals were in line with the Group's principal activities on financial products and investments. Having consider the performance of the price of the Notes, the Board is of the opinion that the Disposals represent a good opportunity for the Group to exit the investment in the Notes. Taking into account the financial effect of the Disposals as disclosed in the paragraph headed "**Financial Effect of the Disposals**" below, the Board is of the view that the Disposals are fair and reasonable and in the interests of the Company and the Shareholders as a whole.

FINANCIAL EFFECT OF THE DISPOSALS

The Group recorded a loss of approximately US\$4,873 (equivalent to approximately HK\$38,252), being the difference between the acquisition cost of the Notes and the proceeds received from the Disposals. The actual amount of gain or loss as a result of the Disposals to be recorded by the Group will be subject to review and final audit by the auditors of the Company.

INTENDED USE OF PROCEEDS
