A total of 14,158,848 Placing Shares have been successfully placed and issued to not less than six Placees at the Placing Price of HK\$0.300 per Placing Share.

Reference is made to the announcement of the Company dated 23 August 2024 (the “**Announcement**”) in relation to the Placing of the Placing Shares under the General Mandate. Capitalised terms used in this announcement have the same meanings as those defined in the Announcement unless the context requires otherwise.

#### **COMPLETION OF PLACING OF NEW SHARES**

The Board is pleased to announce that with the condition of the Placing Agreement having been fulfilled, completion of the Placing took place on 11 September 2024 as agreed between the parties. A total of 14,158,848 Placing Shares have been successfully placed and issued to not less than six Placees. To the best of the Directors’ knowledge, information and belief having made all reasonable enquiries, the Placees and their ultimate beneficial owners are Independent Third Parties. None of the Placees has become a substantial shareholder (as defined under the Listing Rules) of the Company immediately after completion of the Placing.

The net proceeds from the Placing, after deduction of related costs and expenses to be borne by the Company, amounted to approximately HK\$4.2 million, will be used for the purpose as set out in the Announcement.
