### **UNAUDITED OPERATING FIGURES FOR THE NINE MONTHS ENDED 30 SEPTEMBER 2024**

The board (the “**Board**”) of directors (the “**Directors**”) of Top Spring International Holdings Limited (the “**Company**”) is pleased to announce certain unaudited operating figures of the Company and its subsidiaries (the “**Group**”) for the nine months ended 30 September 2024.

- For the nine months ended 30 September 2024, the pre-sales of the Group were approximately HK\$585.6 million, among which, pre-sales of properties and pre-sales of car park units were approximately HK\$581.4 million and approximately HK\$4.2 million, respectively. The pre-sales properties’ gross floor area was approximately 8,109 sq.m., with an average selling price of pre-sales properties of approximately HK\$71,690 per sq.m..

The above operating information is unaudited, which was prepared according to the preliminary internal information of the Group. Given that various uncertainties may exist in the process of collecting such pre-sales figures, such operating information may be different from those to be disclosed in the audited or unaudited consolidated financial statements published by the Company on an annual or a semi-annual basis.
