**ANNOUNCEMENT ON UNAUDITED OPERATING DATA
FOR THE THIRD QUARTER OF
THE THREE MONTHS ENDED 30 SEPTEMBER 2024 AND
THE NINE MONTHS ENDED 30 SEPTEMBER 2024**

This announcement is voluntarily made by Dynagreen Environmental Protection Group Co., Ltd.* (the “**Company**”, together with its subsidiaries, the “**Group**”).

The board of directors (the “**Board**”) of the Company is pleased to announce that the unaudited waste input volume, electricity generation volume, on-grid electricity volume and steam supply volume of the Group amounted to 3,700,200 tons, 1,323,499,200 kWh, 1,088,168,900 kWh and 136,200 tons respectively in the third quarter of the three months ended 30 September 2024. For the nine months ended 30 September 2024, the unaudited accumulated waste input volume of the Group amounted to 10,707,500 tons, representing a year-on-year increase of 7.16%; the accumulated electricity generation volume was 3,822,188,800 kWh, representing a year-on-year increase of 10.44%; the accumulated on-grid electricity volume was 3,160,189,100 kWh, representing a year-on-year increase of 10.94%; and the accumulated steam supply volume amounted to 371,900 tons, representing a year-on-year increase of 23.64%.
