GRANT OF WAIVER FROM STRICT COMPLIANCE WITH RULE 14.41(A) OF THE LISTING RULES AND FURTHER DELAY IN DESPATCH OF CIRCULAR

Reference is made to (i) the announcements of Central New Energy Holding Group Limited (the “**Company**”) dated 28 June 2024 and 12 July 2024 respectively in relation to, among others, the entering into of the New Equipment Lease Agreements and the transactions contemplated thereunder; and (ii) the announcements of the Company dated 2 August 2024, 13 September 2024 and 25 October 2024 respectively in relation to the delay in despatch of the circular (collectively, the “**Announcements**”). Unless otherwise defined, capitalised terms used herein shall have the same meanings as those defined in the Announcements.

As disclosed in the Announcements, the Circular, containing, among other things, (i) further information of the New Equipment Lease Agreements and the transactions contemplated thereunder; and (ii) other information required to be disclosed under the Listing Rules, was expected to be despatched to the Shareholders on or before 25 October 2024.

As additional time is required to prepare and finalise certain information in the Circular, the Company has applied to the Stock Exchange for a waiver from strict compliance with Rule 14.41(a) of the Listing Rules. On 6 November 2024, the Stock Exchange has granted the aforesaid waiver to the Company provided that the Company would despatch the Circular on or before 25 November 2024. It is therefore currently expected that the Circular will be despatched to the Shareholders on or before 25 November 2024. Please note that the aforesaid waiver applies to this case only and the Stock Exchange may withdraw or change the waiver if the Company’s situation changes.
