This announcement is made by Grandshores Technology Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on a preliminary review of the Group’s consolidated management accounts for the six months period ended 30 September 2024 (the “**Current Period**”), the Group is expected to record a loss for the period of approximately S\$3.0 million for the Current Period as compared with a loss for the period of approximately S\$1.6 million for the six months period ended 30 September 2023 (the “**Last Period**”).

The Board considers that the increase in loss was mainly attributable to the following factors:

- (i) decrease in government grant received in the Current Period; and
- (ii) change from an exchange gain in the Last Period to an exchange loss in the Current Period due to the fluctuation in foreign exchange rate.

As the Group’s interim results for the Current Period have not yet been finalised, the information contained in this announcement is only a preliminary assessment by the management of the Company which is based on the latest financial information currently available, including but not limited to the Group’s consolidated management accounts for the Current Period, which has not been audited by the independent auditors of the Company nor reviewed by the audit committee of the Company as at the date of this announcement and may be subject to adjustment upon further review.

Shareholders and potential investors of the Company are advised to read carefully the interim results announcement of the Company for the Current Period, which is expected to be published by the end of November 2024.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the shares of the Company.
