POSITIVE PROFIT ALERT

This announcement is made by F8 Enterprises (Holdings) Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined in the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors (the “**Directors**”) of the Company (the “**Board**”) would like to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on a preliminary review of the unaudited consolidated management accounts of the Group for the six months ended 30 September 2024 (“**2024Q2**”) and the information currently available to the Board, the Group expects to record a net profit in the range of approximately HK\$1.5 million to approximately HK\$2.5 million for 2024Q2, as compared with a net loss of approximately HK\$2.4 million for the six months ended 30 September 2023.

Based on the information currently available to the Board, the Board believes that the net profit of the Group was mainly attributable to (i) increase in sale and transportation of diesel oil business for 2024Q2; (ii) increase in other income and other gains or losses for 2024Q2; and (iii) decrease in other operating expenses for 2024Q2.

As the Company is still in the process of finalising the consolidated results of the Group for 2024Q2, the information contained in this announcement is only based on the information currently available to the Board and the preliminary review of the unaudited consolidated management accounts of the Group for 2024Q2 by the Board and may be subject to adjustments. The unaudited consolidated management accounts of the Group for 2024Q2 have not yet been reviewed by the audit committee of the Board, and have not been reviewed or audited by the auditor of the Company. The final interim results of the Group for 2024Q2 may be different from the information disclosed in this announcement. Shareholders and potential investors are advised to read carefully the Company’s interim results announcement for 2024Q2, which is expected to be published on or around 27 November 2024 in accordance with the GEM Listing Rules.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
